Senator Connor offered the following Senate Resolution, which was referred to the Committee on Assignments:

SENATE RESOLUTION NO. 237

WHEREAS, Property tax appeals are necessary to ensure property tax assessments are accurate and fair; and

WHEREAS, The Illinois Property Tax Appeal Board (the Board) was established to consider appeals after decisions from County Boards of Review; and

WHEREAS, The Board makes a decision in each appeal based on equity and the weight of evidence; and

WHEREAS, Property tax appeals involve the filing of various forms, documentation, and photographs at each stage of the appeal process to meet the evidentiary burden; and

WHEREAS, The Board and many counties require mail-in or hand delivery of property tax appeal forms and materials; and

WHEREAS, Submission of multiple paper copies is overly burdensome to those with limited time and resources; this burden falls disproportionately on individuals with lower incomes seeking appeals and can impair their access to justice; and

WHEREAS, The use of a centralized statewide submission platform has the potential to ease this burden and promote a consistent process across Illinois counties; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois Property Tax Appeal Board to deliver a report to the Illinois Senate on or before October 1, 2021 that examines the feasibility and associated costs of implementing a centralized property tax appeal submission platform for appeals to the Property Tax Appeal Board and counties that elect to use this platform to process appeals and any additional internet-based platform the Board may find sufficient to accept property tax appeals electronically; and be it further

RESOLVED, That this report should describe available technology and cost estimates and offer potential funding sources to cover the costs associated with implementation; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Property Tax Appeal Board.

Senator T. Cullerton offered the following Senate Joint Resolution, which was referred to the Committee on Assignments:

SENATE JOINT RESOLUTION NO. 28

WHEREAS, The Medal of Honor is our nation's highest award for valor and is presented to veterans of the Armed Forces of the United States for "acting with conspicuous gallantry and intrepidity above and beyond the call of duty at the risk of one's life during combat with an enemy of the United States"; and

WHEREAS, President Abraham Lincoln signed legislation into law in 1861 and 1862 creating the Medal of Honor and was laid to rest in his hometown of Springfield, Illinois in 1865; and

WHEREAS, The Medal of Honor is widely respected by the military and public alike; and

WHEREAS, 108 Medal of Honor recipients were born in Illinois, 209 recipients entered service from Illinois, and 110 recipients were laid to rest in Illinois; and

WHEREAS, The Medal of Honor recipients with connections to Illinois served during 11 wars, from the Civil War to the Vietnam War, over a period of 114 years; and

WHEREAS, Two Medal of Honor recipients who were born in or who entered service from Illinois, received their Medal of Honor awards for valor in Vietnam and are included in the 71 recipients of all wars living in our nation today; and

WHEREAS, Two of the Illinois Medal of Honor recipients who earned their Medal of Honor awards in Vietnam either entered service from Chicago or were born in Chicago, which is located on U.S. Highway 20: and

WHEREAS, The nonprofit Bend Heroes Foundation and the Oregon Legislature created a law designating all 451 miles of the border to border U.S. Highway 20 in Oregon as the Oregon Medal of Honor Highway, a first in our nation to honor all of a state's Medal of Honor recipients; and

WHEREAS, The Oregon law envisioned that a first ever national Medal of Honor Highway would be created on the 3,365 mile U.S. Highway 20, the longest highway in the United States, if all 11 states east of Oregon and through which U.S. Highway 20 traverses designate border to border Medal of Honor highways in their states; and

WHEREAS, Illinois has not dedicated a border to border highway to honor all of its Medal of Honor recipients; and

WHEREAS, A 234 mile border to border Illinois Medal of Honor highway on U.S. Highway 20 would honor current and future Medal of Honor recipients from Illinois and would also facilitate the 3,365 mile National Medal of Honor Highway across America; and

WHEREAS, Illinois deeply appreciates the service and sacrifice of its Medal of Honor recipients and the positive roles they have played in their communities for over 110 years; and

WHEREAS, Illinois veterans have offered to pay the cost to create and install the Illinois Medal of Honor Highway signs; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate the entire portion of U.S. Highway 20 in Illinois beginning at the Illinois/Iowa border and ending at the Illinois/Indiana border as the "Illinois Medal of Honor Highway", honoring current and future Medal of Honor recipients from Illinois; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name "Illinois

Medal of Honor Highway"; if appropriate and possible, the signs will include the three versions of the logos displaying a Medal of Honor; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Director of the Illinois Department of Veterans' Affairs and the President of the Illinois Council of Chapters of the Military Officers Association of America.

WHEREAS, The University of Illinois' 2018 Illinois Youth Survey found that 58% of 12th grade students used alcohol, tobacco, inhalants, or marijuana in the past year; and

WHEREAS, Interactions with their peers is a major component of a student's daily life; school days last for an average of 6.5 hours, and Illinois requires a minimum of 176 school attendance days each school year; therefore, students are exposed to their peers for a minimum of 1,144 hours each year; and

AMENDMENT NO. $\underline{1}$. Amend Senate Bill 317 by replacing everything after the enacting clause with the following:

"Section 5. The Illinois Promotion Act is amended by changing Sections 3, 4, 8a, and 13 as follows: (20 ILCS 665/3) (from Ch. 127, par. 200-23)

- Sec. 3. Definitions. The following words and terms, whenever used or referred to in this Act, shall have the following meanings, except where the context may otherwise require:
- (a) "Department" means the Department of Commerce and Economic Opportunity of the State of Illinois.
- (b) "Local promotion group" means any non-profit corporation, organization, association, agency or committee thereof formed for the primary purpose of publicizing, promoting, advertising or otherwise encouraging the development of tourism in any municipality, county, or region of Illinois.
- (c) "Promotional activities" means preparing, planning and conducting campaigns of information, advertising and publicity through such media as newspapers, radio, television, magazines, trade journals, moving and still photography, posters, outdoor signboards and personal contact within and without the State of Illinois; dissemination of information, advertising, publicity, photographs and other literature and material designed to carry out the purpose of this Act; and participation in and attendance at meetings and conventions concerned primarily with tourism, including travel to and from such meetings.
- (d) "Municipality" means "municipality" as defined in Section 1-1-2 of the Illinois Municipal Code, as heretofore and hereafter amended.
- (e) "Tourism" means travel 50 miles or more one-way or an overnight trip outside of a person's normal routine.
- (f) "Municipal amateur sports facility" means a sports facility that: (1) is owned by a unit of local government; (2) has contiguous indoor sports competition space; (3) is designed to principally accommodate and host amateur competitions for youths, adults, or both; and (4) is not used for professional sporting events where participants are compensated for their participation.
- (g) "Municipal convention center" means a convention center or civic center owned by a unit of local government or operated by a convention center authority, or a municipal convention hall as defined in paragraph (1) of Section 11-65-1 of the Illinois Municipal Code, with contiguous exhibition space ranging between 30,000 and 125,000 square feet.
- (h) "Convention center authority" means an Authority, as defined by the Civic Center Code, that operates a municipal convention center with contiguous exhibition space ranging between 30,000 and 125,000 square feet.
- (i) "Incentive" means: (1) a financial incentive provided by a unit of local government or convention center authority to attract a convention, meeting, or trade show held at a municipal convention center that, but for the incentive, would not have occurred in the State or been retained in the State; or (2) a financial incentive provided by a unit of local government for attracting a sporting event held at its municipal amateur sports facility that, but for the incentive, would not have occurred in the State or been retained in the State; but (3) only a financial incentive offered or provided to a person or entity in the form of financial benefits or costs which are allowable costs pursuant to the Grant Accountability and Transparency Act.
- (j) "Unit of local government" has the meaning provided in Section 1 of Article VII of the Illinois Constitution.
- (k) "Local parks" means any park, recreation area, or other similar facility owned or operated by a unit of local government.

Sec. 4. Powers. The Department shall have the following powers:

- (a) To formulate a program for the promotion of tourism and the film industry in the State of Illinois, including, but not limited to, the promotion of our State Parks and local parks, fishing and hunting areas, historical shrines, vacation regions and areas of historic or scenic interest.
- (b) To cooperate with civic groups and local, State and federal departments and agencies, and agencies and departments of other states in encouraging educational tourism and developing programs therefor.
 - (c) To publish tourist promotional material such as brochures and booklets.
- (d) To promote tourism in Illinois through all media, including but not limited to, the Internet, television, articles and advertisements in magazines, newspapers and travel publications and by establishing promotional exhibitions at fairs, travel shows, and similar exhibitions.
 - (e) To establish and maintain travel offices at major points of entry to the State.
 - (f) To recommend legislation relating to the encouragement of tourism in Illinois.
- (g) To assist municipalities, other units of local government, or local promotion groups in developing new tourist attractions including but not limited to feasibility studies and analyses, research and development, and management and marketing planning for such new tourist attractions.
 - (h) (Blank).
- (i) To implement a program of matching grants and loans to counties, municipalities, other units of local government, local promotion groups and others, as provided in Sections 5 and 8a of this Act, for the development or improvement of tourism attractions and tourism events in Illinois under the terms and conditions provided in this Act.
- (j) To expend funds from the International and Promotional Fund, subject to appropriation, on any activity authorized under this Act.
- (k) To do any other acts that, in the judgment of the Department, are necessary and proper in fostering and promoting tourism in the State of Illinois.

Sec. 8a. Tourism grants and loans.

(1) The Department is authorized to make grants and loans, subject to appropriations by the General Assembly for this purpose from the Tourism Promotion Fund, to counties, municipalities, other units of local government, local promotion groups, not-for-profit organizations, or for-profit businesses for the development or improvement of tourism attractions in Illinois. Individual grants and loans shall not exceed \$1,000,000 and shall not exceed 50% of the entire amount of the actual expenditures for the development or improvement of a tourist attraction. Agreements for loans made by the Department pursuant to this subsection may contain provisions regarding term, interest rate, security as may be required by the Department and any other provisions the Department may require to protect the State's interest.

AMENDMENT NO. $\underline{1}$. Amend Senate Bill 1819 by replacing everything after the enacting clause with the following:

"Section 5. The School Code is amended by adding Section 22-92 as follows:

(105 ILCS 5/22-92 new)

Sec. 22-92. Rural Education Advisory Council.

- (a) The Rural Education Advisory Council is created as a statewide advisory council to exchange thoughtful dialogue concerning the needs, challenges, and opportunities of rural schools districts and to provide policy recommendations to the State. The Council shall perform all of the following functions:
 - (1) Convey and impart the perspective of rural communities and provide context during policy discussions on various statewide issues with the State Superintendent of Education and State Board of Education.
 - (2) Present to the State Superintendent of Education the opportunity to provide an explanation to rural communities about the statewide perspective with regard to various policy and legal issues, to present feedback on critical issues facing rural communities, to generate ideas, and to communicate information to the State Superintendent.
 - (3) Provide feedback about this State's pre-kindergarten through grade 20 practices and policies in order that the application of policies in rural areas may be more fully understood.
 - (4) Analyze and monitor the continued impact of the implementation of Public Act 100-465 on school districts and to provide a rural perspective on the continued funding challenges faced by schools.
 - (b) The Council shall consist of all of the following members:
 - (1) The State Superintendent of Education or his or her designee.
 - (2) The Executive Director of the Association of Illinois Rural and Small Schools or his or her designee appointed by the State Superintendent of Education.
 - (3) The Executive Director of the Illinois Community College Board or his or her designee.
 - (4) Five superintendents of rural school districts who represent 3 super-regions of this State recommended by the Executive Director of the Association of Illinois Rural and Small Schools and appointed by the State Superintendent of Education.
 - (5) One principal from a rural school district recommended by the Illinois Principal Association and appointed by the State Superintendent of Education.
 - (6) One elementary school teacher who teaches in a rural school district that is eligible under the federal Rural Education Achievement Program appointed by the State Superintendent of Education from a list of school teachers nominated by school principals.
 - (7) One secondary school teacher who teaches in a rural school district that is eligible under the federal Rural Education Achievement Program appointed by the State Superintendent of Education from a list of school teachers nominated by school principals.
 - (8) One representative from the Illinois Association of School Boards appointed by the State Superintendent of Education.
 - (9) One representative from the Board of Directors of the Illinois Association of School Administrators appointed by the State Superintendent of Education.
 - (10) The President of the Illinois Association of Regional School Superintendents or his or her designee appointed by the State Superintendent of Education.
 - (11) One student who is at least 16 years old and who is from a rural school district that is eligible under the federal Rural Education Achievement Program appointed by the State Superintendent of Education from a list of students nominated by school principals.
- Council members shall serve without compensation, but shall be reimbursed for their reasonable and necessary expenses from funds appropriated to the State Board of Education for that purpose.
- (c) The Council shall meet initially at the call of the State Superintendent of Education, shall select one member as chairperson at its initial meeting, and shall thereafter meet at the call of the chairperson.
- (d) The State Board of Education shall provide administrative and other support to the Council, with assistance from the Association of Illinois Rural and Small Schools. Support shall include all of the following:
 - (1) To collaborate with the State Superintendent of Education to create a clear and strategically focused agenda with expected outcomes.

- (2) To gather input from the Council and other stakeholders to ensure that meetings are productive.
- (3) To coordinate with presenters to ensure that presentations are designed to prompt discussions and problem solving.
 - (4) To assist with necessary research and content creation between Council meetings.
- (5) To cooperate with other State agencies and the General Assembly to assist in keeping the Council informed of major policy developments that may impact rural schools and students.
- (6) To take meeting minutes and work with the Council to ensure that Open Meetings Act requirements are satisfied."

Senator Sims offered the following amendment and moved its adoption:

AMENDMENT NO. 2 TO SENATE BILL 2182

AMENDMENT NO. 2 . Amend Senate Bill 2182 by replacing everything after the enacting clause with the following:

"Section 5. The Department of Commerce and Economic Opportunity Law of the Civil Administrative Code of Illinois is amended by changing Section 605-1025 as follows:

(20 ILCS 605/605-1025)

Sec. 605-1025. Data center investment.

- (a) The Department shall issue certificates of exemption from the Retailers' Occupation Tax Act, the Use Tax Act, the Service Use Tax Act, and the Service Occupation Tax Act, all locally-imposed retailers' occupation taxes administered and collected by the Department, the Chicago non-titled Use Tax, and a credit certification against the taxes imposed under subsections (a) and (b) of Section 201 of the Illinois Income Tax Act to qualifying Illinois data centers.
- (b) For taxable years beginning on or after January 1, 2019, the Department shall award credits against the taxes imposed under subsections (a) and (b) of Section 201 of the Illinois Income Tax Act as provided in Section 229 of the Illinois Income Tax Act.
 - (c) For purposes of this Section:

"Data center" means a facility: (1) whose primary services are the storage, management, and processing of digital data; and (2) that is used to house (i) computer and network systems, including associated components such as servers, network equipment and appliances, telecommunications, and data storage systems, (ii) systems for monitoring and managing infrastructure performance, (iii) Internet-related equipment and services, (iv) data communications connections, (v) environmental controls, (vi) fire protection systems, and (vii) security systems and services.

"Qualifying Illinois data center" means a new or existing data center that:

- (1) is located in the State of Illinois, is located within a 5-mile geographic radius, and is connected by common infrastructure;
- (2) in the case of an existing data center, made a capital investment of at least \$250,000,000 collectively by the data center operator and the tenants of the data center over the 60-month period immediately prior to January 1, 2020 or committed to make a capital investment of at least \$250,000,000 over a 60-month period commencing before January 1, 2020 and ending after January 1, 2020; or
- (3) in the case of a new data center, or an existing data center making an upgrade, makes a capital investment of at least \$250,000,000 over a 60-month period beginning on or after January 1, 2020; and
- (4) in the case of both existing and new data centers, results in the creation of at least 20 full-time or full-time equivalent new jobs over a period of 60 months by the data center operator

and the tenants of the data center, collectively, associated with the operation or maintenance of the data center; all jobs associated with a qualifying data center meeting its job creation requirements those jobs must have a total compensation equal to or greater than 120% of the average wage paid to full-time employees in the county where the data center is located, as determined by the U.S. Bureau of Labor Statistics; and

- (5) within 2 years 90 days after being placed in service, certifies to the Department that it is carbon neutral or has attained certification under one or more of the following green building standards:
 - (A) BREEAM for New Construction or BREEAM In-Use;
 - (B) ENERGY STAR;
 - (C) Envision;
 - (D) ISO 50001-energy management;
 - (E) LEED for Building Design and Construction or LEED for Operations and Maintenance:
 - (F) Green Globes for New Construction or Green Globes for Existing Buildings;
 - (G) UL 3223; or
 - (H) an equivalent program approved by the Department of Commerce and Economic Opportunity, except that entering into an agreement with an independent business or entity unrelated to the data center for the purchase, sale, or transfer of carbon credits that would not result in carbon neutral outcomes at the actual site of the data center shall not qualify as an eligible program for the purposes of this Section.

"Full-time equivalent job" means a job in which the new employee works for the owner, operator, contractor, or tenant of a data center or for a corporation under contract with the owner, operator or tenant of a data center at a rate of at least 35 hours per week. An owner, operator or tenant who employs labor or services at a specific site or facility under contract with another may declare one full-time, permanent job for every 1,820 man hours worked per year under that contract. Vacations, paid holidays, and sick time are included in this computation. Overtime is not considered a part of regular hours.

"Qualified tangible personal property" means: electrical systems and equipment; climate control and chilling equipment and systems; mechanical systems and equipment; monitoring and secure systems; emergency generators; hardware; computers; servers; data storage devices; network connectivity equipment; racks; cabinets; telecommunications cabling infrastructure; raised floor systems; peripheral components or systems; software; mechanical, electrical, or plumbing systems; battery systems; cooling systems and towers; temperature control systems; other cabling; and other data center infrastructure equipment and systems necessary to operate qualified tangible personal property, including fixtures; and component parts of any of the foregoing, including installation, maintenance, repair, refurbishment, and replacement of qualified tangible personal property to generate, transform, transmit, distribute, or manage electricity necessary to operate qualified tangible personal property; and all other tangible personal property that is essential to the operations of a computer data center. "Qualified tangible personal property" also includes building materials physically incorporated in to the qualifying data center.

"Tenant" means an entity that leases, subleases, or licenses with the owner or operator of a qualified data center that is certified under this Section to use or occupy all or part of the data center for a period of at least one year.

To document the exemption allowed under this Section, the retailer must obtain from the purchaser a copy of the certificate of eligibility issued by the Department.

- (d) New and existing data centers seeking a certificate of exemption for new or existing facilities shall apply to the Department in the manner specified by the Department. The Department shall determine the duration of the certificate of exemption awarded under this Act. The duration of the certificate of exemption may not exceed 20 calendar years. The Department and any data center seeking the exemption, including a data center operator on behalf of itself and its tenants, must enter into a memorandum of understanding that at a minimum provides:
 - (1) the details for determining the amount of capital investment to be made;
 - (2) the number of new jobs created;
 - (3) the timeline for achieving the capital investment and new job goals;

- (4) the repayment obligation should those goals not be achieved and any conditions under which repayment by the qualifying data center or data center tenant claiming the exemption will be required;
 - (5) the duration of the exemption; and
 - (6) other provisions as deemed necessary by the Department.
- A data center and an associated tenant may also enter into an ancillary memorandum of understanding, as prescribed by the Department, for purposes of receipt of the exemption.
- (e) Beginning July 1, 2021, and each year thereafter, the Department shall annually report to the Governor and the General Assembly on the outcomes and effectiveness of Public Act 101-31 that shall include the following:
 - (1) the name of each recipient business;
 - (2) the location of the project;
 - (3) the estimated value of the credit;
 - (4) the number of new jobs and, if applicable, retained jobs pledged as a result of the project; and
 - (5) whether or not the project is located in an underserved area.
- (f) New and existing data centers seeking a certificate of exemption related to the rehabilitation or construction of data centers in the State shall require the contractor and all subcontractors to comply with the requirements of Section 30-22 of the Illinois Procurement Code as they apply to responsible bidders and to present satisfactory evidence of that compliance to the Department.
- (g) New and existing data centers seeking a certificate of exemption for the rehabilitation or construction of data centers in the State shall require the contractor to enter into a project labor agreement approved by the Department.
- (h) Any qualifying data center issued a certificate of exemption under this Section must annually report to the Department the total data center tax benefits that are received by the business. Reports are due no later than May 31 of each year and shall cover the previous calendar year. The first report is for the 2019 calendar year and is due no later than May 31, 2020.

To the extent that a business issued a certificate of exemption under this Section has obtained an Enterprise Zone Building Materials Exemption Certificate or a High Impact Business Building Materials Exemption Certificate, no additional reporting for those building materials exemption benefits is required under this Section.

Failure to file a report under this subsection (h) may result in suspension or revocation of the certificate of exemption. Factors to be considered in determining whether a data center certificate of exemption shall be suspended or revoked include, but are not limited to, prior compliance with the reporting requirements, cooperation in discontinuing and correcting violations, the extent of the violation, and whether the violation was willful or inadvertent.

- (i) The Department shall not issue any new certificates of exemption under the provisions of this Section after July 1, 2029. This sunset shall not affect any existing certificates of exemption in effect on July 1, 2029.
 - (j) The Department shall adopt rules to implement and administer this Section.
- (k) The Department is authorized to conform existing memorandums of understanding with the provisions of this Section.
