Offered by Senator D. Turner and all Senators: Mourns the passing of Deidre Nicole Silas of Springfield.

#### **SENATE RESOLUTION NO. 822**

Senator Collins offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### **SENATE RESOLUTION NO. 820**

WHEREAS, Reverend Dr. Martin Luther King Jr. walked into the heart of Jim Crow demanding change from those intransigents in their hatred; his courage was unquestioned, his method of nonviolence was risky, and his style was unapologetic; and

WHEREAS, At 34 years of age, Dr. King received international recognition with the awarding of the Nobel Peace Prize; and

WHEREAS, The U.S. Federal Bureau of Investigation (FBI) immorally recorded the life and conversations of Dr. King; and

WHEREAS, The FBI began monitoring Dr. King in December 1955 during his involvement with the Montgomery Bus Boycott and engaged in covert operations against him throughout the 1960s; and

WHEREAS, For the last four and one-half years of his life, from November 1963 until his death in April 1968, Dr. King lived without any semblance of privacy; his hotel rooms were bugged, his phones tapped, and his office and inner circle infiltrated by informants; and

WHEREAS, On November 21, 1964, the FBI anonymously sent Dr. King a letter encouraging him to commit suicide to avoid public embarrassment; and

WHEREAS, According to a U.S. Senate Committee convened in the 1970s to investigate the FBI's domestic intelligence operations, when Dr. King condemned the Vietnam War in a speech at Riverside Church on April 4, 1967, the FBI interpreted this position as proof he "has been influenced by Communist advisors" and increased their covert operations against him; and

WHEREAS, In August 1967, the FBI created a counterintelligence program, COINTELPRO, which targeted Dr. King, the Black Panther Party, and other civil rights leaders; and

WHEREAS, The FBI's surveillance tapes and the transcripts of them remain under seal until 2027; and

WHEREAS, Dr. King is critical to memorializing the Black experience in America; his mission and the challenges he unfortunately confronted remain timeless, and no one has the right to feed on his legacy; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Governor Pritzker to express written support for the destruction of the National Archives and Record Administration's immorally obtained surveillance tapes on Dr. Martin Luther King; and be it further

RESOLVED, That we urge Governor Pritzker to work with the Illinois General Assembly to pass legislation that will prevent similar abuses of power from being perpetrated for immoral and defamatory reasons; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor Pritzker, Lt. Governor Stratton, Governor Pritzker's Office of Equity, and the Illinois Attorney General.

#### SENATE JOINT RESOLUTION NO. 46

WHEREAS, It is appropriate to remember the many sacrifices and contributions to the cause of freedom made by the outstanding men and women who served in the U.S. Armed Forces; and

WHEREAS, First Lieutenant James F. Claussen was born to Ernest and Stella Claussen on Christmas Day in 1921; at the time, the family lived on a small farm near Jacob; and

WHEREAS, 1LT Claussen voluntarily enlisted in the U.S. Army in June of 1940 with the goal of becoming a paratrooper; he did not meet the Army's size requirements to become a paratrooper and redirected his efforts to becoming a pilot; and

WHEREAS, From June of 1943 until his death in March of 1945, 1LT Claussen flew seven combat missions over Sicily, France, Holland, and Germany; and

WHEREAS, On March 24, 1945, 1LT Claussen was killed in action while taking part in Operation Varsity; while his three year commitment when enlisting had ended, he volunteered to fly the day he was killed in action; his C-46 Commando was last seen with its left engine on fire heading back across the Rhine River after successfully dropping all of its paratroopers; and

WHEREAS, 1LT Claussen was the recipient of the Air Medal, the American Defense Service Medal, and the Good Conduct Medal; he was posthumously awarded the Purple Heart; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE HOUSE OF REPRESENTATIVES CONCURRING HEREIN, that we designate the portion of Illinois Route 3 between mile marker 20 and mile marker 22, near Rockwood, as the "1LT James F. Claussen Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name of "1LT James F. Claussen Memorial Highway"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Secretary of Transportation and the family of 1LT Claussen.
