WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to those who have made a difference in their community and the State of Illinois; and

WHEREAS, South Roxana Fire Chief William "Todd" Werner passed away on July 1, 2021, at the age of 48; and

WHEREAS, Chief Werner was born in Carlinville on September 9, 1972; he was the son of Josie (Fischer) Sparks and the late William "Bill" Sparks; he married Sonja Krotz on August 26, 2006; and

WHEREAS, Chief Werner worked in the fire service for 30 years; he joined the South Roxana Fire Department in 1996, becoming the chief in 2013; and

WHEREAS, Chief Werner had been employed by the Madison County Sheriff's Office for the last three years; he was a member of the South Roxana Dad's Club and the Madison County Emergency Management Association; at the time of his passing, he was serving as village trustee for the Village of South Roxana; and

WHEREAS, Chief Werner is survived by his mother; his wife; his sons, Christopher Moore, Devin Moore, and Austin Moore; his sister, Carla Lattimore; his many nieces and nephews; and other extended family and friends; and

WHEREAS, Chief Werner devoted his entire life to public service and was the epitome of selfless service to his community; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate Illinois Route 111 from New Poag Road to Madison Avenue as "The Chief Todd Werner Memorial Highway"; and be it further

Mr. President -- I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

HOUSE JOINT RESOLUTION NO. 57

WHEREAS, It is highly fitting that the Illinois General Assembly pay respect to the life of former Illinois State Senator John Benjamin "Jack" Roe III by honoring him with a memorial overpass on Rochelle State Route 251; and

WHEREAS, Sen. Roe's family has a long history of service to the State of Illinois; and

WHEREAS, Sen. Roe's great-grandfather, Dr. John Roe, was born near Philadelphia, Pennsylvania in 1800 and moved to Ogle County in 1836; he was the first doctor in the Rock River Valley; he established a farm and medical practice on a hill, which later became known as "Lighthouse Point" because Dr. Roe and his wife kept a light burning in a window as a beacon so that all knew how to find the doctor; that land now houses the Lighthouse Church and Cemetery and was donated by the Roe family; and

WHEREAS, Sen. Roe was born to Jane Gilbert and John B. Roe II on November 21, 1942; he graduated from Oregon Community High School in 1960 and Center College in Danville, Kentucky in 1964 with a Bachelor of Arts in Political Science and History; and

WHEREAS, Sen. Roe attended the University of Illinois, where he graduated from law school in 1967 and began his practice of law in Ogle County; he served as a public defender for the county and was then elected the youngest state's attorney in Illinois in 1968; and

WHEREAS, Sen. Roe was elected State Senator of the 35th District of Illinois in 1972 and was the first freshman senator to be appointed to the Committee of Committees; he also served on the Legislative Investigative Commission; and

WHEREAS, Sen. Roe sponsored the Illinois Campaign Disclosure Act, requiring candidates for public office to disclose their contributors and their expenditures; and

WHEREAS, Sen. Roe sponsored and passed legislation that appropriated the necessary funds for the first leg of the North-South Freeway from Rockford to the west tollway extension of Rochelle and legislation allocating money for the U.S. 20 Freeway Bypass system to be built from Lena to east of Freeport; and

WHEREAS, In 1976, Sen. Roe was approached by Robert "Bob" Hultgren, a local businessman and entrepreneur, and Mayor Bill Cipolla to obtain assistance and funding to place an overpass on then U.S. Route 51 through Rochelle; at that time, U.S. Route 51 was the major north-south thoroughfare through the state; Rochelle had two sets of railroad tracks, the Chicago Northwestern and Burlington Northern; as many as 80 trains a day went through Rochelle, creating delays of 15 to 20 minutes for each train; the city had become known as Jamtown and Delaysville by truckers; and

WHEREAS, Sen. Roe obtained the money necessary to construct the Rochelle overpass; and

WHEREAS, Sen. Roe was appointed Chief Justice of the Illinois Court of Claims by Governor Jim Thompson in 1979; he was a member of the Rochelle Grade School Board of District 230 from 1982 to 1984; and

WHEREAS, Sen. Roe. practiced law in Rochelle from 1973 to 1995; he was appointed a circuit judge in 1995 by the Illinois Supreme Court and was elected as a circuit judge in 1996; and

WHEREAS, Sen. Roe retired as a judge in 2000 and was a member of the Governor's Commission to Revise and Rewrite The Illinois Criminal Code; he was also a member of the board of the Abraham Lincoln Presidential Library and Museum and served on the faculty at Stetson University College of Law in St. Petersburg, Florida as an adjunct professor; he was a Certified Florida County Circuit and Family Mediator and a Certified Mediator of the U.S. District Court Middle District of Florida and U.S. District Court Northern District of Illinois; he was a Florida Bar Association arbitrator and mediator and was a certified mediator and arbitrator of the 12th Circuit of Florida and the 15th Circuit of Illinois; he was a Manatee County Florida administration hearing officer and was an arbitrator for the New York and Nasdaq Stock Exchanges; and

WHEREAS, Sen. Roe was preceded in death by his parents; and

WHEREAS, At the time of his passing, Sen. Roe was survived by his wife of 47 years, Phyllis, who was his companion, love, best friend, and caretaker; his son, John B. "Ben" (Irene) Roe IV; his stepdaughter, Julie (Jim) Watt; his grandchildren, John Benjamin Roe V, Mary Margaret Roe, Justin Watt, and Emma Watt; his sister, Ruth Roe Arth; and many nieces and nephews and extended family members; and

WHEREAS, Without the leadership, statesmanship, and perseverance of Sen. Roe, the Rochelle overpass would not have been built; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the Rochelle State Route 251 overpass as the "Sen. John B. "Jack" Roe Overpass"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal highway regulations, appropriate plaques or signs giving notice of the name of the "Sen. John B. "Jack" Roe Overpass"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Sen. Roe, the Secretary of the Illinois Department of Transportation, and the Mayor of City of Rochelle.

Mr. President -- I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

HOUSE JOINT RESOLUTION NO. 55

WHEREAS, The State of Illinois is in great need of a state conviction integrity unit, run by the Attorney General's Office, to identify and overturn wrongful convictions, and to set free those falsely imprisoned; and

WHEREAS, A conviction integrity unit investigates claims of innocence to determine whether new evidence gives rise to a substantial probability that the convicted defendant was not the person who

committed the offense of conviction; a conviction integrity unit can also make recommendations about the appropriate remedy, if any, that should result from its findings; and

WHEREAS, The Attorney General's Office is best positioned to run a conviction integrity unit because its resources far exceed those of local prosecutors; and

WHEREAS, According to the National Registry of Exonerations, 78 prosecutors and attorneys general have created conviction integrity or review units in the past decade; 461 people have been freed due in part to work by these prosecutors; and

WHEREAS, Attorneys general in Washington D.C. and in eight states, including Connecticut, Delaware, Michigan, Minnesota, New Jersey, New York, Pennsylvania, and Virginia, have launched conviction review units; and

WHEREAS, Since 2018, the Philadelphia District Attorney's Office, under Larry Krasner, has exonerated 17 people wrongly convicted of murder; Baltimore State's Attorney Marilyn Mosby has cleared 10 people serving murder or attempted murder sentences since 2016; and

WHEREAS, A convictions integrity unit will aid in achieving and ensuring justice by investigating claims of innocence, remedying identified wrongful convictions, and providing proactive support and recommendations to the Attorney General's Office; and

WHEREAS, Conviction integrity units can assist in addressing racial inequity in the criminal justice system and mass incarceration; and

WHEREAS, The State of Illinois' goal should be for justice and truth instead of preserving convictions in defiance of logic, facts, or new evidence; to wrongly convict a person is to deny them untold opportunities and the chance to live their life in freedom; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we urge the Office of the Attorney General to establish a task force to examine the creation of a statewide conviction integrity unit within its office; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Attorney General Kwame Raoul and Governor JB Pritzker.
