#### **SENATE RESOLUTION NO. 934**

WHEREAS, The Illinois State Police will celebrate 100 years of service to the State of Illinois on April 1, 2022; and

WHEREAS, The Illinois State Police began as part of the Department of Public Works and Buildings with the appointment of former Kankakee Police Chief John Stack as the agency's first superintendent and the first eight highway patrolmen on April 1, 1922; and

WHEREAS, The Illinois State Police's initial mission was to enforce the road weight laws of the State, patrolling 1,110 miles of newly paved road; the agency used Superintendent John Stack's residence as its original headquarters, and the patrolmen's equipment consisted of surplus World War I uniforms and motorcycles, which included portable scales in their sidecars for weighing trucks to determine overloads; Superintendent Stack held officers to a higher standard than most officers in the State at the time, and this legacy of exemplary ethics and standards has continued to this day; and

WHEREAS, From its humble beginnings, the Illinois State Police has grown into 21 patrol districts, eight investigative zones, six operational forensic science laboratories, and five regional crime scene services commands; it is now comprised of several divisions, including Academy and Training, Patrol, Criminal Investigation, Forensic Services, Justice Services, Statewide 9-1-1, and Internal Investigation; and

WHEREAS, As of 2021, more than 70 troopers of the Illinois State Police have made the ultimate sacrifice by giving their lives in service to the State and its citizens; and

WHEREAS, The mission of the Illinois State Police is to promote public safety with Integrity, Service, and Pride to improve the quality of life for the citizens of Illinois; over the years, the agency has continued its mission while evolving in law enforcement duties, expectations, responsibilities, training, equipment, technology, and objectives, making it one of the preeminent law enforcement departments; and

WHEREAS, The Illinois State Police is currently helmed by Director Brendan F. Kelly; therefore, be it

RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the month of April 2022 as Illinois State Police Centennial Month in the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Illinois State Police, the Illinois State Police Heritage Foundation, and Illinois Troopers Lodge #41.

Senator Villanueva offered the following Senate Resolution, which was referred to the Committee on Assignments:

#### **SENATE RESOLUTION NO. 936**

WHEREAS, The Brighton Park Neighborhood Council (BPNC) is a community-based, non-profit organization serving the Brighton Park community, a predominantly Latinx, low-income working class neighborhood on Chicago's southwest side; and

WHEREAS, BPNC's mission is to create a safer community, improve the learning environment at public schools, preserve affordable housing, provide a voice for youth, protect immigrants' rights, promote gender equity, and end all forms of violence; and

WHEREAS, Founded in 1997, BPNC unites individuals and neighborhood institutions to organize campaigns to obtain essential resources for a predominantly immigrant community, improve public policy, and address the root causes of poverty and inequality; and

WHEREAS, BPNC works to address a range of community issues through school and community-based services, including school-based programs, trauma-informed counseling addressing child abuse and domestic violence, violence prevention, case management services, health and wellness, foreclosure prevention and financial literacy, and public benefits enrollment; and

WHEREAS, Since its inception in 1997, BPNC has worked to achieve three goals: (1) to develop and train community residents as grassroots leaders to lead campaigns for neighborhood improvement and development, (2) to develop the social service infrastructure to address the needs of the community, and (3) to build community by bringing together leaders and institutions from throughout the neighborhood; its model engages low-income and immigrant Latinx community members who are most affected by the lack of access to healthcare, public education funding inequities, immigration reform, and economic injustice; and

WHEREAS, BPNC works to unite local institutions, community leaders, funders, community partners, and vested stakeholders to improve the service infrastructure of the Brighton Park community; it has worked diligently to increase community partnerships and improve collaborations with local institutions and philanthropic organizations to maximize funder dollars without duplicating programs; and

WHEREAS, In 2012, BPNC worked with United Way Metropolitan Chicago (UWMC) to develop the Brighton Park Neighborhood Network (BPNN), which focuses its efforts on developing an infrastructure of social services within Brighton Park to support cradle-to-career opportunities for children, youth, and young adults; BPNN has worked collaboratively to develop a common agenda to develop a more robust and efficient social service infrastructure and to engage institutions and community leaders in policy change campaigns in the four key areas of violence prevention and public safety, education, health, and income/economic development; through the BPNN collaborative, BPNC has coordinated resources among community service providers and other institutions to develop a pipeline of services to support student's academic and social emotional growth from 1st grade to 12th grade; and

WHEREAS, Over the course of its inception, BPNC has served thousands of families across Brighton Park and the southwest side of Chicago in a variety of capacities; most recently, since April 2020, BPNC has provided over \$2.5 million in direct cash assistance, food assistance, rental and mortgage assistance, and utility assistance for over 1,000 families in the community in response to the COVID-19 pandemic; over the past ten years, BPNC has registered over 8,500 people to become part of the donor registry in Illinois; BPNC has also seen hundreds of individuals become U.S. citizens through its citizenship program; BPNC continues to maintain a strong commitment to its full-service community schools program, working closely with local Chicago Public School partners to provide students and their families academic, social-emotional, and mental health support; therefore, be it RESOLVED, BY THE SENATE OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge support for community-based, non-profit organizations such as the Brighton Park Neighborhood Council as they strive to improve their neighborhoods; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the BPNC as a symbol of our respect and esteem.

Mr. President -- I am directed to inform the Senate that the House of Representatives has adopted the following joint resolution, in the adoption of which I am instructed to ask the concurrence of the Senate, to-wit:

#### **HOUSE JOINT RESOLUTION NO. 75**

WHEREAS, Tobacco smoke is a major contributor to indoor air pollution, and breathing secondhand smoke is a cause of disease and death, including heart disease, stroke, respiratory disease, lung cancer, low birth-weight babies, sudden infant death syndrome (SIDS), increased respiratory infections in children, asthma in children and adults, sinus cancer, and breast cancer in younger, premenopausal women; and WHEREAS, The 2006 U.S. Surgeon General report, The Health Consequences of Involuntary Exposure to Tobacco Smoke, estimated that exposure to secondhand smoke kills approximately 50,000 people in the United States annually, including approximately 2,000 in Illinois; there is no risk-free level of exposure to secondhand smoke; ventilation and other air cleaning technologies cannot completely control for exposure of nonsmokers to secondhand smoke; smoke-free workplace policies are the only effective way to eliminate secondhand smoke exposure in the workplace, and evidence shows that smoke-free policies and laws do not have an adverse economic impact on the hospitality industry; and

WHEREAS, The Illinois Department of Public Health reported a 28.4 percent decline in the smoking rate after the Smoke Free Illinois Act (the Act) was enacted in 2008 in addition to a 4.1 percent and 1.4 percent decline in the mortality rate for heart disease and lung cancer, respectively; the number of callers to the Illinois Tobacco Quitline increased dramatically after the Act became law from 7,255 in 2006 to 24,575 in 2012; in 2011, 91 percent of adults reported no exposure to secondhand smoke in indoor public places, and 89% of Illinois adults believed policies not allowing tobacco use in indoor or outdoor public places should be strictly enforced; and

WHEREAS, Twenty-eight states and the District of Columbia have passed comprehensive smoke-free laws to protect people against the harmful effects of secondhand smoke; and

WHEREAS, Aerosol from electronic cigarettes has a high concentration of heavy metals, volatile organic compounds, and ultrafine particles; the particle concentration is higher than in conventional tobacco cigarette smoke; exposure to fine and ultrafine particles may exacerbate respiratory ailments like asthma and constrict arteries, which could trigger a heart attack; and

WHEREAS, The World Health Organization (WHO) recommends that electronic cigarettes not be used indoors, especially in smoke-free environments, in order to minimize the risk to bystanders of breathing in the aerosol emitted by the devices and to avoid undermining the enforcement of smoke-free laws; and

WHEREAS, Secondhand smoke from combusted marijuana contains many of the same toxins, irritants, and carcinogens as tobacco smoke that can be breathed deeply into the lungs, which can cause lung irritation and asthma attacks and makes respiratory infections more likely; exposure to fine particulate matter can exacerbate health problems, especially for people with respiratory conditions like asthma, bronchitis, or chronic obstructive pulmonary disease; research has shown that secondhand marijuana smoke can do as much damage to the heart and blood vessels as secondhand tobacco smoke; and

WHEREAS, The American Society for Heating, Refrigeration, and Air-Conditioning Engineers (ASHRAE), the standard setting body for the HVAC industry, affirms that mechanical solutions like ventilation cannot control for the health hazards of secondhand smoke, and its standard (62.1) for acceptable indoor air quality is based on an environment that is free from tobacco and marijuana smoke and secondhand aerosol from electronic cigarettes; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED SECOND GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we strive to protect and strengthen the Smoke Free Illinois Act and urge the Illinois Department of Public Health to provide a data brief by 2023 on the impact of the Act since 2013 to commemorate the 15th anniversary of the Act's enactment; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Illinois Department of Public Health.

WHEREAS, Staff Sergeant Hollinsaid was an avid outdoorsman and loved to hunt and drive his pickup, which he had adapted to use for four wheeling in the rough terrain and mountains of Southern California; therefore, be it
