All I'm saying is that we have had 7. nothing but trouble with notifying candidates as to the time they were 8. to file. At this present time, this bill, 2878, would provide the 9. candidates, who'd not filed, would be given another opportunity to 10. I've read several editorials in newspapers saying that perfile. haps these people have made mistakes and they ought to be given 11. 12. another chance. One of the thing, which will be different in the future from the past, is that we now have a State Board of Elec-13. 14. tions; a State Board of Elections, which can have the time and the 15. interest and the know how to notify all candidates what their obli-16. gations are with reference to the Ethics Act. Now, one of the things 17. that causes me a great deal of grief is the knowledge that today 18. there are over five hundred suits on file throughout the State of 19. Illinois by candidates who have not filed their ethics statement, seeking to overturn the law, seeking to provide for themselves an 20. avenue for filing. They're all over the State. There'll be suits 21. filed and there have been in many, many counties. The Attorney 22. 23. General will be having persons in various counties representing 24. them. There is no over-all, one kind of approach by way of defense. 25. You'll have fifty different areas with fifty different kinds of judgments and it makes the whole thing look very ridiculous. 26. Now. what this amendment does is to repeal, repeal that section of the 27. law which requires ethics statements to be filed for local candidates. 28. The suggestion had been made that the repeal should be for all can-29. didates for this election. We cannot do that because the Constitu-30. tion mandates that persons running for State offices, including 31. The main point 14. of this amendment seems to be that the people of Alton don't 15. want this land for a park and I happen to be the Senator of 16. that district. And, I say they do want that land. Some 17. persons have urg...used a 1971 referendum as a sign that Alton 18. doesn't want a park. Well, first of all, that was 1971, not 19. 1974.
