Now, this bill is in response to serious difficulties that arise when the developers fail to -- or refuse to comply with the statute. This bill encompasses a fee recovery provision which will deter

the developers from failing or refusing to comply and is a consumer protection in the event legal action is necessary to obtain statutory compliance. I amended the bill at the request of the Home Builders with regard to the burden of proof, and I know of no opposition, with the possible exception of former Representative Ellis Levin. SENATOR HALVORSON:

In this bill, what we're against is -- and -- is the fact that the UI trust fund balance is expected to be bankrupt by the year 2005, and this is another part of the agreed bill process, that we need to take a look at this. At a time when our economy is as good as it is, it's not the time to start fooling with this, because I can remember there were times where the economy wasn't so good and we were going back looking to bring money into it. Thank you.

SENATOR LAUZEN:

I would just appreciate a Yes vote.

Senator Noland.

SENATOR NOLAND:

Thank you, Mr. President. Senate Bill 354 amends the Motor Fuel Tax (Law) and would provide that railroads that are currently licensed as bulk users of fuel would not have to be a distributor or a supplier in this State.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Is there any discussion? If not, the question is, shall Senate Bill -- I tried, Duane. Senator Burzynski.

SENATOR BURZYNSKI:

Thank you, Mr. President. Will the sponsor yield?

SENATOR BURZYNSKI:

Is that in their diesel locomotives or is that in the caboose, or what?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Noland.

SENATOR NOLAND:

They would generally refuel the locomotive.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Burzynski.

SENATOR BURZYNSKI:

Do you know of any instances where they've refueled, other than the locomotive?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Noland.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Noland.

SENATOR NOLAND:

Well, as a child I had an HO train set, and I've always had a fascination for railroads. And the railroad industry came to me and asked me to carry this very important piece of legislation that will make -- that will make the railroad industry more competitive and expand jobs, create wealth, eliminate crime in Illinois.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Burzynski.

SENATOR BURZYNSKI:

Well, Mr. -- Mr. President, and -- and to the fine sponsor of the bill: Just because you rode on HO train sets as a child and have a fixation on that, I'm not sure if that's a good enough reason for us to -- to support this bill. I -- I have some real reservations about that.

SENATOR HAWKINSON:

Thank you, Mr. President. This bill amends the Code of Civil Procedure dealing with special appearances. It is not an initiative of the Illinois State Bar Association but it was suggested by the Bar Association. It's a cleanup. It is designed to prevent an unknowing waiver. When you file a motion in court,

Senator Dillard.

SENATOR DILLARD:

Senator Shaw, this type of disorderly conduct is only for what is commonly referred to as a Peeping Tom. So you could have disorderly conducts before for different conduct. Here you'd have to be a Peeping Tom multiple times.

Senator Dillard.

SENATOR DILLARD:

SENATOR LAUZEN:

Provides for the confidentiality of all reports of regulatory examinations and related items, except for disclosure of the reports to other State or federal regulatory authorities or law enforcement personnel and all documents and records prepared or obtained in connection with or relating to the examination, visitation or investigation. PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

This -- this, Senator, is a request from the Community Bankers. The bill is broadening the confidential umbrella that exists already to include reports of regulatory visitation and investigation.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Demuzio.

SENATOR DEMUZIO:

Having not read the bill, but the synopsis indicates that the -- the documents -- classifies the documents, records -- records, examination, visitations, and investigations of a bank prepared by the Commissioner of Banks is confidential supervisory information and designates such information as property of the Commissioner. What does that mean?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley. Senator Demuzio.

SENATOR DEMUZIO:

What does that mean?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

We're only dealing with confidential reports, and -- and, as you probably recall, the reason they have any confidentiality at all is to maintain the relationship between the regulators and the Commissioner and -- and avoid a chilling effect on the communications that they have between themselves.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Demuzio.

SENATOR DEMUZIO:

Well, on page six of your bill, at the bottom, it says, notwithstanding any provisions of this Act or any other law, "confidential supervisory information shall be the property of the Commissioner and shall be privileged from disclosure to any person except as provided in this Section." Who -- this -- this is -- isn't this unusual? Property of the Commissioner? Disclosure is privileged? How do you...

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

Senator Demuzio, as far as it being property, that -- that -- that provision basically defines that that information does belong to them, but for purposes of it belonging to them, it is to remain confidential. However, that information may be disclosed to other regulatory agencies that they need to deal with.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Demuzio.

SENATOR DEMUZIO:

Why is it not public information?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

Senator, I -- I explained earlier that -- and I -- and I think you're familiar with this concept of -- of confidentiality under these circumstances, but we want to maintain as open a dialogue as we possibly can between the regulators here in the State and the agencies that they -- that they regulate.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Demuzio.

SENATOR DEMUZIO:

Doesn't tell me why the information is not made public.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

Well, the information is purely informational and may be -frankly, could be taken out of context, but we -- again, we don't
want to chill that relationship between the regulator and the -the entity being regulated, to make sure that we have as open and
-- and clear discussion as we possibly can.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Demuzio.

SENATOR DEMUZIO:

Well, since this came from the banks, what -- what's the regulators' position with respect to this? Because I also notice that no -- no person in possession of confidential supervisory information may disclose that reason for any reason or any -- or any circumstances. What's the -- what is the -- the Commissioner of Banks position with respect to this bill?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

Senator, the Commissioner took no position.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Demuzio.

SENATOR DEMUZIO:

Well, maybe that's what we should do. We should take no position and vote Present. I mean, what Commissioner of Banks was this? The old Commissioner, the new Commissioner, or -- or which? I mean, if they're not taking any position with respect to this, I mean, and this coming from the banks itself, it seems to me that the regulatory -- the Director of the Department ought -- ought to have some position with respect to this material. I mean, this is confidential material that we are making, now, property of the

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

First of all, I take that's a question or -- you're looking for an additional response. This is confidential supervisory information. It doesn't deal with the business records. None of the business records would be confidential. I hope that clarifies it for everybody. And as far as the -- you know, the -- the Community Bankers bringing this forward as an initiative and -- and -- and the -- the current supervisor or -- the current Commissioner not having a -- a position, I can't speak to that, Senator.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Demuzio.

SENATOR DEMUZIO:

Well, I think I don't have a position either. If the Commissioner doesn't have one, I don't either. I think I'm going to be voting Present. I mean, this seems to me to be a tremendous departure from previous practice, and it just seems to me that if we can't get the regulatory department to make a — some declaration or position with respect to this bill, why should we?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Any further discussion? Senator Welch.

SENATOR WELCH:

I have a question of the sponsor.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Sponsor indicates he will yield. Senator Welch.

SENATOR WELCH:

Senator O'Malley, is there any intention or intent on your part to make this a privileged communication so that it's not

discoverable in -- in a lawsuit, for instance?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

Senator Welch, I understand that under current practice that this information would not be privileged in the event a subpoena were issued. So it is certainly not my intent to change that practice.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Welch.

SENATOR WELCH:

So not just a subpoena, but if there's a lawsuit and there's interrogatories or there's discovery or a notice to produce, the bank has to produce this study, this confidential study. That's the -- apparently the only way to get ahold of it.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

Senator Welch, the -- the -- the Commissioner would have the opportunity to make the decision, on their own, whether or not, in the case of an interrogatory, they would -- they would share that information.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Welch.

SENATOR WELCH:

But what about the bank? The bank has -- has -- has to answer the interrogatory or refer us to the Commissioner. The bank has to answer the interrogatories.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

Senator Welch, that's correct.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Welch.

SENATOR WELCH:

And they have to produce the study if there's a lawsuit, in court, if there's a notice to produce that -- all documents relating to -- to the lawsuit.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

If the court were to order them to do so, yes, sir, they would.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Welch.

SENATOR WELCH:

Well, that -- that doesn't make sense to me. If -- if the bank doesn't -- let's say the bank does not make themselves compliant with the Y2K issue and they screw up all my bank records and I lose money, and I file a lawsuit against them, you're saying to me that I have to ask -- well, your answer was that I would have to get a court order telling them to turn over those documents that reviewed their Y2K compliance to me instead of, in the normal course of a lawsuit, me asking their lawyer to have the bank turn them over. Now, is that not correct? They have to turn over the documents?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

Senator Welch, that is not what I said. What I -- what I indicated is that this -- this applies to supervisory information, not to the business records. Your business records that are related to -- to what your -- your business interactions at that bank would certainly be discoverable and, frankly, without a court

order. Be subject to the normal rules of -- of -- of the court.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Any further discussion? Senator Hawkinson.

SENATOR HAWKINSON:

Thank you, Mr. President. Will sponsor yield for a question?
PRESIDING OFFICER: (SENATOR DUDYCZ)

Sponsor indicates he will yield. Senator Hawkinson.

SENATOR HAWKINSON:

Senator, can you tell us what you mean by supervisory information?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

It's a report of examination, visitation or investigation prepared by the Commissioner or the Commissioner's office.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Hawkinson.

SENATOR HAWKINSON:

So it doesn't refer to information conveyed by the bank but, rather, to information compiled by the -- the inspector? Or could the information compiled by the inspector be a reporting of information gained from the bank officers and employees?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

I believe that that information could be, but if it's available in a different manner, it certainly wouldn't be held confidential.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Hawkinson.

SENATOR HAWKINSON:

To piggyback on Senator Welch's questions, if this bill makes

that the property of the Commissioner and the bank is deposed or has -- is asked to produce, can the bank produce it? Will the bank also have a copy of that document that they produce, or will they be able to say, "No, we can't because that is the property of the Commissioner"?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

I -- I believe, Senator, that -- that they -- they would -- they wouldn't... They would not necessarily have that information. This is information compiled by the Commissioner or their -- their staff members.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Any further discussion? Senator Demuzio, for a second time. SENATOR DEMUZIO:

...for a second time, but on page 7 it says that any request starting around line 15 - for discovery or disclosure of the confidential supervisory information, whether by subpoena, order, or other judicial or administrative process, shall be made to the Commissioner, and the Commissioner shall determine within fifteen days whether to disclose the information pursuant to procedures and standards of the Commissioner -- that the Commissioner shall establish by rule. If the Commissioner determines that such information will not be disclosed, the Commissioner's decision shall be subjected -- subject to judicial review under the provisions of the Administrative Review Law, and venue shall be in either Sangamon or Cook County. Any court order that compels confidential disclosure of supervisory information may immediately appealed by the Commissioner, and the order shall automatically stayed pending the outcome of the appeal. Wow. Isn't that something? I'm not an attorney, but, I mean, wow. mean, a court makes a decision and it's automatically -- the

decision is automatically stayed pending the outcome of the appeal of the Commissioner? Wow. Why are we doing that?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

Again, Senator, this is supervisory information that is compiled in the Commissioner's office.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Demuzio.

SENATOR DEMUZIO:

I know what information it is. Why are we doing this? Why are we putting in the statute that any court order that compels disclosure of this confidential supervisory information shall immediately be appealed by the Commissioner and the order shall be automatically stayed pending the outcome of the appeal? Is there ever going to be any closure to this?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator O'Malley.

SENATOR O'MALLEY:

This is not, Senator Demuzio, a departure from current practice. This is what's going on right now. What this is intended to do is -- is address the public policy associated with maintaining a good, open working relationship between a regulator and the regulated entity.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Demuzio.

SENATOR DEMUZIO:

It is a departure from previous practices. I mean, if you allow the -- the court to make a decision and if the court decision isn't the same as the Commissioner would -- would deem, then it's automatically appealed. Automatically. Automatically stayed pending an appeal. Never heard of such a thing. I think

you ought to take this thing out of the record till we fully understand what we're doing here.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Any further discussion? If not, Senator O'Malley, to close. SENATOR O'MALLEY:

Yes. Thank you for the questions. I do want to tell you that as we were having this discussion, the legislative liaison from the Office of Banks and Real Estate sent in a card saying, "We are neutral." I don't know if that's much different than saying that we don't have a position, but I'm sharing that information with you. I'd be -- I would request your support for this, and I can assure you that the concerns that Senator Demuzio has expressed here, which he tends to express on this type of legislation, will continue to be discussed right through to -- through the House, should it be -- should it go to the House.

PRESIDING OFFICER: (SENATOR DUDYCZ)

The question is, shall Senate Bill 447 pass. All those in favor will vote Aye. Opposed will vote Nay. And the voting is open. Have all voted who wish? Have all voted who wish? Cost is minimal. They already provide this service for other cancers.

Senator, how do you define minimum?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Sullivan.

SENATOR SULLIVAN:

Printing -- printing some pamphlets.

PRESIDING OFFICER: (SENATOR DUDYCZ)

I don't think we've voted on their budget yet.

Can you tell me what it was last year?

Senator Sullivan.

PRESIDING OFFICER: (SENATOR DUDYCZ)

So many lights here. I don't know if -- if my board is broken. Senator Burzynski.

SENATOR BURZYNSKI:

Just one more question. I notice Senator Sullivan sits by Senator Parker, over on the Floor, and I just wondered if he would like to pass sponsorship of this bill to Senator Parker because normally she carries women's health issues.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Any further discussion? Senator Silverstein.

SENATOR SILVERSTEIN:

Thank you, Mr. President. I couldn't sleep last night, so I started going through the bills that were going to be called, and, you know, I think you're getting off pretty easy today, than I had. I want to commend the sponsor for this piece of legislation,

Is this some more useless legislation or -- I mean, you don't seem like it -- it really does anything. You say print up a few pamphlets. You could do that on your Xerox machine, couldn't you?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Sullivan.

SENATOR SULLIVAN:

No, there's an eight hundred number, there's a lot of promotional activity that the Department will do with this, as they do with other cancers.

Well, Mr. President, Ladies and Gentlemen of the Senate, my colleague on the other side questions Senator Silverstein's support. Well, that's because he knows better than you do, Senator. And -- and he's doing the right thing. And, furthermore, talking about passionate, can you see this good-looking gentleman, full of good health, not being passionate? Of course, he's passionate about the bill, and I urge support.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Will the sponsor yield?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Sponsor indicates he will yield. Senator Cullerton.

Senator, this particular bill deals with a particular cancer.

I think it's ovarian cancer, is that correct?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Sullivan.

SENATOR SULLIVAN:

That is correct.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Cullerton.

SENATOR CULLERTON:

So ovarian cancer would be, obviously, dealing with women's health issues. I understand that the Department also has in place a breast and cervical research fund. But you indicated that the

Department deals with other cancers as well, and I've -- I've got the statute that you're trying to amend here and I don't see anything in here about cancer that affects men. I'm wondering if you wouldn't mind -- would you have any objection to an amendment that would add prostate cancer to this particular bill? Would you have any objection to that, sir?

Senator Cullerton, yesterday in State Government Committee, your colleague, our colleague, Senator Trotter, got a bill passed out dealing with prostate cancer.

Senator Cullerton.

SENATOR CULLERTON:

But, I think it would be safer for all of us here to know that your bill, before we pass it, also contains that — that material, because, you know, Senator Trotter's bill hasn't passed yet. And — and it may be that Senator Trotter, he has a bad arm, he may not be here, he may forget to call it. If you have it included right in your bill, then we wouldn't have to worry about it. So all I'm asking is just take it out of the record, we do an amendment, and then you can pass it next — next — next Monday or Tuesday. Would that be okay?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Any further discussion? Senator Syverson.

SENATOR SYVERSON:

Thank you, Mr. President. Just one quick question.

There were some sections that were ambiguous or had some unnecessary or burdensome requirements in them. The recommendation of a task force that was put together was that we do some clean-up language on this -- this Act. There is no opposition to this bill, and I would ask for a favorable roll call.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Is there any discussion? If not, the question is, shall Senate Bill 565 pass. All those in favor will vote Aye. Opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 58 Ayes, no Nays, none voting Present. And Senate Bill 565, having received the required constitutional majority, is declared passed. Senate Bill 570. Senator Hawkinson. Madam Secretary, read the bill.

ACTING SECRETARY HAWKER:

Senate Bill 570.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Hawkinson.

SENATOR HAWKINSON:

Thank you, Mr. President. This bill is an initiative of the Mothers Against Drunk Driving. One of the problems that we have in — in dealing with drunk driving cases is the lack of resources, particularly at the local level and the county prosecutor level. In — in many of our smaller counties, particularly if you have only one state's attorney or a state's attorney and one assistant, sometimes the more serious cases take precedent and there just aren't the resources available to

prosecute drunk driving and other alcohol-related traffic cases. This initiative would apply State funds to -- to pay for assistant state's attorneys in the counties that wish to avail themselves of it. The smaller counties would get one; some of those over a hundred thousand would get two, and so forth. It is permissive. The counties can choose to do it. If all the counties avail themselves of this program, it would have six-million-dollar annual budget impact. I know of no opposition, but it does have a significant budget impact, and I would ask for your support. Be happy to try and answer any questions.

Is there any discussion? If not, the question is, shall Senate Bill 570 pass. All those in favor will vote Aye. Opposed will vote Nay. The voting is open. Have all voted who wish? And Senate Bill 570, having received the required constitutional majority, is declared passed. Senate Bill 572. Senator Thomas Walsh. Madam Secretary, read the bill.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Thomas Walsh.

SENATOR T. WALSH:

Thank you, Mr. President. Senate Bill 572 amends the Criminal Code by creating the offense of aiming a laser pointer at a peace officer, which is a Class A misdemeanor. It amends the Code of Corrections to include committing an offense using a fire arm with a laser sight attached as the basis for imposing an extended term sentence. Be happy to answer any questions.

SENATOR MUNOZ:

Thank you, Mr. President and Members of the Senate. Senate Bill 643 amends the Code of Corrections relating to restitution. Complete restitution shall be paid in as short time as possible. A defendant has five years to make complete restitution, but the court shall ensure that it's been paid in a short time -- period as possible based on the defendant's ability to pay. This bill eliminates what would be a difficult and expensive job for a prosecutor to investigate the financial circumstances of a defendant who has been sentenced to or has agreed to restitution but now cannot pay. Then the defendant has the opportunity to rebut the presumption that has facts established at trial or plea agreement have materially changed. For example, the defendant testifies to a loss of a job. At this time, I open for any questions, Mr. President.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Is there any discussion? Senator Burzynski.

The cards are subject to tax currently in Illinois and this bill changes the place of taxation from the usage of the card to the point of sale and reduces the telecommunications tax on this type of card from seven percent to a sales tax of six and a quarter cents. All the states surrounding Illinois have the point of — of sale for these phone cards: Missouri, Iowa, Wisconsin, Michigan, Indiana, Ohio, Minnesota. The bill simplifies the tax collection by charging the tax up front when the card is purchased, instead of on each individual call, which then has to be calculated from each particular municipality, or if it's out of state, we don't get any tax at all. I ask for your support of Senate Bill 659.

SENATOR LUECHTEFELD:

Senate Bill 725 amends the Civil Administrative Code of Illinois and the Agricultural {sic} (Aquaculture) Development Act to provide that the Department of Agriculture shall make grants to the Agriculture {sic} (Aquaculture) Cooperative, which is under the rules of the Agriculture Co-Operative Act. SENATOR HAWKINSON:

Thank you, Mr. President. This bill changes the word "the" to the word "a". It's in the Juvenile Court Act. It deals with abused and neglected kids and it comes to us out of Peoria County. It is a significant piece of legislation, however. There was opposition in committee. But what the bill does is this: In abuse and neglect cases, right now under current law, if the victim of abuse or neglect by a parent or stepparent has given a prior statement, that statement may be introduced. It may not form the sole basis for the finding of abuse or neglect. In many cases, there are siblings in the family who have been abused or Under current law, their prior statements are not so neglected. admissible. This would allow the other siblings or minors in the family who have been abused by the same offender to be admitted under the same circumstances.

That — that law, which was — which was part of Public Act 88-680, was declared unconstitutional for — for violating the single subject rule. Be happy to answer any questions.

And Senate Bill 731, having received the required constitutional majority, is declared passed. Top of page 13 of your regular Calendar, in the Order of Senate Bills 3rd Reading, is Senate Bill 740. Senator Burzynski. Madam Secretary, read the bill.

ACTING SECRETARY HAWKER:

Senate Bill 740.

SENATOR BURZYNSKI:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. Just a few minutes ago, we heard Senator Hawkinson present Senate Bill 570, talking about the lack of resources for prosecution of DUIs and that that bill would help. I think this bill will assist him even greater in that process. Senate Bill 740 calls for an additional fine of one hundred dollars for the conviction of a DUI to go to the local arresting jurisdiction for the purchase of technology and equipment to assist in the apprehension and conviction of DUI offenders. What we've seen over the last few years is that people that have this type of technology are able to move the -- move the process along quickly and we have less cases appearing in court. People are pleading guilty. I'd be more than happy to answer any questions.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Any discussion? Senator Cullerton.

SENATOR CULLERTON:

Yes. Will the sponsor yield?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Sponsor indicates he will yield. Senator Cullerton.

SENATOR CULLERTON:

This is for people who are found guilty of driving under the influence. Would it cover people who are given supervision for the offense in their first offense?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Burzynski.

SENATOR BURZYNSKI:

The answer to that is, I don't know, Senator. I'm not sure at

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Cullerton.

SENATOR CULLERTON:

Well, do you know how the dollar amount of one hundred dollars was chosen and how much money is expected to be raised statewide?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Burzynski.

SENATOR BURZYNSKI:

Yes. Let me address the -- the dollar amount. Senator, what we looked at was the number of DUI arrests that have been made over -- and convictions, I should say, that have been made over the last year. And in 1997 alone, there was forty-seven thousand DUI convictions by Illinois State Police. In Winnebago County, my county, it's thirteen hundred and eighty-nine. Ogle County, two hundred and sixty-two. Boone County, two hundred and ninety-two. What we tried to do, in looking at this -- this bill came to me from one of my constituents who lost not only a daughter, but her grandmother, in a head-on collision with a -- with a drunk. And so what they were trying to do is find a way to provide for a cost for local officials to -- to purchase equipment. hundred-dollar fine is just a number that we thought was adequate, that would help provide for a considerable amount of dollars back to local jurisdictions.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Cullerton.

SENATOR CULLERTON:

Well, thank you, Mr. President, and thank you for that answer. Obviously I'm going to support the bill, but I would make a couple recommendations for possibly your House sponsor. First of all, you got to clarify whether it covers people who are typically first offenders and they get supervision. They lose their

driver's license because they didn't take the Breathalyzer or they blew over .08, but they usually don't get an actual conviction. And that question then would be as to how much money is raised. You've indicated forty-five thousand convictions. That would be four and a half million dollars. It may be that a particular jurisdiction may need a little more flexibility in — in the use of this money. It may be that some county just bought all the Breathalyzer machines and laser guns that they — that they needed and now they're going to get this influx of new money and the bill may be drafted such that they're limited as to where they can get it. So I would make those two recommendations, not having been on the committee that this came through, but I would make those recommendations for the proverbial "I'll amend it in the House."

PRESIDING OFFICER: (SENATOR DUDYCZ)

Further discussion? Senator Shadid.

SENATOR SHADID:

Yes. Would the sponsor yield?

PRESIDING OFFICER: (SENATOR DUDYCZ)

Sponsor indicates he will yield. Senator Shadid.

SENATOR SHADID:

Senator Burzynski, in the committee, I believe I asked you if this money was going to be used for personnel.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Burzynski.

SENATOR BURZYNSKI:

No. The funds are not to be used for personnel. This is narrowly defined for the technology and for the training of people to utilize the technology to aid in the apprehension and conviction.

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Shadid.

SENATOR SHADID:

I -- I don't -- I think that you were going to put an amendment on or to clarify that or...

PRESIDING OFFICER: (SENATOR DUDYCZ)

Senator Burzynski.

SENATOR BURZYNSKI:

I think that the bill pretty well speaks for itself, Senator. Any time that you have that type of equipment, you're going to better be capable of — of apprehending or convicting a person who's DUI. Let me give you a little bit of — of an example of that. When we started talking about that in committee, what we wanted to do was initiate something that provided technology. The couple that brought this bill to me, who had lost members of their family, have provided over three hundred and fifty—one thousand of their own dollars into project programs in four counties in Illinois, as well as in Wisconsin and for the State Police. So, they have assisted by providing technology and really thought this was a way to — to draft the bill so that it does go strictly to technology and not personnel.

Senator Shadid.

SENATOR SHADID:

Yes, Senator Burzynski, I support what you're trying to do. I just wanted to make it very clear that this money would not be used to hire additional personnel or use it for clerks and stuff like that. Thank you.

SENATOR PETKA:

Will the sponsor yield?

The Fence Law goes on to suggest — it does not suggest, it says that — that it's mandatory that that hedge fence be kept trimmed to a height of four feet and a width of two feet. This will allow, then, some jurisdiction over some of the fences that have — fence lines that have gotten out of control. I would appreciate the support of the Body.
