#### HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 24

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 2 of Article IV of the Illinois Constitution as follows:

### ARTICLE IV

### THE LEGISLATURE

#### SECTION 2. LEGISLATIVE COMPOSITION

(a) One Senator shall be elected from each Legislative District. Immediately following each decennial redistricting, the General Assembly by law shall divide the Legislative Districts as equally as possible into three groups. Senators from one group shall be elected for terms of four years, four years and two years; Senators from the second group, for terms of four years, two years and four years; and Senators from the third group, for terms of two years, four years and four years. The Legislative Districts in each group shall be distributed substantially equally over the State.

(b) Each Legislative District shall be divided into two Representative Districts. In 1982 and every two years thereafter one Representative shall be elected from each Representative District for a term of two years.

(c) To be eligible to serve as a member of the General Assembly, a person must be a United States citizen, at least 21 years old, and for the two years preceding his election or appointment a resident of the district which he is to represent. In the general election following a redistricting, a candidate for the General Assembly may be elected from any district which contains a part of the district in which he resided at the time of the redistricting and reelected if a resident of the new district he represents for 18 months prior to reelection.

(d) Within thirty days after a vacancy occurs, it shall be filled by appointment as provided by law. If the vacancy is in a Senatorial office with more than twenty-eight months remaining in the term, the appointed Senator shall serve until the next general election, at which time a Senator shall be elected to serve for the remainder of the term. If the vacancy is in a Representative office or in any other Senatorial office, the appointment shall be for the remainder of the term. An appointee to fill a vacancy shall be a member of the same political party as the person he succeeds.

(e) No member of the General Assembly shall receive compensation as a public officer or employee from any other governmental entity for time during which he is in attendance as a member of the General Assembly.

No member of the General Assembly during the term for which he was elected or appointed shall be appointed to a public office which shall have been created or the compensation for which shall have been increased by the General Assembly during that term.

(f) No person may serve more than eight years in the General Assembly. No person may be elected or appointed as Senator or Representative if, upon completion of the term of office, that person will have been a member of the General Assembly for more than eight years. Time served in the General Assembly before the session beginning in January 2017 shall not count toward the eight-year service limitation.

#### HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 25

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-NINTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be

submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Sections 7, 11, and 12 of Article VI of the Illinois Constitution as follows:

### ARTICLE VI THE JUDICIARY

#### SECTION 7. JUDICIAL CIRCUITS

(a) The State shall be divided into Judicial Circuits consisting of one or more counties. The First Judicial District shall constitute a Judicial Circuit. The Judicial Circuits within the other Judicial Districts shall be as provided by law. Circuits composed of more than one county shall be compact and of contiguous counties. The General Assembly by law may provide for the division of a circuit for the purpose of selection of Circuit Judges from the circuit at large.

(b) Each Judicial Circuit shall have one Circuit Court with such number of Circuit Judges as provided by law. Unless otherwise provided by law, there shall be at least one Circuit Judge from each county. In the First Judicial District, unless otherwise provided by law, Cook County, Chicago, and the area outside Chicago shall be separate units for the selection of Circuit Judges, with at least twelve chosen at large from the area outside Chicago and at least thirty six chosen at large from Chicago.

(c) Circuit Judges in each circuit shall select by secret ballot a Chief Judge from their number to serve at their pleasure. Subject to the authority of the Supreme Court, the Chief Judge shall have general administrative authority over his <u>or her</u> court, including authority to provide for divisions, general or specialized, and for appropriate times and places of holding court.

#### SECTION 11. ELIGIBILITY FOR OFFICE

No person shall be eligible to be a Judge or Associate Judge unless he <u>or she</u> is a United States citizen, a licensed attorney-at-law of this State, and a resident of the unit <u>from which he or she is selected</u> which selects <u>him</u>. No change in the boundaries of a unit shall affect the tenure in office of a Judge or Associate Judge incumbent at the time of such change.

#### SECTION 12. <u>SELECTION</u> ELECTION AND RETENTION

(a) Supreme, Appellate and Circuit Judges shall be nominated <u>as provided in this Section</u>. at primary elections or by petition. Judges shall be elected at general or judicial elections as the General Assembly shall provide by law. A person eligible for the office of Judge may cause his name to appear on the ballot as a candidate for Judge at the primary and at the general or judicial elections by submitting petitions. The General Assembly shall prescribe by law the requirements for petitions.

(b) The office of a Judge shall be vacant upon his <u>or her</u> death, resignation, retirement, removal, or upon the conclusion of his <u>or her</u> term without retention in office. Whenever an additional Appellate or Circuit Judge is authorized by law, the office shall be filled in the manner provided for filling a vacancy in that office.

(c) Nonpartisan judicial commissions whose duty it shall be to nominate and submit to the Governor names of persons for appointment as provided in subsection (c-5) are hereby established and shall be organized on the following basis: (i) for vacancies in the office of Supreme Court Judge, there shall be one such commission; (ii) for vacancies in the office Appellate Court Judge, there shall be one such commission for each Judicial District; and (iii) for vacancies in the office of Circuit Judge there shall be one such commission for each Judicial Circuit. Each commission shall consist of 4 attorneys and 4 non-attorneys. The 4 attorney members for the Supreme Court judicial commission shall be selected by the attorneys who are licensed to practice law in this State. The 4 attorney members of each Appellate or Circuit Court judicial commission shall be selected by the attorneys who are licensed to practice law in this State and who reside within the appropriate District or Circuit. The 4 non-attorney members of each judicial commission shall be appointed as follows: one member appointed by the President of the Senate; one member appointed by the Minority Leader of the Senate; one member appointed by the Speaker of the House of Representatives; and one member appointed by the Minority Leader of the House of Representatives. Vacancies shall be filled for the unexpired term by the appointing authority. A person is not eligible to serve on a commission if he or she (i) is a federal, State, or local elected official and receives compensation for services rendered as an elected official or (ii) holds any office or official position in a political party. Service in the State Militia or Armed Forces of the United States for a period of time determined by Supreme Court rule does not disqualify a person from service on a commission. Each member of a judicial commission shall be subject to ethics and economic disclosure requirements as provided by law. Members of judicial commissions shall serve for terms of 6 years. No member may be appointed or reappointed to a judicial commission for a period of 3 years after the expiration of his or her 6-year term. No member may serve on more than one judicial commission at a time. No member of a judicial commission may be appointed to judicial office while serving on a commission or for a period of 3 years after his or her term on the commission has ended. Each commission shall select a chairperson from among its members. The chairperson shall serve as chairperson for a term of 3 years or until the expiration of his or her term of office as a member, whichever occurs sooner. A commission may conduct investigations, meetings, and hearings, and may employ staff members as necessary to perform its duties. The members of any commission established under this subsection shall receive no salary or other compensation for their services, but they shall be reimbursed for necessary expenses incurred while actually engaged in the discharge of their official duties from moneys appropriated for that purpose. All such commissions shall be administered, and all elections provided for under this subsection shall be held and regulated, under such rules as the Supreme Court shall promulgate.

(c-5) Whenever a vacancy occurs in the office of Supreme, Appellate, or Circuit Judge, the Administrative Director of the Illinois Courts shall promptly notify the applicable nonpartisan judicial commission established under subsection (c) of this Section. Within 60 days after receiving that notice, the commission shall submit to the Governor a list of 3 nominees who are qualified for review by the commission. Nominations shall be submitted to the Governor only upon concurrence of not less than two-thirds of all members of the commission. The list shall be in alphabetical order. The Governor shall make the list public. Not less than 28 days nor more than 56 days after receiving the list, the Governor shall fill the vacancy by appointing one of the 3 nominees. If the Governor fails to appoint any of the nominees within 56 days after the list of nominees is submitted, the nonpartisan judicial commission making the nomination shall appoint one of the nominees to fill the vacancy. As used in this subsection, "qualified for review by the commission" means that the nominee, by his or her character, temperament, professional aptitude, experience, and commitment to equal justice under the law, is deemed by the commission to be well qualified to fit the vacancy. All such qualified persons have the right to be considered for selection by the commission free from discrimination on the basis of race, color, creed, national ancestry, or gender. A commission may not include on its list of 3 nominees any person who is on another list submitted to the Governor to fill a vacancy in the same judicial office. A vacancy occurring in the office of Supreme, Appellate or Circuit Judge shall be filled as the General Assembly may provide by law. In the absence of a law, vacancies may be filled by appointment by the Supreme Court. A person appointed to fill a vacancy 60 or more days prior to the next primary election to nominate Judges shall serve until the vacancy is filled for a term at the next general or judicial election. A person appointed to fill a vacancy less than 60 days prior to the next primary election to nominate Judges shall serve until the vacancy is filled at the second general or judicial election following such appointment.

(d) Not less than six months before the general election preceding the expiration of his <u>or her</u> term of office, a Supreme, Appellate or Circuit Judge who has been <u>appointed or</u> elected to that office may file in the office of the Secretary of State a declaration of candidacy to succeed himself <u>or herself</u>. The Secretary of State, not less than 63 days before the election, shall certify the Judge's candidacy to the proper election officials. The names of Judges seeking retention shall be submitted to the electors, separately and without party designation, on the sole question whether each Judge shall be retained in office for another term. The retention elections shall be conducted at general elections in the appropriate Judicial District, for Supreme and Appellate Judges, and in the circuit for Circuit Judges. The affirmative vote of three-fifths of the electors voting on the question shall elect the Judge to the office for a term commencing on the first Monday in December following his or her election.

(e) A law reducing the number of Appellate or Circuit Judges shall be without prejudice to the right of the Judges affected to seek retention in office. A reduction shall become effective when a vacancy occurs in the affected unit.
