Elevator Safety and Review Board – Illinois Elevator Safety Rules (41 Ill. Adm. Code 1000; 47 Ill. Reg. 6388)

REVIEW OF AGENCY RULEMAKINGS

Department on Aging – Community Care Program (89 Ill. Adm. Code 240; 47 Ill. Reg. 15309)

Ronda Armstead represented the Department of Aging.

Sen. Harris moved, seconded by Sen. DeWitte, that JCAR, with the concurrence of the Department on Aging, extend the second notice period for this rulemaking for an additional 45 days. The motion passed unanimously (12-0-0).

Department of Employment Security – Access to Records of the Department of Employment Security (2 Ill. Adm. Code 1301; 47 Ill. Reg. 18212) and Claims, Adjudication, Appeals and Hearings (56 Ill. Adm. Code 2720; 47 Ill. Reg. 18235)

Rep. Haas moved, seconded by Sen. Rezin, that JCAR, with the concurrence of the Department of Employment Security, extend the second notice period for these rulemakings for an additional 45 days. The motion passed unanimously (12-0-0).

Department of Labor – Paid Leave for All Workers Act (56 Ill. Adm. Code 200; 47 Ill. Reg. 15559)

Department of Public Health – Sheltered Care Facilities Code (77 Ill. Adm. Code 330; 47 Ill. Reg. 15139)

Rep. Tarver moved, seconded by Rep. Reick, that JCAR, with the concurrence of the Department of Public Health, extend the second notice period for this rulemaking for an additional 45 days. The motion passed unanimously (12-0-0).

Department of Commerce and Economic Opportunity – Broadband Grant Programs (14 Ill. Adm. Code 548; 47 Ill. Reg. 19237)

Matt Schmit and Craig Colbrook represented DCEO.
