294 **Section 113.253 Allowances for Increase in SSI Benefits**  
 295

- 296 a) A monthly allowance for ~~\$764.90~~~~735.90~~ is authorized for all AABD cases as a  
 297 "grant adjustment". A grant adjustment is an allowance that ensures that the
