The Flinn Report is a weekly summary of regulatory actions of State agencies published in the *Illinois Register* and action taken by the Illinois General Assembly's Joint Committee on Administrative Rules (JCAR). The Flinn Report honors founding JCAR member Representative Monroe Flinn, and is designed to inform and involve the public in changes taking place in agency administration.

# Proposed Rulemakings

## MONEY TRANSMISSION

The DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION proposed a new Part titled Uniform Money Transmission Modernization Act (38 IAC 207; 48 III Reg 12942) and proposed amendments to the Part titled Transmitters of Money Act (38 IAC 205; 48 111 Reg 12933) implementing Public Act 103-991. The PA and these rulemakings implement the Uniform Money Transmission Modernization Act (MTMA), which aligns Illinois with nationwide standards for regulation of such transactions. The new Part 207 simply states that the Part 205 rules and future amendments will apply to all licensees, authorized delegates, persons and entities subject to the MTMA. Amendments to Part 205 define an authorized delegate as any person, including an authorized seller under the Transmitters of Money Act

(TOMA), whom a licensee designates to engage in money transactions on behalf of the licensee. The term "average daily balance" is replaced with "average daily money transmission liability" and the method of calculating this liability is changed to the total of each day's outstanding money transmission obligations for an

entire calendar quarter (ending on March 31, June 30, Sept. 30 or Dec. 31) divided by the number of days in that quarter. (Currently, the average daily balance is calculated on an annual basis from the amount of outstanding obligations at the end of each month.) The definition of digital currency (which is not a permissible investment for money transmitters) is also updated. Fees currently charged for license application, license renewal, and records examinations remain in effect but a \$550 per day fee for verification examinations (to determine if a licensee has corrected violations of the Act or rules) is being removed. Licensees and authorized delegates must keep documents related to money transmissions for at least 3 years, unless data contained in these documents has been electronically transmitted and recorded. Businesses subject to TOMA or the MTMA are affected.

#### SOS PROCEEDINGS

The SECRETARY OF STATE proposed amendments to Procedures and Standards (92 IAC 1001; 48 III Reg 12946) that allow public comments at the quarterly meetings of the Motor Vehicle Review Board (MVRB). Commenters must identify themselves by name and by the agenda item they wish to address, and will be allowed up to 3 minutes to address the Board. Additional 5-minute increments of time to speak may be granted to the commenter at the Board's discretion. Comment periods will be limited to 15 minutes unless extended by Board motion, and will be immediately closed if there are no commenters.

# **Adopted Rule**

## SCHOOL BUSES

The DEPARTMENT OF TRANSPORTATION adopted a new Part titled School Bus Safety Equipment Test Pilot Program (92 IAC 448; proposed at 47 III Reg 15257) effective 8/16/24 at 48 III Reg 12955, implementing Section 12-182 of the Illinois Vehicle Code, which authorizes IDOT to develop a program allowing school districts to test pilot newly introduced school bus safety equipment by installing it in certain school buses for a minimum of 90 days and gathering data on its performance. School districts must request permission from DOT to test equipment and must specify, in their requests, the equipment to be tested; the VIN and manufacturer of the chassis and body of each bus in which the tested equipment will be installed; the bus routes where the equipment will be tested; the testing method to be used; the start date of the test; any known crash tests or safety studies related to the equipment; and certification from the manufacturer that the equipment meets or exceeds all federal safety standards. Requests will be denied if State or federal regulations prohibit use of the equipment, or if another school districts. DOT may also place limits on the number of buses to be used in the test pilot, the routes to be used, and other factors. School districts are responsible for installing and maintaining the equipment being tested and ensuring that drivers are trained to properly operate it. Data from and results of these programs will be used by DOT to formulate rules governing general use of the tested equipment. School districts are affected by this rulemaking.
