1 AMENDMENT TO HOUSE BILL 4196

2 AMENDMENT NO. _____. Amend House Bill 4196 by replacing
3 everything after the enacting clause with the following:

4 "Section 5. The Township Code is amended by adding Section
5 80-85 as follows:

6 (60 ILCS 1/80-85 new)

7 Sec. 80-85. Approval of township credit card statements.
8 If a township has been issued a credit card, then, each month,
9 the township board shall vote to verify the validity of an
10 itemized statement of all purchases made using the credit in
11 the preceding month. The itemized statement must include all
12 purchases made using the credit card in the preceding month
13 and may not be redacted in a manner inconsistent with the
14 Freedom of Information Act. The vote shall solely be for the
15 approval of the itemized statement of all purchases made using
16 the credit card and shall not include any other expense

1 approval.

2 Section 10. The Illinois Municipal Code is amended by
3 adding Section 8-1-19 as follows:

4 (65 ILCS 5/8-1-19 new)

5 Sec. 8-1-19. Approval of municipal credit card statements.

6 If a municipality has been issued a credit card, then, each
7 month, the corporate authorities of the municipality shall
8 vote to verify the validity of an itemized statement of all
9 purchases made using the credit card in the preceding month.

10 The itemized statement must include all purchases made using
11 the credit card in the preceding month and may not be redacted
12 in a manner inconsistent with the Freedom of Information Act.
13 The vote shall solely be for the approval of the itemized
14 statement of all purchases made using the credit card and
15 shall not include any other expense approval.

16 Section 15. The Park District Code is amended by adding
17 Section 4-10 as follows:

18 (70 ILCS 1205/4-10 new)

19 Sec. 4-10. Approval of park district credit card
20 statements. If a park district has been issued a credit card,
21 then, each month, the board of the park district shall vote to
22 verify the validity of an itemized statement of all purchases

1 made using the credit card in the preceding month. The
2 itemized statement must include all purchases made using the
3 credit card in the preceding month and may not be redacted in a
4 manner inconsistent with the Freedom of Information Act. The
5 vote shall solely be for the approval of the itemized
6 statement of all purchases made using the credit card and
7 shall not include any other expense approval.

8 Section 20. The School Code is amended by adding Sections
9 10-31 and 34-240 as follows:

10 (105 ILCS 5/10-31 new)

11 Sec. 10-31. Approval of school district credit card
12 statements. If the district has been issued a credit card,
13 then, each month, the board shall vote to verify the validity
14 of an itemized statement of all purchases made using the
15 credit card in the preceding month. The itemized statement
16 must include all purchases made using the credit card in the
17 preceding month and may not be redacted in a manner
18 inconsistent with the Freedom of Information Act. The vote
19 shall solely be for the approval of the itemized statement of
20 all purchases made using the credit card and shall not include
21 any other expense approval.

22 (105 ILCS 5/34-240 new)

23 Sec. 34-240. Approval of school district credit card

1 statements. If the district has been issued a credit card,
2 then, each month, the board shall vote to verify the validity
3 of an itemized statement of all purchases made using the
4 credit card in the preceding month. The itemized statement
5 must include all purchases made using the credit card in the
6 preceding month and may not be redacted in a manner
7 inconsistent with the Freedom of Information Act. The vote
8 shall solely be for the approval of the itemized statement of
9 all purchases made using the credit card and shall not include
10 any other expense approval.

11 Section 25. The Public Community College Act is amended by
12 adding Section 3-85 as follows:

13 (110 ILCS 805/3-85 new)

14 Sec. 3-85. Approval of community college credit card
15 statements. If a community college district has been issued a
16 credit card, then, each month, the board shall vote to verify
17 the validity of an itemized statement of all purchases made
18 using the credit card in the preceding month. The itemized
19 statement must include all purchases made using the credit
20 card in the preceding month and may not be redacted in a manner
21 inconsistent with the Freedom of Information Act. The vote
22 shall solely be for the approval of the itemized statement of
23 all purchases made using the credit card and shall not include
24 any other expense approval."
