### SYNOPSIS AS INTRODUCED:

735 ILCS 30/25-5-145 new

Amends the Eminent Domain Act. Provides that quick-take powers may be used by the Village of Oak Park for a period of 2 years after the effective date of the amendatory Act for the acquisition of specified properties in Cook County for the purpose of a public building and facility. Repeals the provisions added by the amendatory Act 3 years after the effective date. Effective immediately.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 5. The Eminent Domain Act is amended by adding  
5 Section 25-5-145 as follows:

7 Sec. 25-5-145. Quick-take; Village of Oak Park.

8 (a) Quick-take proceedings under Article 20 may be used by  
9 the Village of Oak Park for a period of 2 years after the  
10 effective date of this amendatory Act of the 104th General  
11 Assembly for the acquisition of the following described  
12 properties for the purpose of a public building and facility:

13 3-31 Madison Street and 509 S. Humphrey Avenue (sometimes  
14 known as 11 Madison Street)

6       THE EAST 10 ACRES OF THE WEST HALF OF THE EAST HALF OF THE  
7       NORTHWEST QUARTER AND THE NORTH HALF OF THE EAST HALF OF  
8       THE EAST HALF OF THE NORTHWEST QUARTER OF SECTION 17,  
9       TOWNSHIP 39 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL
