1 HOUSE JOINT RESOLUTION

2 WHEREAS, On November 12, 1922, Sigma Gamma Rho Sorority,
3 Inc. was founded by seven visionary educators at Butler
4 University, united in their mission to enhance the quality of
5 life for women and families through education, community
6 service, and civic engagement; and

7 WHEREAS, Sigma Gamma Rho Sorority, Inc.'s Central Region,
8 originally established in 1925 and organized by Homer Woods of
9 Chicago in 1940, further advanced the sorority's mission by
10 fostering leadership, service, and sisterhood across the
11 Midwest; and

12 WHEREAS, Across the State, Sigma Gamma Rho Sorority, Inc.
13 has remained a steadfast advocate for equity in education and
14 health care, leading impactful initiatives that address
15 systemic disparities in mental health, academic achievement,
16 and access to essential resources while uplifting youth,
17 families, and historically underserved communities; and

18 WHEREAS, Sigma Gamma Rho Sorority, Inc.'s 21 alumnae
19 chapters and 19 undergraduate chapters throughout Illinois
20 reflect the sorority's deep-rooted commitment to leadership,
21 service, and sisterhood across college campuses and local
22 communities alike; and

1 WHEREAS, Sigma Gamma Rho Sorority, Inc.'s
2 multigenerational impact is evident through its signature
3 programs, which include Project CRADLE Care, Youth Symposium,
4 Swim 1922, and Operation Big Book Bag, as well as its
5 investment in the growth and development of young girls
6 through the Rhosebuds and Rhoers clubs, instilling leadership,
7 confidence, and civic responsibility from an early age; and

8 WHEREAS, Sigma Gamma Rho Sorority, Inc. draws strength and
9 inspiration from distinguished leaders who have shaped the
10 landscape of public service and community empowerment,
11 including former State Senator Margaret Smith, Rainbow PUSH
12 Coalition cofounder Rev. Willie T. Barrow, 13th International
13 Grand Basileus of Sigma Gamma Rho Sorority, Inc. and
14 pioneering educator Dr. Annie Lawrence Brown, who also served
15 as the first African American president of the Illinois Nurses
16 Association, former State Representative Sharon Markette
17 Malone, current State Representative Debbie Meyers Martin,
18 21st Central Region Director of Sigma Gamma Rho Sorority, Inc.
19 and Executive Director of the Illinois Legislative Black
20 Caucus Foundation Tiffany D. Hightower, former State
21 Representative and current City Treasurer of Chicago Melissa
22 Conyears Ervin, and former State Representative and current
23 U.S. Congresswoman Robin Kelly; and

1 WHEREAS, Sigma Gamma Rho Sorority, Inc.'s Central Region
2 celebrates 100 years of sisterhood, service, and excellence,
3 of continued leadership, of unwavering advocacy, and of making
4 a transformative impact throughout the State and beyond; and

5 WHEREAS, On May 7, 2025, members of Sigma Gamma Rho
6 Sorority, Inc. from across Illinois will gather at the
7 Illinois State Capitol to participate in Sigma Gamma Rho,
8 Incorporated Day and to engage directly with lawmakers, lend
9 their voices to the legislative process, and continue their
10 legacy of purposeful advocacy and policy-centered service in
11 alignment with the sorority's national mission and core
12 values; therefore, be it

13 RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE
14 HUNDRED FOURTH GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE
15 SENATE CONCURRING HEREIN, that we declare May 7, 2025 as Sigma
16 Gamma Rho Sorority, Incorporated Day in the State of Illinois.
