1 HOUSE RESOLUTION

2 reported decisions of Federal courts, the Illinois Supreme
3 Court, and the Illinois Appellate Court that affect the
4 interpretation of the Illinois Constitution or statutes and
5 reports the results of its research annually to the General
6 Assembly; and

7 WHEREAS, The Legislative Reference Bureau supervises the
8 participation of the State of Illinois in the National
9 Conference of Commissioners on Uniform State Laws; and

10 WHEREAS, The Legislative Reference Bureau employs
11 attorneys and staff to fulfill its statutorily mandated
12 duties; and

13 WHEREAS, The attorneys and staff of the Legislative
14 Reference Bureau continually make personal sacrifices to serve
15 as a critical resource for every member of the General
16 Assembly; and

17 WHEREAS, The attorneys and staff of the Legislative
18 Reference Bureau reliably fulfill their duties with the utmost
19 diligence, dependability, and integrity; therefore, be it
