6       the organization's executive board and one year as chair; and

8       the thriving and dynamic community it is today, advocating for  
9       the village to take a business friendly approach to promote  
10      economic and community development and helping secure several  
11      large scale development projects in the village such as the  
12      addition of Woodman's grocery store and ongoing redevelopment  
13      of the former town center, now known as The Clove; and
