AMENDMENT TO SENATE BILL 1698

AMENDMENT NO. _____. Amend Senate Bill 1698 by replacing everything after the enacting clause with the following:

"Section 5. The Director of Corrections, on behalf of the State of Illinois, is authorized to execute and deliver to the

State of Illinois, is authorized to execute and deliver to the Forest Preserve District of Will County, Illinois, for and in consideration of \$1 paid to the Department of Corrections, a quit claim deed to the following described real property owned by the State of Illinois:

LOTS 1, 2, 3 AND 11 (EXCEPT THEREFROM THE E. J. & E.

RAILROAD) ALL IN ASSESSOR'S SUBDIVISION OF SECTION 3,

TOWNSHIP 35 NORTH, RANGE 10 EAST OF THE THIRD PRINCIPAL

MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED OCTOBER

28, 1861 IN BOOK 73, PAGE 464 1/2, IN WILL COUNTY,

ILLINOIS, EXCEPT THAT PART OF SAID LOT 1 LYING IN THE

NORTHWEST AND SOUTHWEST QUARTERS OF SAID SECTION 3 AND

OF SAID TRACT, BEING ALSO THE EAST LINE OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 3, A DISTANCE OF 320.26 FEET; THENCE SOUTH 01 DEGREES 14 MINUTES 35 SECONDS EAST ALONG THE EAST LINE OF SAID TRACT, BEING ALSO THE EAST LINE OF THE NORTHWEST QUARTER OF THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 3, A DISTANCE OF 5.59 FEET TO THE NORTHERLY RIGHT OF WAY LINE OF WOODRUFF ROAD (66 FEET WIDE AS STAKED AND OCCUPIED), BEING ALSO THE SOUTHEAST CORNER OF SAID TRACT; THENCE SOUTH 78 DEGREES 07 MINUTES 28 SECONDS WEST, ALONG SAID NORTHERLY RIGHT OF WAY LINE, BEING ALSO THE SOUTHERLY LINE OF SAID TRACT, 630.79 FEET TO AN ANGLE POINT IN SAID LINE; THENCE SOUTH 88 DEGREES 10 MINUTES 22 SECONDS WEST ALONG SAID NORTHERLY RIGHT OF WAY LINE AND SAID SOUTHERLY TRACT LINE, 41.88 FEET TO THE WEST LINE OF THE NORTHEAST QUARTER OF THE NORTHWEST QUARTER OF THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SAID SECTION 3, BEING ALSO THE SOUTHWEST CORNER OF SAID TRACT; THENCE SOUTH 01 DEGREES 11 MINUTES 50 SECONDS EAST ALONG THE SAID WEST LINE, 65.90 FEET TO THE SOUTH LINE OF AFORESAID LOT 1 IN ASSESSOR'S SUBDIVISION; THENCE SOUTH 88 DEGREES 10 MINUTES 22 SECONDS WEST ALONG SAID SOUTH LINE 330.96 FEET TO THE WEST LINE OF THE SOUTHEAST QUARTER OF SAID SECTION 3; THENCE NORTH 01 DEGREES 10 MINUTES 11 SECONDS WEST, ALONG SAID WEST LINE 181.55 FEET TO THE POINT OF BEGINNING. 2 Section 10. Conveyance. Upon the payment of the sum of \$1 3 the Department of Corrections, and subject to the conditions set forth herein, the Director of Corrections, on 4 behalf of the State of Illinois and the Department of 5 Corrections, shall convey by quit claim deed all right, title, 6 7 and interest of the State of Illinois and the Department of 8 Corrections in and to the real property described in Section 5 9 to the Forest Preserve District of Will County, Illinois. The 10 conveyance of real property authorized by Section 5 shall be made subject to existing public utilities, existing public 11 12 roads, and any and all reservations, easements, encumbrances, 13 licenses, covenants, and restrictions of record.

Section 15. Recording. The Director of Corrections shall obtain a certified copy of this Act within 60 days after its effective date. The Department of Corrections shall ensure that a certified copy of this Act and any quit claim deed executed pursuant to this Act that is provided to the Forest Preserve of Will County, Illinois, shall be recorded by the Forest Preserve of Will County, Illinois, in the Recorder's Office of the county in which the land is located.

22 Section 99. Effective date. This Act takes effect upon 23 becoming law.".
