#### SYNOPSIS AS INTRODUCED:

New Act  
30 ILCS 105/5.1030 new

Creates the Firefighter Health and Wellness Act. Provides that the Firefighter Health and Wellness Unit is created within the Department of Public Health to investigate the impact of perfluoroalkyl and polyfluoroalkyl substance (PFAS) exposure and the rising incidence of cancer among firefighters in Illinois. Provides that the Unit shall conduct a comprehensive study, including baseline PFAS sampling for Illinois firefighters and the provision of cancer screenings. Provides that funding for the Unit shall be allocated from the Firefighter Health and Wellness Fund for the purpose of long-term research focused on understanding the higher rates of cancer within the Illinois firefighter community. Provides that the Unit shall collaborate with Illinois-based universities to develop testing parameters, establish guidelines for voluntary firefighter participation and screening, and identify the root causes contributing to the increased cancer risks faced by Illinois firefighters. Creates the Firefighter Health and Wellness Fund as a separate fund in the State treasury. Provides that moneys in the Fund shall be appropriated by the General Assembly to the Firefighter Health and Wellness Unit for the purposes described in the provision. Amends the State Finance Act to make conforming changes.

1 AN ACT concerning firefighter health and wellness.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 Section 1. Short title. This Act may be cited as the  
5 Firefighter Health and Wellness Act.

6 Section 5. Firefighter Health and Wellness Unit.

7 (a) The Firefighter Health and Wellness Unit is created  
8 within the Department of Public Health to investigate the  
9 impact of perfluoroalkyl and polyfluoroalkyl substance (PFAS)  
10 exposure and the rising incidence of cancer among firefighters  
11 in Illinois. The Unit shall conduct a comprehensive study,  
12 including baseline PFAS sampling for Illinois firefighters and  
13 the provision of cancer screenings. Funding for the Unit shall  
14 be allocated from the Firefighter Health and Wellness Fund for  
15 the purpose of long-term research focused on understanding the  
16 higher rates of cancer within the Illinois firefighter  
17 community. The Unit shall collaborate with Illinois-based  
18 universities to develop testing parameters, establish  
19 guidelines for voluntary firefighter participation and  
20 screening, and identify the root causes contributing to the  
21 increased cancer risks faced by Illinois firefighters.

22 (b) The Firefighter Health and Wellness Fund is created as  
23 a special fund in the State treasury. Moneys in the Fund shall

1 be appropriated by the General Assembly to the Firefighter  
2 Health and Wellness Unit for the purposes described in  
3 subsection (a).

4 Section 90. The State Finance Act is amended by adding  
5 Section 5.1030 as follows:
