18 the interior and exterior of the various buildings and
19 facilities under the jurisdiction of the Office of the
20 Secretary of State, including sidewalks, terraces, and grounds
21 and all labor, materials, and other costs incidental to the
22 above work:

24 Section 15. The sum of \$6,000,000, or so much thereof as

1 may be necessary, is appropriated from the Capital Development
2 Fund to the Office of the Secretary of State for new
3 construction and alterations, and maintenance of the interiors
4 and exteriors of the various buildings and facilities under
5 the jurisdiction of the Office of the Secretary of State.

6 Section 20. The sum of \$5,056,509, or so much thereof as
7 may be necessary and remains unexpended at the close of
8 business on June 30, 2025, from appropriations heretofore made
9 for such purpose in Article 39, Section 15 and Section 20 of
10 Public Act 103-0589, is reappropriated from the Capital
11 Development Fund to the Office of the Secretary of State for
12 new construction and alterations, and maintenance of the
13 interiors and exteriors of the various buildings and
14 facilities under the jurisdiction of the Office of the
15 Secretary of State.

16 Section 25. The sum of \$800,000, or so much thereof as may

12 be necessary, is appropriated from the Secretary of State

15 Section 100. The sum of \$35,000, or so much thereof as may
16 be necessary, is appropriated to the Office of the Secretary
17 of State from the Master Mason Fund to provide grants to
18 Illinois Masonic Charities Fund, a not-for-profit corporation,
19 for charitable purposes.

20 Section 105. The sum of \$135,000, or so much thereof as may
21 be necessary, is appropriated to the Secretary of State from

1 the Illinois Pan Hellenic Trust Fund to provide grants for
2 charitable purposes sponsored by African-American fraternities
3 and sororities.

4 Section 110. The sum of \$28,000, or so much thereof as may
5 be necessary, is appropriated to the Secretary of State from
6 the Park District Youth Program Fund to provide grants for the
7 Illinois Association of Park Districts: After School
8 Programming.

9 Section 115. The sum of \$220,000, or so much thereof as may
10 be necessary, is appropriated to the Secretary of State from
11 the Illinois Route 66 Heritage Project Fund to provide grants
12 for the development of tourism, education, preservation and
13 promotion of Route 66.

14 Section 120. The sum of \$550,000, or so much thereof as may
15 be necessary, is appropriated from the Police Memorial
16 Committee Fund to the Office of the Secretary of State for
17 grants to the Police Memorial Committee for maintaining a
18 memorial statue, holding an annual memorial commemoration, and
19 giving scholarships or grants to children and spouses of
20 police officers killed in the line of duty.

21 Section 125. The following named sum, or so much thereof
22 as may be necessary, respectively, are appropriated to the

1 Office of the Secretary of State for such purposes in Section
2 3-646 of the Illinois Vehicle Code, for grants to the Regional
3 Organ Bank of Illinois and to Mid-America Transplant Services
4 for the purpose of promotion of organ and tissue donation
5 awareness. These amounts are in addition to any amounts
6 otherwise appropriated to the Office of the Secretary of
7 State:

8 From Organ Donor Awareness Fund.....125,000

9 Section 130. The sum of \$400,000, or so much thereof as may
10 be necessary, is appropriated to the Secretary of State from
11 the Chicago Police Memorial Foundation Fund for grants to the
12 Chicago Police Memorial Foundation for maintenance of a
13 memorial and park, holding an annual memorial commemoration,
14 giving scholarships to children of police officers killed or
15 catastrophically injured in the line of duty, providing
16 financial assistance to police officers and their families
17 when a police officer is killed or injured in the line of duty,
18 and paying the insurance premiums for police officers who are
19 terminally ill.

20 Section 135. The sum of \$145,000, or so much thereof as may
21 be necessary, is appropriated to the Secretary of State from
22 the U.S. Marine Corps Scholarship Fund to provide grants per
23 Section 3-651 of the Illinois Vehicle Code.

1 Section 140. The sum of \$1,000,000, or so much thereof as
2 may be necessary, is appropriated from the SOS Federal
3 Projects Fund to the Office of the Secretary of State for the
4 payment of any operational expenses relating to the cost
5 incident to augmenting the Illinois Commercial Motor Vehicle
6 safety program by assuring and verifying the identity of
7 drivers prior to licensure, including CDL operators; for
8 improved security for Drivers Licenses and Personal
9 Identification Cards; and any other related program deemed
10 appropriate by the Office of the Secretary of State.

11 Section 145. The sum of \$1,500,000, or so much thereof as
12 may be necessary, is appropriated to the Office of the
13 Secretary of State from the Securities Investors Education
14 Fund for any expenses used to promote public awareness of the
15 dangers of securities fraud.

16 Section 150. The sum of \$200,000, or so much thereof as may
17 be necessary, is appropriated to the Office of the Secretary
18 of State from the Secretary of State Evidence Fund for the
19 purchase of evidence, for the employment of persons to obtain
20 evidence, and for the payment for any goods or services
21 related to obtaining evidence.

22 Section 155. The sum of \$225,000, or so much thereof as may
23 be necessary, is appropriated from the Electric Vehicle Rebate

1 Fund to the Office of Secretary of State for the cost of
2 administering the Electric Vehicle Rebate Act.

3 Section 160. The sum of \$200,000,000, or so much thereof
4 as may be necessary, is appropriated from the Secretary of
5 State Special Services Fund to the Office of the Secretary of
6 State for electronic data processing, for office automation
7 and technology, and for operating program expenses related to
8 the enforcement of administering laws related to vehicles and
9 transportation.

10 Section 165. The sum of \$20,000,000, or so much thereof as
11 may be necessary, is appropriated from the Motor Vehicle
12 License Plate Fund to the Office of the Secretary of State for
13 the cost incident to providing new or replacement plates for
14 motor vehicles.

15 Section 170. The sum of \$4,600,000, or so much thereof as
16 may be necessary, is appropriated from the Secretary of State
17 DUI Administration Fund to the Office of Secretary of State
18 for operation of the Department of Administrative Hearings of
19 the Office of Secretary of State and for no other purpose.

20 Section 175. The sum of \$0, or so much thereof as may be
21 necessary, is appropriated from the Secretary of State Police
22 DUI Fund to the Secretary of State for the payments of goods

1 and services that will assist in the prevention of
2 alcohol-related criminal violence throughout the State.

3 Section 180. The sum of \$1,000,000, or so much thereof as
4 may be necessary, is appropriated from the Secretary of State
5 Police Services Fund to the Secretary of State for purposes as
6 indicated by the grantor or contractor or, in the case of money
7 bequeathed or granted for no specific purpose, for any purpose
8 as deemed appropriate by the Director of the Secretary of
9 State Department of Police in administering the
10 responsibilities of the Secretary of State Department of
11 Police.

12 Section 185. The sum of \$300,000, or so much thereof as may
13 be necessary, is appropriated from the Office of the Secretary
14 of State Grant Fund to the Office of the Secretary of State to
15 be expended in accordance with the terms and conditions upon
16 which such funds were received.

17 Section 190. The sum of \$24,300, or so much thereof as may
18 be necessary, is appropriated to the Office of the Secretary
19 of State from the State Library Fund to increase the
20 collection of books, records, and holdings; to hold public
21 forums; to purchase equipment and resource materials for the
22 State Library; and for the upkeep, repair, and maintenance of
23 the State Library building and grounds.

1 Section 195. The following sum, or so much thereof as may
2 be necessary, is appropriated to the Office of the Secretary
3 of State for any operations, alterations, rehabilitations, new
4 construction, and maintenance of the interior and exterior of
5 the various buildings and facilities under the jurisdiction of
6 the Secretary of State to enhance security measures in the
7 Capitol Complex:

8 From General Revenue Fund.....7,500,000

9 Section 200. The sum of \$50,000,000, or so much thereof as
10 may be necessary, is appropriated from the Secretary of State
11 Identification Security and Theft Prevention Fund to the
12 Office of Secretary of State for all costs related to
13 implementing identification security and theft prevention
14 measures.

15 Section 205. The sum of \$2,500,000, or so much thereof as
16 may be necessary, is appropriated to the Office of the
17 Secretary of State from the Driver Services Administration
18 Fund for the payment of costs related to the issuance of
19 temporary visitor's driver's licenses, and other operational
20 costs, including personnel, facilities, computer programming,
21 and data transmission.

22 Section 210. The sum of \$2,100,000, or so much thereof as

1 may be necessary, is appropriated from the Monitoring Device
2 Driving Permit Administration Fee Fund to the Office of the
3 Secretary of State for all Secretary of State costs associated
4 with administering Monitoring Device Driving Permits per
5 Public Act 95-0400.

6 Section 215. The sum of \$300,000, or so much thereof as may
7 be necessary, is appropriated from the Indigent BAIID Fund to
8 the Office of the Secretary of State to reimburse ignition
9 interlock device providers per Public Act 95-0400, including
10 reimbursements submitted in prior years.

11 Section 220. The sum of \$35,000,000, or so much thereof as
12 may be necessary, is appropriated to the Office of the
13 Secretary of State from the Vehicle Hijacking and Motor
14 Vehicle Theft Prevention and Insurance Verification Trust Fund
15 for awards, grants, and operational support to implement the
16 Illinois Vehicle Hijacking and Motor Vehicle Theft Prevention
17 and Insurance Verification Act, and for operational expenses
18 of the Office to implement the Act.

19 Section 225. The sum of \$50,000, or so much thereof as may
20 be necessary, is appropriated to the Secretary of State from
21 the Illinois Professional Golfers Association Junior Golf Fund
22 for grants to the Illinois Professional Golfers Association
23 Foundation to help Association members expose Illinois

1 youngsters to the game of golf.

2 Section 230. The sum of \$170,000, or so much thereof as may
3 be necessary, is appropriated to the Secretary of State from
4 the Agriculture in the Classroom Fund for grants to support
5 Agriculture in the Classroom programming for public and
6 private schools within Illinois.

7 Section 235. The sum of \$25,000, or so much thereof as may
8 be necessary, is appropriated to the Secretary of State from
9 the Boy Scout and Girl Scout Fund for grants to the Illinois
10 divisions of the Boy Scouts of America and the Girl Scouts of
11 the U.S.A.

12 Section 240. The sum of \$45,000, or so much thereof as may
13 be necessary, is appropriated to the Secretary of State from
14 the Support Our Troops Fund for grants to Illinois Support Our
15 Troops, Inc. for charitable assistance to the troops and their
16 families in accordance with its Articles of Incorporation.

17 Section 245. The sum of \$4,000, or so much thereof as may
18 be necessary, is appropriated to the Office of the Secretary
19 of State from the Rotary Club Fund for grants for charitable
20 purposes sponsored by the Rotary Club.

21 Section 250. The sum of \$13,000, or so much thereof as may

1 be necessary, is appropriated to the Office of the Secretary
2 of State from the Ovarian Cancer Awareness Fund for grants to
3 the National Ovarian Cancer Coalition, Inc. for ovarian cancer
4 research, education, screening, and treatment.

5 Section 255. The sum of \$6,000, or so much thereof as may
6 be necessary, is appropriated to the Office of the Secretary
7 of State from the Sheet Metal Workers International
8 Association of Illinois Fund for grants for charitable
9 purposes sponsored by Illinois chapters of the Sheet Metal
10 Workers International Association.

11 Section 260. The sum of \$120,000, or so much thereof as may
12 be necessary, is appropriated to the Office of the Secretary
13 of State from the Illinois Police Association Fund for
14 providing death benefits for the families of police officers
15 killed in the line of duty, and for providing scholarships,
16 for graduate study, undergraduate study, or both, to children
17 and spouses of police officers killed in the line of duty.

18 Section 265. The sum of \$10,000, or so much thereof as may
19 be necessary, is appropriated to the Secretary of State from
20 the International Brotherhood of Teamsters Fund for grants to
21 the Teamsters Joint Council 25 Charitable Trust for religious,
22 charitable, scientific, literary, and educational purposes.

1 Section 270. The sum of \$16,000, or so much thereof as may
2 be necessary, is appropriated to the Office of the Secretary
3 of State from the Fraternal Order of Police Fund for grants to
4 the Illinois Fraternal Order of Police to increase the
5 efficiency and professionalism of law enforcement officers in
6 Illinois, to educate the public about law enforcement issues,
7 to more firmly establish the public confidence in law
8 enforcement, to create partnerships with the public, and to
9 honor the service of law enforcement officers.

10 Section 275. The sum of \$35,000, or so much thereof as may
11 be necessary, is appropriated to the Secretary of State from
12 the Share the Road Fund for grants to the League of Illinois
13 Bicyclists, a not for profit corporation, for educational
14 programs instructing bicyclists and motorists how to legally
15 and more safely share the roadways.

16 Section 280. The sum of \$0, or so much thereof as may be
17 necessary, is appropriated to the Office of the Secretary of
18 State from the St. Jude Children's Research Fund for grants to
19 St. Jude Children's Research Hospital for pediatric treatment
20 and research.

21 Section 285. The sum of \$25,000, or so much thereof as may
22 be necessary, is appropriated to the Office of the Secretary
23 of State from the Ducks Unlimited Fund for grants to Ducks

1 Unlimited, Inc. to fund wetland protection, enhancement, and
2 restoration projects in the State of Illinois, to fund
3 education and outreach for media, volunteers, members, and the
4 general public regarding waterfowl and wetlands conservation
5 in the State of Illinois, and to cover reasonable cost for
6 Ducks Unlimited plate advertising and administration of the
7 wetland conservation projects and education program.

8 Section 290. The sum of \$200,000, or so much thereof as may
9 be necessary, is appropriated to the Secretary of State from
10 the Family Responsibility Fund for all costs associated with
11 enforcement of the Family Financial Responsibility Law.

12 Section 295. The sum of \$450,000, or so much thereof as may
13 be necessary, is appropriated to the Office of the Secretary
14 of State from the Illinois State Police Memorial Park Fund for
15 grants to the Illinois State Police Heritage Foundation, Inc.
16 for building and maintaining a memorial and park, holding an
17 annual memorial commemoration, giving scholarships to children
18 of State police officers killed or catastrophically injured in
19 the line of duty, and providing financial assistance to police
20 officers and their families when a police officer is killed or
21 injured in the line of duty.

22 Section 300. The sum of \$6,000, or so much thereof as may
23 be necessary, is appropriated to the Office of the Secretary

1 of State from the Illinois Sheriffs' Association Scholarship
2 and Training Fund for grants to the Illinois Sheriffs'
3 Association for scholarships obtained in a competitive process
4 to attend the Illinois Teen Institute or an accredited college
5 or university, for programs designed to benefit the elderly
6 and teens, and for law enforcement training.

7 Section 305. The sum of \$1,300,000, or so much thereof as
8 may be necessary, is appropriated to the Office of the
9 Secretary of State from the Alzheimer's Awareness Fund for
10 grants to the Alzheimer's Disease and Related Disorders
11 Association, Greater Illinois Chapter, for Alzheimer's care,
12 support, education, and awareness programs.

13 Section 310. The sum of \$40,000, or so much thereof as may
14 be necessary, is appropriated to the Office of the Secretary
15 of State from the Illinois Nurses Foundation Fund for grants
16 to the Illinois Nurses Foundation, to promote the health of
17 the public by advancing the nursing profession in this State.

18 Section 315. The sum of \$3,000, or so much thereof as may
19 be necessary, is appropriated to the Office of the Secretary
20 of State from the Hospice Fund for grants to a statewide
21 organization whose primary membership consists of hospice
22 programs.

1 Section 320. The sum of \$45,000, or so much thereof as may
2 be necessary, is appropriated to the Office of the Secretary
3 of State from the Octave Chanute Aerospace Heritage Fund for
4 grants to the Rantoul Historical Society and Museum, or any
5 other charitable foundation responsible for the former
6 exhibits and collections of the Chanute Air Museum, for
7 operational and program expenses of the Chanute Air Museum and
8 any other structure housing exhibits and collections of the
9 Chanute Air Museum.

10 Section 325. The sum of \$0, or so much thereof as may be
11 necessary, is appropriated from the Secretary of State Special
12 Services Fund to the Office of the Secretary of State for
13 operating program expenses related to the enforcement of
14 administering laws related to vehicles and transportation.

15 Section 330. The sum of \$0 or so much thereof as may be
16 necessary, is appropriated from the General Revenue Fund to
17 the Office of the Secretary of State for all Secretary of State
18 costs associated with the implementation of the provisions of
19 Article XIV of the Illinois Constitution, including, without
20 limitation, the duties under the Constitutional Convention Act
21 and the Illinois Constitutional Amendment Act.

22 Section 335. The amount of \$155,000, or so much of this
23 amount as may be necessary, is appropriated from the General

1 Revenue Fund to the Office of the Secretary of State for
2 ordinary and contingent expenses of the Executive Inspector
3 General.

4 Section 340. The sum of \$0 or so much thereof as may be
5 necessary, is appropriated from the Guide Dogs of America Fund
6 to the Office of the Secretary of State for such purposes in
7 Section 3-699.14 of the Illinois Vehicle Code (625 ILCS 5).

8 Section 345. The sum of \$0, or so much thereof as may be
9 necessary, is appropriated from the Illinois EMS Memorial
10 Scholarship and Training Fund to the Office of the Secretary
11 of State for such purposes in Section 3-684 of the Illinois
12 Vehicle Code (625 ILCS 5).

13 Section 350. The amount of \$25,000,000, or so much thereof
14 as may be necessary, is appropriated to the Office of the
15 Secretary of State from the General Revenue Fund for deposit
16 into the Secretary of State Special Services Fund for
17 technology modernization and maintenance of information
18 technology systems and infrastructure and other costs.

19 Section 355. The amount of \$400,000, or so much thereof as
20 may be necessary, is appropriated from the Electronic
21 Notarization Fund to the Office of the Secretary of State to
22 fund the Department of Index's implementation and maintenance

1 of the electronic notarization commissions.

2 Section 360. The amount of \$100,000, or so much thereof as
3 may be necessary, is appropriated from the 100 Club of
4 Illinois Fund to the Office of the Secretary of State for
5 grants and administrative expenses associated with providing
6 resources to families of first responders killed in the line
7 of duty and to active duty first responders.

8 Section 99. Effective date. This Act takes effect July 1,
9 2025.
