SYNOPSIS AS INTRODUCED:

New Act 30 ILCS 105/5.1038 new 505 ILCS 90/22 505 ILCS 90/22.01

Creates the Emerald City Task Force Act. Establishes the Emerald City Task Force in the Department of Natural Resources. Provides that the Task Force may consult with the Environmental Protection Agency. Lists the responsibilities of the Task Force. Requires the Task Force to submit an annual report to the Governor and the General Assembly. Lists the membership of the Task Force. Provides that fines collected under certain provisions of the Insect Pest and Plant Disease Act shall be paid into the Emerald City Fund, a special fund that is created in the State treasury, and, subject to appropriation, may be expended by and for the Emerald City Task Force in the fulfillment of its purposes, the carrying out of its responsibilities, and any other requirements as determined by the Task Force. Allows the Fund to accept donations from individuals, corporations, or other entities, including by means of corporate sponsorship related to the Emerald City Task Force. Provides that Task Force members shall serve without compensation but shall be reimbursed for their reasonable and necessary expenses from funds appropriated for that purpose. Grants the Department of Natural Resources rulemaking authority. Declares the purpose of the Act and purposes of the Task Force. Defines terms. Makes conforming changes to the State Finance Act and the Insect Pest and Plant Disease Act.

1 AN ACT concerning State government.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 1. Short title. This Act may be cited as the Emerald City Task Force Act.
- 6 Section 5. Purpose. The purposes of this Act are (1) to 7 improve Illinois' ability to mitigate the damage that emerald 8 ash borers are causing throughout the State by increasing 9 public awareness of the topic; (2) to expand local government access to grants and low-cost loans for the replacement of ash 10 trees with trees that are better suited to life in cities and 11 villages; (3) to address issues caused by the rules adopted to 12 alleviate emerald ash borer infestations in the State; and (4) 13 14 to unite persons with diverse perspectives and to encourage them to collaborate with one another to tackle the obstacles 15 16 that emerald ash borers pose and will continue to pose if 17 nothing effective is done to address the issue.
- Section 10. Definitions. In this Act, unless the context requires otherwise:
- 20 "Agency" means the Environmental Protection Agency.
- "Department" means the Department of Natural Resources.
- "Fund" means the Emerald City Fund established under this

- 4 Section 15. Emerald City Task Force.
- 5 (a) The Emerald City Task Force is established in the 6 Department of Natural Resources for the purposes described in 7 Section 5 of this Act. The Task Force may consult with the 8 Environmental Protection Agency, and the Agency may consult 9 with the Task Force, at the discretion of the Task Force or the
- 11 (b) The Task Force has the following responsibilities:
 - (1) launching public awareness campaigns throughout Illinois to educate residents about the many detrimental effects of emerald ash borers and to describe actions residents can take to decrease the spread of these invasive insects:
 - (2) supporting and coordinating increased funding, grants, and low-cost loans to municipalities and units of local government to replace dead ash trees;
 - (3) organizing community engagement activities for children, such as poster, bumper-sticker, and slogan contests;
 - (4) investigating the reasons why the statewide quarantine is not as effective as hoped by, among other things, determining whether there is or was a lack of

- people willing to serve as enforcement officers, a lack of funding to isolate quarantine zones, a lack of equipment-based resources, or other causes or factors contributing to the lack of program effectiveness;
 - (5) investigating the reasons why the low-cost loans being given to local governments for tree replacement are not as effective as hoped by, among other things, determining whether or not the loans themselves are effective, whether the loans simply need to be expanded across greater areas, or whether the relevant program has other defects that deter local governments from making use of the loans; and
 - (6) researching methods to mitigate the spread of emerald ash borers in a sustainable manner.
- (c) Public awareness campaigns under this Section and support and coordination for municipalities and units of local government under this Section shall use a mixture of the of researchers, objective findings well as as emotionally-touching and heartfelt first-hand accounts and stories from people who have been hit the hardest by emerald ash borers. The Task Force shall launch public awareness campaigns through (1) partnerships with public schools, (2) social media platforms, (3) community-wide awareness events, (4) posters and QR codes for residents to learn more about emerald ash borers, and (5) explaining how residents can (i) play their part in mitigating the spread of emerald ash borers

- or (ii) directly get involved with the Emerald City Task Force
 by donating money or by becoming a volunteer.
- (d) By January 1, 2027, and by January 1 of each year thereafter, the Task Force shall submit a report to the General Assembly, as provided in Section 3.1 of the General Assembly Organization Act, and to the Governor on the actions it has taken and the progress it has made toward addressing its

- 11 (a) The Emerald City Task Force shall consist of the 12 following members:
 - (1) the Director of Natural Resources or the Director's designee, who shall serve as a co-chairperson;
 - (2) the Director of the Environmental Protection Agency or the Director's designee, who shall serve as a co-chairperson;
 - (3) one member of the Senate who is appointed by the President of the Senate and who is willing (i) to help organize educational campaigns throughout Illinois in order to inform residents about the detrimental effects of emerald ash borers from a variety of perspectives and (ii) to speak with local government officials to ascertain the reason for the lower-than-hoped use of low-cost loans;
 - (4) one member of the Senate who is appointed by the

Senate Minority Leader and who is willing (i) to help organize educational campaigns throughout Illinois in order to inform residents about the detrimental effects of emerald ash borers from a variety of perspectives and (ii) to speak with local government officials to ascertain the reason for the lower-than-hoped use of low-cost loans;

- (5) one member of the House of Representatives who is appointed by the Speaker of the House of Representatives and who is willing (i) to help organize educational campaigns throughout Illinois in order to inform residents about the detrimental effects of emerald ash borers from a variety of perspectives and (ii) to speak with local government officials to ascertain the reason for the lower-than-hoped use of low-cost loans;
- (6) one member of the House of Representatives who is appointed by the Minority Leader of the House of Representatives and who is willing (i) to help organize educational campaigns throughout Illinois in order to inform residents about the detrimental effects of emerald ash borers from a variety of perspectives and (ii) to speak with local government officials to ascertain the reason for the lower-than-hoped use of low-cost loans;
- (7) 3 residents of the State who are appointed by the Governor and who are willing to share the impact that emerald ash borers have had on them from a personal perspective, including at least one person who has worked

in the ash tree industry and at least one person whose household falls under the definition of "low-income household" or "very low-income household" under Section 3 of the Illinois Affordable Housing Act;

- (8) 3 residents of the State who are appointed by the Governor and who either reside in environmental justice communities, as defined by the Illinois Power Agency, or in municipalities without the funding to replace ash trees:
- (9) 3 residents of the State who are appointed by the Governor and who are willing to help organize educational campaigns throughout Illinois in order to inform residents about the detrimental effects of emerald ash borers from a variety of perspectives;
- (10) 3 experts or other professionals who are appointed by the Governor and who are able to investigate the reasons that the statewide quarantine regarding emerald ash borers is or was not as effective as hoped; and
- (11) 3 experts or other researchers, such as researchers from the University of Illinois' College of Agriculture, Consumer, and Environmental Sciences, who are appointed by the Governor and are able to investigate methods to decrease the spread of emerald ash borers in a sustainable manner.
- (b) The Task Force shall convene and meet at the call of a co-chairperson and shall meet as frequently as necessary to

- 2 (c) The Department of Natural Resources shall provide 3 administrative and other support to the Task Force. Upon 4 reasonable request by the Task Force, the Environmental 5 Protection Agency shall also provide administrative and other 6 support to the Task Force.
 - (d) Fines collected for violations of rules adopted under Section 35 of the Insect Pest and Plant Disease Act shall be paid into the Emerald City Fund, a special fund that is created in the State treasury, and, subject to appropriation, may be expended by and for the Emerald City Task Force in the fulfillment of its purposes, the carrying out of its responsibilities, and any other requirements as determined by the Task Force. The Fund may also accept donations from individuals, corporations, or other entities, including by means of corporate sponsorship related to the Emerald City Force. Task Force members shall Task serve without. compensation but shall be reimbursed for their reasonable and necessary expenses from funds appropriated for that purpose.
- Section 25. Rulemaking. The Department may adopt rules necessary to implement recommendations of the Task Force.

- 3 Section 75. The Insect Pest and Plant Disease Act is 4 amended by changing Sections 22 and 22.01 as follows:
- 5 (505 ILCS 90/22) (from Ch. 5, par. 82)
 - Sec. 22. Any person who shall violate any of the provisions of this Act with reference to the sale, shipment, transportation, receipt or delivery of nursery stock without inspection or certificate, or with reference to treatment of nursery stock, plants, plant products or other property; or who shall forge, counterfeit, deface, alter, destroy or wrongfully use a certificate belonging to another person or fail to obtain a certificate of inspection or nursery dealer's certificate; or who shall use a certificate after it has been suspended or revoked or has expired; or who shall transport, receive or convey any article into the State of Illinois in violation of any proclamation of the Governor or regulation of the Department or any Federal quarantine, or who, having received the same directly or indirectly shall refuse to dispose of the same as the Department may direct; or who shall violate any proclamation of the Governor or quarantine or rule, regulation or order of the Department as provided for in this Act; or who shall maintain a nuisance after receiving notice from the Department to abate the same shall be adjudged

quilty of a business offense and shall be subject to a fine of 1 2 not less than \$1,000 nor more than \$10,000. Except for fines 3 collected for violations of rules adopted under Section 35 of this Act, the The fines collected under this Act shall be paid 4 5 to the Department and by it paid into the Pesticide Control Fund, Director as Trustee, to be used for the administration 6 7 of this Act. Fines collected for violations of rules adopted under Section 35 of this Act shall be paid into the Emerald 8 9 City Fund established under Section 20 of the Emerald City 10 Task Force Act to be used according to Section 20 of the 11 Emerald City Task Force Act.

Any person who impedes, obstructs, hinders or otherwise prevents or attempts to prevent the Director in the performance of official duties shall be guilty of a Class B misdemeanor for the first violation and guilty of a Class A misdemeanor for subsequent violations. Any person using physical force against the Director in the performance of official duties shall be guilty of a Class 4 felony.

Sec. 22.01. When an administrative hearing is held, the hearing officer shall upon determination of a violation, on a per-occurrence basis, assess an appropriate administrative monetary penalty. The Department shall collect the administrative monetary penalty which will be paid as

 - B. Selling, offering or exposing for sale, or distributing nursery stock which is not accompanied by a shipping tag or label bearing a copy of the certificate of inspection or nursery dealer's certificate.
 - C. Failing to comply with any of the provisions of this Act, or the rules and regulations promulgated hereunder for which a fine for a specific violation is not specified.
 - D. Making a false declaration of acreage or causing any concealment of nursery stock from inspection by the Department.
- E. Selling, offering for sale, or distributing nursery stock or other article infested with injurious insect pests or infected with injurious plant diseases.
- 23 II. A fine of \$300 shall be imposed for each of the following violations:
- 25 A. Failing to carry out the treatment or destruction 26 of any plant pest or regulated article in accordance with

- official notification from the Director.
- B. Selling, transporting, or offering for sale nursery stock which has not been inspected and which is not covered by a valid certificate of inspection.
 - C. Selling, offering or exposing for sale or delivering any nursery stock without having a current certificate of inspection or nursery dealer's certificate.
- 8 III. A fine of \$500 shall be imposed for each of the following violations:
- 10 A. Using an invalid, suspended, or revoked nursery
 11 certificate or nursery dealer's certificate in the sale or
 12 distribution of nursery stock.
 - B. Neglecting or refusing to comply with provisions of this Act or any lawful order of the Director.
 - C. Moving any regulated article into or out of a quarantined area unless such regulated article has been treated or handled as provided by the requirements of said quarantine.
- D. Selling, installing or otherwise distributing nursery stock or other article which has been placed on stop-sale.
- IV. A fine of not less than \$500 but not greater than \$5,000 shall be imposed for each of the following violations related to a devastating insect or plant disease:
- 25 A. Thwarting or hindering an inspection by 26 misrepresenting or concealing facts or conditions related

- 1 to compliance with the terms of the quarantine.
- B. Selling, offering for sale, or distributing nursery stock or other articles infested with devastating insects or plant diseases in violation of the quarantine.
 - C. Failing to carry out the treatment or destruction of any devastating insect or plant disease or regulated article as required under the terms of the quarantine and in accordance with official notification from the Director.
 - D. Moving any regulated article into or out of the quarantined area unless the regulated article has been treated or handled as provided by the requirements of the quarantine.
- 14 E. Falsifying a compliance agreement under the quarantine.
 - Any penalty not paid within 60 days of notice from the Department shall be submitted to the Attorney General's office for collection. Failure to pay a penalty shall also be grounds for suspension or revocation of certificates and permits.
