SYNOPSIS AS INTRODUCED:

10 ILCS 5/1A-55

Amends the Election Code. In provisions concerning cybersecurity efforts, modifies the amendatory changes made by Public Act 100-587 to conform with the amendatory changes made by Public Act 100-623. Makes technical changes.

A BILL FOR

1 AN ACT concerning elections.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Election Code is amended by changing
5 Section 1A-55 as follows:

22 designed to provide equal support to all election authorities,

14 Board shall adopt rules, after at least 2 public hearings of
15 the Board and in consultation with election authorities,
16 establishing a cyber navigator program to support election
17 authorities' efforts to defend against cybersecurity ~~cyber~~
18 breaches and detect and recover from cyberattacks ~~cyber~~
19 ~~attacks~~. The rules shall include the Board's plan to allocate
20 any resources received in accordance with the federal Help
21 America Vote Act and shall provide that no less than half of
22 any funds received under the federal Help America Vote Act
23 shall be allocated to the cyber navigator program. The cyber
24 navigator program shall be designed to provide equal support
25 to all election ~~elections~~ authorities, with some modifications

1 allowable based on need. The remaining half of the federal
2 Help America Vote Act funds shall be distributed as the Board
3 sees fit, but no grants may be made to election authorities
4 that do not participate in the cyber navigator program managed
5 by the Board.

6 In distribution of the remaining funds received under the
7 federal Help America Vote Act, the Board may make such funds
8 available to election authorities for the maintenance of
9 secure collection sites for the return of vote by mail
10 ballots.
