2 AMENDMENT NO. _____. Amend Senate Bill 3107 as follows:

3 on page 1, by replacing line 5 with "Sections 25-5-145 and
4 25-5-146 as follows"; and

5 on page 2, immediately after line 13, by inserting the
6 following:

7 "(735 ILCS 30/25-5-146 new)

8 Sec. 25-5-146. Quick-take; Cook County; Calumet City.

9 (a) Quick-take proceedings under Article 20 may be used
10 for a period of no more than 2 years after the effective date
11 of this amendatory Act of the 104th General Assembly by Cook
12 County and the City of Calumet City for the acquisition of the
13 following described property for the purpose of economic
14 development:

1 PARCEL 1:

2 THAT PART OF THE NORTHWEST QUARTER OF SECTION 19, TOWNSHIP

17 COMPANY OF NORTHERN ILLINOIS BY DEEDS DULY RECORDED
18 JULY 24, 1926 AS DOCUMENTS 9349854 AND 9350297;

19 (E) THAT PART OF SAID NORTHWEST QUARTER DESCRIBED AS
20 FOLLOWS:
