Makes appropriations for the ordinary and contingent expenses of the Illinois Criminal Justice Information Authority for the fiscal year beginning July 1, 2026, as follows:

1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois,**  
3 **represented in the General Assembly:**

4 ARTICLE 1

5 Section 5. The following named amounts, or so much thereof  
6 as may be necessary, respectively, for the objects and  
7 purposes hereinafter named, are appropriated to meet the  
8 ordinary and contingent expenses of the Illinois Criminal  
9 Justice Information Authority:

1           Section 10. The amount of \$525,000, or so much thereof as  
2 may be necessary, is appropriated from the General Revenue  
3 Fund to the Illinois Criminal Justice Information Authority  
4 for the Illinois Family Violence Coordinating Council Program.

5           Section 15. The amount of \$700,000, or so much thereof as  
6 may be necessary, is appropriated from the General Revenue  
7 Fund to the Illinois Criminal Justice Information Authority  
8 for all costs associated with Bullying Prevention.

9           Section 20. The amount of \$275,500, or so much thereof as  
10 may be necessary, is appropriated from the General Revenue  
11 Fund to the Illinois Criminal Justice Information Authority  
12 for all costs associated with technical assistance and  
13 navigation of the Grant Accountability and Transparency Act.

14           Section 25. The amount of \$13,000,000, or so much thereof  
15 as may be necessary, is appropriated to the Illinois Criminal  
16 Justice Information Authority from the General Revenue Fund  
17 for administrative costs, awards and grants for Adult Redeploy  
18 and Diversion Programs.

19           Section 30. The amount of \$3,000,000, or so much thereof  
20 as may be necessary, is appropriated from the General Revenue  
21 Fund to the Illinois Criminal Justice Information Authority  
22 for the purpose of awarding grants, contracts, administrative

1 expenses and all related costs for the Safe From the Start  
2 Program.

3 Section 35. The amount of \$16,342,700, or so much thereof  
4 as may be necessary, is appropriated from the General Revenue  
5 Fund to the Illinois Criminal Justice Information Authority  
6 for administrative costs, awards and grants for  
7 Community-Based Violence Prevention Programs, including prior  
8 years' costs.

9 Section 40. The amount of \$6,694,300, or so much thereof  
10 as may be necessary, is appropriated from the General Revenue  
11 Fund to the Illinois Criminal Justice Information Authority  
12 for grants and administrative expenses related to Metropolitan  
13 Family Services' support of street intervention programming.

14 Section 45. The amount of \$1,000,000, or so much thereof  
15 as may be necessary, is appropriated from the General Revenue  
16 Fund to the Illinois Criminal Justice Information Authority  
17 for a grant to the Safer Foundation for violence prevention  
18 services and any associated administrative expenses.

19 Section 50. The amount of \$1,000,000, or so much thereof  
20 as may be necessary, is appropriated from the General Revenue  
21 Fund to the Illinois Criminal Justice Information Authority  
22 for grants to local law enforcement agencies, other first

1 responders, and co-responders for training and other allowable  
2 costs pursuant to the Community Partnership for Deflection and  
3 Addiction Treatment Act and any associated administrative  
4 expenses.

5 Section 55. The amount of \$623,700, or so much thereof as  
6 may be necessary, is appropriated from the General Revenue  
7 Fund to the Illinois Criminal Justice Information Authority  
8 for costs associated with implementation of the Public Act  
9 101-652.

10 Section 60. The amount of \$1,500,000, or so much thereof  
11 as may be necessary, is appropriated from the General Revenue  
12 Fund to the Illinois Criminal Justice Information Authority  
13 for grants and administrative expenses associated with  
14 statewide deferred prosecution funding programs.

15 Section 65. The amount of \$350,000, or so much thereof as  
16 may be necessary, is appropriated from the General Revenue  
17 Fund to the Illinois Criminal Justice Information Authority  
18 for grants and administrative expenses associated with the Ad  
19 Hoc Statewide Domestic Violence Fatality Review Committee.

20 Section 70. The amount of \$600,600, or so much thereof as  
21 may be necessary, is appropriated from the General Revenue  
22 Fund to the Illinois Criminal Justice Information Authority

1 for grants and administrative expenses associated with the  
2 Institute 2 Innovate.

3 Section 75. The amount of \$3,176,200, or so much thereof  
4 as may be necessary, is appropriated from the General Revenue  
5 Fund to the Illinois Criminal Justice Information Authority  
6 for grants and administrative expenses related to trauma  
7 recovery centers.

8 Section 80. The amount of \$5,000,000, or so much thereof  
9 as may be necessary, is appropriated from the General Revenue  
10 Fund to the Illinois Criminal Justice Information Authority  
11 for grants to local law enforcement agencies related to less  
12 lethal devices, less lethal device training, and other  
13 allowable costs associated with less lethal weapon  
14 alternatives, and any associated administrative expenses.

15 Section 85. The amount of \$5,000,000, or so much thereof  
16 as may be necessary, is appropriated from the General Revenue  
17 Fund to the Illinois Criminal Justice Information Authority  
18 for grants to local law enforcement agencies, other first  
19 responders, and co-responders for the co-responder pilot  
20 program as defined in Article 11, Division 1.5 of the Illinois  
21 Municipal Code, and any associated administrative expenses.

22 Section 90. The amount of \$15,320,550, or so much thereof

1 as may be necessary, is appropriated from the General Revenue  
2 Fund to the Illinois Criminal Justice Information Authority  
3 for administrative costs and grants to the following named  
4 entities, in the approximate named amounts below.

5 Section 95. The sum of \$6,572,000, or so much thereof as  
6 may be necessary, is appropriated from the General Revenue  
7 Fund to the Illinois Criminal Justice Information Authority  
8 for the purpose of awarding grants, contracts, administrative  
9 expenses and all related costs.

10 Section 100. The sum of \$1,000,000, or so much thereof as  
11 may be necessary, is appropriated from the General Revenue  
12 fund to the Illinois Criminal Justice Information Authority  
13 for a grant to the Center for Housing and Health to be used for  
14 investment in the Flexible Housing Pool associated with  
15 transitional and permanent supportive housing for returning  
16 residents and any associated administrative expenses.

17 Section 105. The sum of \$1,000,000, or so much thereof as  
18 may be necessary, is appropriated from the General Revenue  
19 Fund to the Illinois Criminal Justice Information Authority  
20 for cost associated with the InfoNet System.

21 Section 110. The sum of \$100,000, or so much thereof as may  
22 be necessary, is appropriated from the General Revenue Fund to

1 the Illinois Criminal Justice Information Authority for cost  
2 associated with the Community-Based Corrections Task Force.

3 Section 115. The sum of \$1,352,700, or so much thereof as  
4 may be necessary, is appropriated from the General Revenue  
5 Fund to the Illinois Criminal Justice Information Authority  
6 for costs associated with activities in support of federal  
7 assistance programs administered by state and local  
8 governments and nonprofit organizations.

9 Section 120. The sum of \$4,000,000, or so much thereof as  
10 may be necessary, is appropriated from the General Revenue  
11 Fund to the Illinois Criminal Justice Information Authority  
12 for grants, contracts, administrative expenses, and all other  
13 costs related to statewide capacity building.

14 Section 125. The sum of \$5,000,000, or so much thereof as  
15 may be necessary, is appropriated from the General Revenue  
16 Fund to the Illinois Criminal Justice Information Authority  
17 for grants and administrative expenses of the Home Illinois  
18 Program, including pilot programs, to prevent and end  
19 homelessness in Illinois, including, but not limited to,  
20 homelessness prevention, emergency and transitional housing,  
21 rapid rehousing, outreach, and related services and supports  
22 for individuals at risk or experiencing homelessness,  
23 including homeless veterans, in the approximate amounts below:

1 For Live Free Illinois.....2,000,000

2 For Treatment Alternatives for Safe Communities...3,000,000

3 Section 130. The amount of \$564,700, or so much thereof as  
4 may be necessary, is appropriated from the ICJIA Violence  
5 Prevention Fund for ordinary and contingent expenses  
6 associated with implementation of the Illinois Criminal  
7 Justice Information Act.

8 Section 135. The amount of \$79,600, or so much thereof as  
9 may be necessary, is appropriated from the ICJIA Violence  
10 Prevention Special Projects Fund to the Illinois Criminal  
11 Justice Information Authority for administrative costs, awards  
12 and grants for Adult Redeploy and Diversion Programs.

13 Section 140. The amount of \$500,000, or so much thereof as  
14 may be necessary, is appropriated from the Criminal Justice  
15 Information Projects Fund to the Illinois Criminal Justice  
16 Information Authority for distribution to fund Department of  
17 State Police drug task forces and Metropolitan Enforcement  
18 Groups.

19 Section 145. The amount of \$2,500,000, or so much thereof  
20 as may be necessary, is appropriated from the Criminal Justice  
21 Information Projects Fund to the Illinois Criminal Justice  
22 Information Authority for distribution of revenue pursuant to

1 Section 21.10 of the Illinois Lottery Law.

2 Section 150. The amount of \$180,000,000, or so much  
3 thereof as may be necessary, is appropriated from the Criminal  
4 Justice Information Projects Fund to the Illinois Criminal  
5 Justice Information Authority for administrative costs, awards  
6 and grants associated with the Restore, Reinvest, and Renew  
7 Program, including prior years' costs.

8 Section 155. The amount of \$2,190,000, or so much thereof  
9 as may be necessary, is appropriated from the Criminal Justice  
10 Information Projects Fund to the Illinois Criminal Justice  
11 Information Authority for all costs associated with research,  
12 analysis and evaluation of Restore, Reinvest, and Renew  
13 programs.

14 Section 160. The amount of \$15,000,000, or so much thereof  
15 as may be necessary, is appropriated from the Criminal Justice  
16 Information Projects Fund to the Illinois Criminal Justice  
17 Information Authority for grants and administrative expenses  
18 associated with implementation of the Illinois Criminal  
19 Justice Information Act, including prior years' costs.

20 Section 165. The following named amounts, or so much  
21 thereof as may be necessary, are appropriated to the Illinois  
22 Criminal Justice Information Authority for awards and grants

1 and other monies received from federal agencies, from other  
 2 units of government, and from private/not-for-profit  
 3 organizations for activities undertaken in support of  
 4 investigating issues in criminal justice and for undertaking  
 5 other criminal justice information projects:

11 Section 170. The following named amounts, or so much  
 12 thereof as may be necessary, are appropriated to the Illinois

 14 undertaken in support of federal assistance programs  
 15 administered by units of state and local government and  
 16 non-profit organizations:

19 Section 175. The amount of \$4,000,000, or so much thereof  
 20 as may be necessary, is appropriated from the Criminal Justice  
 21 Trust Fund to the Illinois Criminal Justice Information  
 22 Authority for its ordinary and contingent expenses.

23 Section 180. The amount of \$140,000,000, or so much

1       thereof as may be necessary, is appropriated from the Criminal  
 2       Justice Trust Fund to the Illinois Criminal Justice  
 3       Information Authority for awards and grants to local units of  
 4       government, state agencies and non-profit organizations.

5               Section 185. The following named amounts, or so much  
 6       thereof as may be necessary, respectively, for the objects and  
 7       purposes hereinafter named, are appropriated to the Illinois  
 8       Criminal Justice Information Authority for the training of law  
 9       enforcement personnel and services for families of victims of  
 10       homicide or murder:

20               Section 190. The amount of \$20,000,000, or so much thereof  
 21       as may be necessary, is appropriated from the Violent Crime  
 22       Witness Protection Program Fund to the Illinois Criminal  
 23       Justice Information Authority for grants and administrative  
 24       expenses associated with the Violent Crime Witness Protection

1 Act and the Crime Reduction Task Force Act.

2 Section 195. The amount of \$7,800, or so much thereof as  
3 may be necessary, is appropriated from the Illinois State  
4 Crime Stoppers Association Fund to the Illinois Criminal  
5 Justice Information Authority for grants to enhance and  
6 develop Crime Stoppers program in Illinois.

7 ARTICLE 2

8 Section 5. The sum of \$300,000, or so much thereof as may  
9 be necessary and remains unexpected at the close of business  
10 on June 30, 2026, from an appropriation heretofore made for  
11 such purpose in Article 122, Section 1390 of Public Act  
12 104-0003, as amended, is reappropriated from the Fund for  
13 Illinois' Future to the Illinois Criminal Justice Information  
14 Authority for a grant to Elite Community Outreach, Inc. for  
15 operational expenses.

16 Section 10. The amount of \$4,836,051, or so much thereof  
17 as may be necessary and remains unexpected at the close of  
18 business on June 30, 2026, from an appropriation heretofore  
19 made for such purpose in Article 83, Section 125 of Public Act  
20 104-0003, as amended, is reappropriated from the Fund for  
21 Illinois' Future to the Illinois Criminal Justice Information  
22 Authority for a grant to Acclivus for costs associated with

1 operating expenses.

2 ARTICLE 3

3 Section 5. The sum of \$2,780,140, or so much thereof as may  
4 be necessary and remains unexpended at the close of business  
5 on June 30, 2026, from a reappropriation heretofore made for  
6 such purposes in Article 123, Section 235 of Public Act  
7 104-0003, as amended, is reappropriated from the State  
8 Coronavirus Urgent Remediation Emergency Fund to the Illinois  
9 Criminal Justice Information Authority for grants and  
10 administrative expenses associated with implementing violence  
11 prevention programs, including but not limited to, for  
12 purposes permitted by Section 9901 of the American Rescue Plan  
13 Act of 2021 and any associated federal guidance, including  
14 prior years' costs.

15 Section 10. The amount of \$313,960, or so much thereof as  
16 may be necessary and remains unexpended at the close of  
17 business on June 30, 2026, from a reappropriation heretofore  
18 made for such purposes in Article 123, Section 240 of Public  
19 Act 104-0003, as amended, is appropriated from the State  
20 Coronavirus Urgent Remediation Emergency Fund to the Illinois  
21 Criminal Justice Information Authority for a grant and  
22 administrative costs to Waukegan School District #60,  
23 including but not limited to, for purposes permitted by

1 Section 9901 of the American Rescue Plan Act of 2021 and  
2 related federal guidance, including prior years' costs.

3 Section 15. The sum of \$800,000, or so much thereof as may  
4 be necessary and remains unexpended at the close of business  
5 on June 30, 2026, from a reappropriation heretofore made for  
6 such purpose in Article 123, Section 245 of Public Act  
7 104-0003, as amended, is reappropriated from the State  
8 Coronavirus Urgent Remediation Emergency Fund to the Illinois  
9 Criminal Justice Information Authority for a grant and  
10 administrative costs to Earhart Elementary School, including  
11 but not limited to, for purposes allowed by Section 9901 of the  
12 American Rescue Plan Act of 2021 and any associated federal  
13 guidance, including prior years' costs.

14 Section 20. The sum of \$260,300, or so much thereof as may  
15 be necessary and remains unexpended at the close of business  
16 on June 30, 2026, from a reappropriation heretofore made for  
17 such purposes in Article 123, Section 250 of Public Act  
18 104-0003, as amended, is reappropriated from the State  
19 Coronavirus Urgent Remediation Emergency Fund to the Illinois  
20 Criminal Justice Information Authority for a grant and  
21 administrative costs to Dulles Elementary School, including  
22 but not limited to, for purposes allowed by Section 9901 of the  
23 American Rescue Plan Act of 2021 and any associated federal  
24 guidance, including prior years' costs.

1           Section 25. The sum of \$216,490, or so much thereof as may  
2 be necessary and remains unexpended at the close of business  
3 on June 30, 2026, from a reappropriation heretofore made for  
4 such purposes in Article 123, Section 255 of Public Act  
5 104-0003, as amended is reappropriated from the State  
6 Coronavirus Urgent Remediation Emergency Fund to the Illinois  
7 Criminal Justice Information Authority for a grant and  
8 administrative costs to St. Bernard Hospital, including but  
9 not limited to, for purposes allowed by Section 9901 of the  
10 American Rescue Plan Act of 2021 and any associated federal  
11 guidance, including prior years' costs.

12           Section 30. The amount of \$7,391,077, or so much thereof  
13 as may be necessary and remains unexpended at the close of  
14 business on June 30, 2026, from a reappropriation heretofore  
15 made for such purposes in Article 123, Section 260 of Public  
16 Act 104-0003, as amended, is reappropriated from the State  
17 Coronavirus Urgent Remediation Emergency Fund to the Illinois  
18 Criminal Justice Information Authority for administrative  
19 costs and grants to the following named entities, including  
20 but not limited to, for purposes allowed by Section 9901 of the  
21 American Rescue Plan Act of 2021 and any associated federal  
22 guidance, including prior years' costs. The combined cost of  
23 grants and administrative expenses associated with each grant  
24 shall equal the approximate amounts below.

1           Section 999. Effective date. This Act takes effect July 1,  
2    2026.
