1. <!--[if !supportLists]--><!--[endif]-->ComEd would continue to send 47.5 hours per month, such work delineated per below:

15.0 hours will be as a "credit" for administrative hearing work that the firm bills on a flat-fee basis (this carve-out was agreed upon in 2015);

15.0 hours will be made up of replevin work, litigation to be handled by junior associates at low hourly rates (ComEd recently agreed to send these kinds of cases to the firm); and

17.5 hours will be made up of litigation or transactional work to be handled by partner-level attorneys at agreed-upon billing rates.

2. <!--[if !supportLists]--><!--[endif]-->Since we have already accepted the 40% reduction in value of the work, the most beneficial thing that ComEd could do would be to make a multi-year extension commitment to the firm.

3. <!--[if !supportLists]--><!--[endif]-->ComEd would continue to send property damage (contingency billing) work, but in accordance with prior year discussions, not include such work in its minimum commitment.
