Sorry for the delay. Attached is a 2 page outline of how we would utilize the training dollars in the Exelon Bill. I had a conversation with Fidel Marquez back in December and it was unclear how they (ComEd) would ask the organizations to spend the funds. Fidel mentioned a period as perhaps being 4 years because of not knowing the capacity of organizations to utilize and spend the dollars.
