INTRODUCTION AND FIRST READING OF BILLS

The following bills were introduced, read by title a first time, ordered reproduced and placed in the Committee on Rules:

HOUSE BILL 3948. Introduced by Representative Gabel, AN ACT concerning health.

HOUSE BILL 3949. Introduced by Representative Harper, AN ACT concerning human rights.

HOUSE BILL 3950. Introduced by Representative Davidsmeyer, AN ACT concerning State government.

SENATE BILLS ON FIRST READING

Having been reproduced, the following bill was taken up, read by title a first time and placed in the Committee on Rules: SENATE BILL 460(Crespo).

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 572

Offered by Representative Spain:

WHEREAS, Many children are affected by childhood cancers, including acute lymphoblastic leukemia (ALL), which is the most common type of childhood cancer; and

WHEREAS, 98% of children with ALL go into remission within weeks of starting treatment, and approximately 90% of those children can be cured (in remission for 10 years) with proper treatment; and

WHEREAS, Vincristine is a low-cost chemotherapy medication that has proven effective in treating childhood cancers, including ALL, and is frequently used to treat childhood cancers; and

WHEREAS, According to the FDA, production issues with the sole supplier of vincristine may lead to a months-long shortage; and

WHEREAS, Shortages of vincristine may lead to rationing, patients being forced to skip doses, or patients receiving lower doses than optimal, which may decrease the effectiveness of treatment; and

WHEREAS, Studies have shown that approximately 65% of pediatric hematologists and oncologists had patients who were affected by drug shortages; and

WHEREAS, A survey of hospitals has found that, on average, hospitals in the United States dedicate more than 8.6 million additional labor hours annually to manage drug shortages, creating a financial impact of nearly \$360 million; and

WHEREAS, The Children's Oncology Group, a clinical trials group supported by the National Cancer Institute which is the world's largest organization devoted exclusively to pediatric cancer research, has called for intervention by governments to combat future drug shortages; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge all stakeholders to work together in a cooperative fashion to not only resolve the current production issues effecting vincristine but also to further examine strategies to combat critical drug shortages; and be it further

RESOLVED, That suitable copies of this resolution be delivered to Governor Pritzker, all U.S. Senators, and all U.S. Representatives.

HOUSE RESOLUTION 577

Offered by Representatives Elizabeth Hernandez:

WHEREAS, On December 20, 2019, the Trump Administration announced the Migrant Protection Protocols, a policy that denies entry into the United States to refugees coming to the Southern border seeking protection from persecution, harm, and torture in their home countries; and

WHEREAS, Since that date, more than 52,000 persons, including adults and children, have been denied entry and forced to remain in Mexico, in very dangerous conditions, to await their court hearings that are sometimes many months away; and

WHEREAS, Refugees are being forced into squalid and inhumane conditions where they are living without clean or running water, without food or shelter, and without access to health care, diapers, and basic needs; and

WHEREAS, The Trump Administration's racist and inhumane actions, denying entry to the most vulnerable, have tragic life or death consequences; and

WHEREAS, Tent courts have been set up along the border, and refugees have no meaningful access to a fair hearing, due process, or legal counsel when forced to remain in Mexico; and

WHEREAS, The State of Illinois is a welcoming state and has taken important steps to ensure that immigrants are safe, protected, and able to live with dignity and respect; and

WHEREAS, History has shown that executive decisions about immigration, refugees, and asylum seekers have life or death consequences that may go unrecognized for far too long; and

WHEREAS, Most of the refugees forced to wait in Mexico have family in the United States, including in Illinois, where they can live safely as they undergo their court proceedings; and

WHEREAS, The United States and the State of Illinois in particular have welcomed, supported, and protected people of all races, ethnicities, religions, and nationality, in compliance with human rights principles and domestic and international law; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we condemn President Donald J. Trump's Migrant Protection Protocols denying entry to refugees at the Southern border and call on him to immediately rescind this abhorrent policy that is placing vulnerable people at further risk of harm, and we call on the U.S. Congress to put an end to the Migrant Protection Protocols by defunding the program in its upcoming budget vote before the end of this calendar year; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the President of the United States, the U.S. Senate Majority Leader, the U.S. Senate Minority Leader, the U.S. Speaker of the House, the U.S. House of Representatives Minority Leader, and all members of the Illinois Congressional Delegation.

HOUSE RESOLUTION 579

Offered by Representative Stuart:

WHEREAS, Multiple sclerosis (MS) can impact individuals of all ages, races, and ethnicities but is at least two to three times more common in women than in men; and

WHEREAS, There are approximately 2,300,000 individuals worldwide who have been diagnosed with MS; and

WHEREAS, In a study presented in October 2017 by the European Committee for Treatment and Research in Multiple Sclerosis, preliminary results from leading experts estimate that nearly one million people are living with MS in the United States alone, which is more than twice the previously reported number of 400,000; and

WHEREAS, The Greater Illinois Chapter of the National Multiple Sclerosis Society shows 18,365 persons living with MS, and, as not all people register with the Society, the true number of persons living with MS in this area is higher; and

WHEREAS, In Illinois, the Department of Public Health collaborates with community partners to improve the health of people at risk for, or affected by, MS; and

WHEREAS, MS is typically diagnosed in individuals between the ages of 20 and 50, but it is estimated that between 8,000 and 10,000 children and adolescents are living with MS in the United States; and

WHEREAS, MS is an unpredictable and often disabling disease of the central nervous system that disrupts the flow of information within the brain and between the brain and the body; and

WHEREAS, Symptoms of MS range from numbness and tingling to vision problems and paralysis, and the progress, severity, and specific symptoms of MS in any one person cannot yet be predicted; and

WHEREAS, While there is no evidence that MS is directly inherited, studies show that there are genetic and environmental factors that give certain individuals a higher risk of developing MS; and

WHEREAS, The exact cause of MS is still unknown, and there is no cure for MS; and

WHEREAS, The Multiple Sclerosis Coalition is a national network of independent MS organizations dedicated to the enhancement of the quality of life of individuals affected by MS; and

WHEREAS, The mission of the Multiple Sclerosis Coalition is to increase opportunities for cooperation and to provide a greater opportunity to leverage the effective use of resources for the benefit of the MS community; and

WHEREAS, In 2012, the National Multiple Sclerosis Society was a founding member of the International Progressive MS Alliance, which coordinates research to accelerate the development of treatments for progressive MS by removing international scientific and technological barriers and, as of 2018, includes 17 MS organizations from 17 countries, nine foundation and trust members, and seven pharmaceutical partners; and

WHEREAS, The Multiple Sclerosis Coalition recognizes and supports Multiple Sclerosis Awareness Week and Day during March of every calendar year; and

WHEREAS, The goals of Multiple Sclerosis Awareness Week and Day are to invite people to join the movement to end MS, to encourage everyone to do something to demonstrate a commitment to moving toward a world free of MS, and to acknowledge those who have dedicated time and talent to help promote MS research and programs; and

WHEREAS, Building awareness is a year-round effort, and MS Awareness Week and Day serve as a platform for everyone affected by MS across the country to share strategies and experiences to live their best lives in the belief that together we are stronger; and

WHEREAS, In 2019, SR 218 recognized Multiple Sclerosis Awareness Week during the week of March 10 through March 16; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the week of March 10 through March 16, 2020 as Illinois Multiple Sclerosis Awareness Week, and we declare March 31, 2020 as Illinois Multiple Sclerosis Awareness Day; and be it further

RESOLVED, That we support the goals and ideals of Multiple Sclerosis Awareness Week and Day and encourage municipalities to support the goals and ideals of Multiple Sclerosis Awareness Week and Day by issuing proclamations designating Multiple Sclerosis Awareness Week and Day; and be it further

RESOLVED, That we encourage media organizations to participate in Multiple Sclerosis Awareness Week and Day to help provide education to the public about multiple sclerosis; and be it further

RESOLVED, That we encourage residents to help ensure that more people understand what life with MS can be like by sharing the stories of those living with MS on social media and by using the hashtag #ThisIsMS; and be it further

RESOLVED, That we commend the efforts of municipalities to support the goals and ideals of Multiple Sclerosis Awareness Week and Day and recognize and reaffirm the commitment of the State of Illinois to ending MS by promoting awareness about individuals that are affected by MS and supporting MS research and education programs; and be it further

RESOLVED, That we recognize all individuals living with MS and express gratitude to the family members and friends of individuals living with multiple sclerosis who are a source of love and encouragement for those individuals, and we salute the healthcare professionals and medical researchers who provide assistance to individuals affected by MS; these professionals continue to work to find ways to stop multiple sclerosis, to restore what has been lost due to MS, and to end MS forever.

WHEREAS, Eldon Williams Jr. was not only loved dearly by his friends and family but was also an esteemed citizen and respected member of Madison County, who had his life tragically taken before his time; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate the portion of Illinois Route 111 along Godfrey Road from Ramona Place to Crestwood Drive as the "Eldon 'Twirp' Williams Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal highway regulations, appropriate plaques or signs giving notice of the name of the "Eldon 'Twirp' Williams Memorial Highway"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Eldon Williams Jr., the Secretary of the Illinois Department of Transportation, and the Mayor of the Village of Godfrey.

HOUSE JOINT RESOLUTION 90

Offered by Representative Ammons:

WHEREAS, The United States' history as a symbol of democracy, freedom, and "home of exiles" is brandished around the world; and

WHEREAS, The legacy of our Nation's African-descended people and indigenous peoples has resounded as an echoing dissonance in its "symphony of brotherhood" throughout its history; and

WHEREAS, The legacy of African American struggles for civil, political, and human rights is interwoven in the fabric of democracy and freedom of the United States; and

WHEREAS, Millions of Africans and their descendants were enslaved in the United States, from the original 13 North American colonies until the abolition of slavery in 1865 with the 13th Amendment to the Constitution to "slavery by another name" under the twin regimes of racial economic and social authoritarianism, called Jim Crow, and domestic terrorism; and

WHEREAS, The aggregate value of enslaved African Americans at the time of Emancipation, measured in 2019 dollars, was more than 13 trillion dollars, which is a meager percentage of the unpaid wealth that they produced for the United States' slave-based economy; and

WHEREAS, The gendered racism of the United States' system of slavery made the productive and reproductive intrinsic value of enslaved African American women an incalculable source of the United States' global economic power; and

WHEREAS, Africans forced into slavery, brutalized, humiliated, dehumanized, and subjected to the indignity of being stripped of their names and heritage makes the reparations due to African Americans necessary but insufficient as the United States' payment on the debt of African American slavery, peonage, and expropriation of Black asset wealth through fraudulent mortgages like Chicago's notorious "contract buyers" schemes; and

WHEREAS, African American families were torn apart when family members were sold off, endured further separation and deprivation under Jim Crow, but sought freedom and economic opportunities in the Great Migration from the South to northern Midwest states like Illinois; and

WHEREAS, The system of hereditary racial slavery that commenced not long after "the 1619 year of no return" provided the foundation of the system of structural racism, inequality, and white supremacy that became woven into the social fabric of the United States; and

WHEREAS, So embedded in the United States' social, political, economic, religious, and cultural landscape was the system of African American subjugation that it took the apocalypse of the American Civil War to rid the Nation of its "original sin"; and

WHEREAS, The State of Illinois assumes a special place in the history and memorialization of "the 1619 day of no return" because of the role that President Abraham Lincoln played as Commander-in-Chief in defeating the armed revolt of the slave power of the southern Confederacy against American democracy and African American freedom; and

WHEREAS, It took the powerful working of the United States' democratic electoral system, propelled by the movement of African American slaves following the North Star to freedom in solidarity with their White and free Black allies in the abolitionist movement, to elect and re-elect Abraham Lincoln to carry out the historic task of ridding the United States of slavery; and

WHEREAS, The great challenge to our experiment in democracy that we face today gives us further reason to memorialize the Black struggle for freedom that recommitted the United States to its democratic ideals, adding the Civil War Amendments (13th, 14th, and 15th) to the Constitution; and

WHEREAS, Illinois has never evinced the same care and consideration for its Black exiles from Africa that it has for its White exiles from Europe; and

WHEREAS, Every positive step that Illinois has taken toward racial justice and equality has been reversed by backward legislative steps that have made Black freedom struggles in Illinois continuous to this day; and

WHEREAS, The 1908 Springfield Race Riot in the State's capital and seat of the people's representatives was the catalyst for the formation of the National Association for the Advancement of Colored People (NAACP); and

WHEREAS, The 1917 East St. Louis race riot demonstrated the tangled history of race, class, and economics that victimized African Americans who were newly arrived to Illinois from the South; and

WHEREAS, Springfield and East St. Louis also reflected a new Black assertiveness, a "New Negro", that culminated in the "Red Summer of 1919" Chicago Race Riot, whose 100th anniversary is also memorialized with this resolution; and

WHEREAS, The history of Illinois' modern system of racial segregation, heroically countered by the democratic struggles of the State's African American communities, calls upon all Illinois legislators to prioritize the State's legislative agenda around policies and realistic funding appropriations aimed at addressing the interminable legacy of racial inequities in African American education, housing, labor market outcomes, transportation marginalization, business inequalities, healthcare disparities, and political decision-making disempowerment; and

WHEREAS, The State of Illinois also boasts numerous racial justice moments throughout its 20th century political history that have impacted both the State's and the United States' history, including the election of Abraham Lincoln, the election of Harold Washington as the first Black Mayor of the City of Chicago, the election of Barack Obama as the first Black President of the United States, the election of Illinois' first Black Woman Lieutenant Governor, the election of the first Black Woman State Representative of Illinois' 103rd District, representing the University of Illinois Urbana-Champaign, the election of the first Black Chancellor of the University of Illinois Urbana-Champaign, and the election in Chicago of the first Black LGBTQ Mayor of any major city in the United States; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we express our support of the 1619 African Year of No Return resolution by turning it into the Illinois Recognition of the 1619 Project: Year of Return resolution; and be it further

RESOLVED, That we urge recognition of Illinois' vibrant history of African American political struggles for democracy and freedom that have widened the scope and deepened the State's and United States' commitment to democracy and racial justice; and be it further

RESOLVED, That we urge adequate appropriations for investigations, research, publication, and a website to represent Illinois' contribution to widening and deepening the State's and the United States' commitment to racial justice in memorializing the 1619-2019 Year of Return; and be it further

RESOLVED, That we urge adequate appropriations for the development of a comprehensive legislative agenda of policies and pending racial justice legislation for engagement with the State's African American stakeholders to memorialize the 1619-2019 Year of Return.

WHEREAS, Jake Ringering passed away in the line of duty on March 5, 2019 at the age of 37; he was born on December 14, 1981 in Alton; he graduated from East Alton Wood River High School in 2000 and from Lewis & Clark Community College in 2004 with an Associate's Degree in Fire Science; he also earned his Emergency Medical Technician License; and

WHEREAS, Jake Ringering began his long career as a firefighter in East Alton on February 20, 2001; he was hired as a career firefighter at East Alton on December 20, 2005; on August 5, 2010, he was hired as a career firefighter with the Godfrey Fire Protection District, where he attained the rank of lieutenant on March 27, 2013 and captain on May 1, 2014; and

WHEREAS, Jake Ringering was the technical rescue officer, respiratory protection officer, and lead instructor for the Godfrey Fire Protection District; he earned Illinois Office of the State Fire Marshal Certification in Firefighter II, Firefighter III, Basic Operations Firefighter, Advanced Technician Service Vehicle Operator, Fire Apparatus Engineer, Vehicle and Machinery Operations, Rescue Specialist-Confined Space, Hazardous Materials First Responder Operations, Rope Operations, Fire Service Instructor I, Fire Service Instructor II, Fire Investigator, and Rescue Specialist Vertical II/High Angle; and

WHEREAS, As a result of his dedication to public service, Jake Ringering impacted many lives, and countless individuals are alive today as a testament; he served as president of the Godfrey Firefighters Local 1692 and taught fire science at Lewis & Clark Community College; he was also a trainer/instructor through Max Fire Training and a member of St. Mary's Catholic Church in Alton; and

WHEREAS, Jake Ringering was preceded in death by his grandparents, Lucien and Majorie Ringering, and Captain Ed Ballard; and

WHEREAS, Jake Ringering is survived by his wife, Allison Budde; his parents, Robin Ballard Disney and her husband, Reverend Stephen Disney, and Larry Ringering and his wife, Jan; his children, Nora Marie Ringering, Elaina Lynn Ringering, and Logan Jacob Ringering; his brother, Chris Stratton (Richel); his sister, Julie Downs (Jedediah); his grandmother, Thelma Ballard; Allison's parents, Robert and Susan Budde; his sister-in-law, Andrea Budde; his brother-in-law, Andrew Budde; his nieces and nephews, Jaden, Jerald, Jolene, and Jacqueline Downs, Landon and Levi Stratton, and Jackson Budde; and numerous aunts; and

WHEREAS, Jake Ringering was the most devoted husband and father to his family and always put them first in his life; he was a leader and always wanted to help others; he was a loving son, brother, and in-law, who never met a stranger; he was loved by many people, and everyone he met called him a friend; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED FIRST GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we designate West Delmar Avenue in Godfrey as it travels between Staten Drive and Valhalla Cemetery as "Jake's Way Memorial Highway"; and be it further

RESOLVED, That the Illinois Department of Transportation is requested to erect at suitable locations, consistent with State and federal regulations, appropriate plaques or signs giving notice of the name "Jake's Way Memorial Highway"; and be it further

RESOLVED, That suitable copies of this resolution be presented to the family of Captain Jake Ringering, the Secretary of the Illinois Department of Transportation, the Mayor of the City of Alton, and the Mayor of the City of Godfrey.
