HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 33

Offered by Representative Grant:

WHEREAS, Governor JB Pritzker has reappointed Marc D. Smith to the position of Director of the Illinois Department of Children and Family Services (DCFS); and

WHEREAS, DCFS is awarded \$1.5 billion of Illinois taxpayer money each year; and

WHEREAS, DCFS is in charge of keeping the most vulnerable youths in Illinois safe and healthy; and WHEREAS, DCFS released Damari Perry into the care of his mother, Jannie Perry, in 2017; he was born in 2015, and she had lost custody of her five other children in 2014; DCFS conducted two investigations into reports of abuse and neglect, including the child being forced to stand in a freezing shower until he threw up and became unresponsive; DCFS failed to remove Damari Perry from the care of his mother before he was found dead in Gary, Indiana; Jannie Perry, her son and Damari's brother, Jeremiah Perry, age 20, and a juvenile sibling have been charged with Damari's death; and

WHEREAS, DCFS was involved with the Hill family for 19 years; the Hill family had 16 children, and each child was investigated as being abused or neglected at least once in that 19-year period; 10 of the children had been removed from the home due to neglect; I'Kera Hill, age three, died of malnutrition while in the care of her parents, and she was not the first of her siblings to die, as her sister, reported by CBS News as "child 10", died while in foster care in 2015; and

WHEREAS, In 2019, there were nine child deaths with a connection to DCFS within nine days; and WHEREAS, Under Marc D. Smith's watch as director of DCFS, at least 171 children in contact with DCFS have died in 2022, according to the DCFS Inspector General; and

WHEREAS, DCFS only fully investigated 97 of the 171 child deaths; and

WHEREAS, The Inspector General's report found that 36 children died from homicide, six from suicide, 38 from accidents, 19 from unknown causes, 67 from natural causes, and five for which the cause was still pending; many of the children died in homes flagged as violent by DCFS, homes in which the children were not supposed to be allowed to live due to the threat of violence; and

WHEREAS, Illinois had a record number of child deaths under the watch of DCFS in 2022, with a 40% increase over previous years; and

WHEREAS, Reports of child abuse and neglect to DCFS have taken up to 100 days for the department to investigate; and

WHEREAS, DCFS Director Marc D. Smith has been found in contempt of court 12 times for failing to properly place children in care while serving as DCFS Director; and

WHEREAS, The Illinois Auditor General's Office documented 30 problems within DCFS, including 18 repeated problems that had been noted in the past and were still not resolved; and

WHEREAS, There are approximately 20,000 youths in the DCFS system in Illinois, but the audits found the department rarely tracks where these youths are placed or whether they are healthy; and

WHEREAS, Auditors found that 98% of the home safety checklists that DCFS is required to conduct every time a child returns home were not completed in 2020; and

WHEREAS, Director Marc D. Smith's actions as leader of DCFS have directly led to more children dying from abuse and neglect, as well as increased failures and problems within DCFS; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge Marc D. Smith to resign as the Director of the Illinois Department of Children and Family Services; and be it further

RESOLVED, That we urge Governor Pritzker to formally ask for the resignation of Marc D. Smith from the position of Director of the Illinois Department of Children and Family Services; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to Governor JB Pritzker and DCFS Director Marc. D. Smith.

HOUSE RESOLUTION 37

Offered by Representative West:

WHEREAS, The opioid crisis has exacted a terrible toll on our State and nation over the past three decades, including the loss of over 3,000 Illinoisans to overdose in 2021 alone, which is a nearly 36% increase in just two years of an epidemic that has hit some areas, including many rural regions and some communities of color, particularly harshly; and

WHEREAS, The countless victims of the opioid epidemic include young children, the most vulnerable and helpless; every 25 minutes in the United States, a baby is born suffering from opioid withdrawal, also known as Neonatal Abstinence Syndrome (NAS); Illinois' own NAS rate grew 64% between 2011 and 2017 alone; and

WHEREAS, Babies born with NAS face a higher likelihood of experiencing health complications at birth, as well as long-term health challenges and developmental delays; and

WHEREAS, Overdose is now the leading cause of maternal death in Illinois, adding to the many challenges experienced by young children, their families, and communities; and

WHEREAS, Parental substance use disorder is considered an Adverse Childhood Experience (ACE), and research consistently shows that children experiencing ACEs are more likely than their peers to grow up to use drugs themselves and face physical and mental health challenges, as well as educational difficulties that can impact their ability to succeed later in life; and

WHEREAS, Recognizing the need to address these issues, the Children and Families Committee of the Illinois Opioid Crisis Response Advisory Council has called for increased focus on how this drug epidemic has impacted children and their households; and

WHEREAS, During development of the most recent iteration of the State Opioid Action Plan (SOAP), that committee made a number of relevant recommendations for increasing supports for affected children and families, in addition to strengthening the systems that help them; and

WHEREAS, Several key birth-to-3 programs have been shown to play an important role in remediating the detrimental effects of opioid use disorder as well as preventing future such problems, among many other positive health outcomes; and

WHEREAS, Voluntary home-visiting programs are one key example of these initiatives, services provided through such evidence-informed models as Healthy Families America, Nurse Family Partnership, BabyTALK, and Parents As Teachers, in which trained professionals visit the homes of new or expecting parents and their young children to help support a wide variety of health, education, and developmental needs; and

WHEREAS, Quality home-visiting services have been shown to help build resilience among young children and reduce the likelihood that they experience ACEs and become involved in later-in-life drug use and crime, thus playing an important prevention role, and can also help connect parents with any substance-use recovery services they might need; and

WHEREAS, The Maternal Morbidity and Mortality Report published in 2021 by the Illinois Department of Public Health recommends expanding home-visiting programs as a key strategy for addressing these significant maternal health challenges; and

WHEREAS, Early Intervention services are another vital birth-to-3 priority, providing physical, developmental, speech, and other therapies desperately needed by infants and toddlers with developmental delays or disabilities, or risks of such challenges, which are experienced more often by children born with NAS; and

WHEREAS, Our State's existing home-visiting and Early Intervention programs, which are administered through the Illinois Department of Human Services and work with local-level service providers statewide, are limited by existing resources, preventing them from reaching all the children and families who could benefit from high-quality birth-to-3 services; and

WHEREAS, These longstanding shortcomings include inadequate compensation for hardworking and often-overextended community-level service providers and support staff, fueling high caseloads and staff turnover; and

WHEREAS, It is an urgent priority to identify and pursue promising new sources of support for these early childhood initiatives that have a demonstrated history of beneficial outcomes for children, their families, their communities, and our entire State; and

WHEREAS, One potential and appropriate source of funding is represented in the settlement of several lawsuits against the manufacturers and distributors of opioids, lawsuits that were initially filed by a number of Illinois state's attorneys and ultimately combined with others across the country; and

WHEREAS, The Illinois Attorney General has joined in negotiating the settlement of these national lawsuits that are leading to hundreds of millions of dollars in new resources for Illinois over the course of two decades, intended to strengthen efforts at drug treatment and remediation, as well as prevention of future opioid problems; and

WHEREAS, Determination of the use of these forthcoming resources is split between local-level and state-level decision makers, with the latter being aided by an Illinois Opioid Remediation Advisory Board; and

WHEREAS, One approved use of these settlement funds, as delineated in the Illinois Opioid Allocation Agreement, is to address the needs of pregnant or parenting women and their families, including babies with NAS; and

WHEREAS, Members of the nonprofit, bipartisan Fight Crime: Invest in Kids organization, representing 340 Illinois police chiefs, sheriffs, and prosecutors, including those from several of the state's attorney's offices that initiated a number of these very same lawsuits, strongly support the use of these settlement dollars for home-visiting and Early Intervention services as an important way to aid our State's response to the opioid epidemic; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we support home-visiting and Early Intervention programs as an essential component of our State's multifaceted approach to the opioid crisis, helping remediate many of its corrosive impacts on young children, their parents, and families, while also assisting efforts at preventing children from future struggles with substance use disorders of their own; and be it further

RESOLVED, That we affirm these vital birth-to-3 services are a top priority for increased public resources, to strengthen their quality and extend their reach to more of the children, parents, and families who could benefit from them, particularly in communities of greatest need and those hit hardest by the opioid epidemic; and be it further

RESOLVED, That we affirm home-visiting and Early Intervention services are an appropriate and necessary use for some of the hundreds of millions of funding coming to Illinois from the settlement of lawsuits against opioid makers and distributors, initiatives that can help meet the settlements' stated aims of boosting opioid remediation, treatment, and prevention; and be it further

RESOLVED, That suitable copies of this resolution be delivered to the offices of the Governor, the Lieutenant Governor, the Attorney General, the Illinois Department of Human Services, the Illinois Department of Public Health, the Governor's Opioid Prevention and Recovery Steering Committee, the Illinois Opioid Crisis Response Advisory Council, and the Illinois Opioid Remediation Advisory Board.

HOUSE RESOLUTION 38

Offered by Representative Reick:

WHEREAS, The Department of Children and Family Services (the Department) (DCFS) is the sole agency responsible for receiving and investigating reports of child abuse or neglect made under the Abused and Neglected Child Reporting Act; and

WHEREAS, As of the end of fiscal year 2022, the Department had conducted 97,400 investigations serving 22,911 youth; and

WHEREAS, In fiscal year 2022, 171 children died after involvement with the Department, a 40% increase over the previous year; while this does not imply causation on the part of the Department, it does imply that the Department's efforts to prevent the death of children are not sufficient; and

WHEREAS, The projected budget of the Department for fiscal year 2023 is \$1.8 billion; and

WHEREAS, Since the establishment of the Office of Inspector General (OIG) in 1993, the annual reports issued by the Inspector General have catalogued a consistent pattern of Departmental failures that unfortunately have contributed, through lack of action and negligence, to the deaths of hundreds of children in DCFS care over that period of time; and

WHEREAS, In her 1995 report, the OIG observed that "the prevalent over-emphasis on Department rules and procedures perpetuates the Department's isolation and fosters the belief that only Department employees are responsible for the well-being of children in Illinois. A more useful analysis considers whether practices should be changed so that Department employees, working with individuals from other disciplines, would be able to pinpoint situations in which death is a possibility or likelihood. By identifying the characteristics that have led to a death in the past and by utilizing the experiences of a variety of professionals, department employees will be in a better position to prevent future deaths."; and

WHEREAS, In her 2022 Annual Report, the Department's Office of the Inspector General identified a systemic pattern of negligence in mandated child protection investigations in which there were significant delays in making initial contact with alleged child victims of abuse or neglect; in these cases, the Department failed to fulfill an essential responsibility in protecting children; and

WHEREAS, The Inspector General noted that several investigations conducted this year highlight the critical need for communication and collaboration among multiple entities; and

WHEREAS, From the above, it is apparent that shortcomings that were noted 27 years ago are still present in the Department; the result of this is the unfortunate litany of the deaths of children who are in the care of and are the responsibility of the Department; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that it is our position that the time is long past for systemic changes to be made to the Department of Children and Family Services so that it can fulfill its mission to protect children and prevent the ongoing tragedy of child abuse and neglect that confronts us every year; and be it further

RESOLVED, That we call upon the Governor and the executive branch as well as the Department of Children and Family Services to cooperate in every way that they can to assure that these changes will be made.

HOUSE RESOLUTION 39

Offered by Representative Hoffman:

WHEREAS, Nearly everyone who visits the dentist's office is familiar with the role of the dental hygienist; a hygienist performs the deep clean of your teeth, flags trouble spots that could become cavities, reviews how diet can affect the health of your mouth, and much more; a dental hygienist works with a patient to prepare them for an appearance before the dentist; and

WHEREAS, The work of a dental hygienist helps prevent tooth decay and helps maintain a patient's oral health; the importance of having hygienists on staff cannot be understated; and

WHEREAS, A good dental hygienist eases the dentist's burden, freeing the dentist to perform more advanced procedures; and

WHEREAS, Across the country, employers are still struggling to fill certain jobs; that is especially true for dentists trying to hire hygienists and other support staff; in addition, many patients are just now returning to the dentist after a long pandemic break, and they are finding it difficult to schedule an appointment; and

WHEREAS, A poll by the American Dental Association shows that nearly 40% of dentists are trying to recruit hygienists; of those, 95% say it has been extremely or very difficult to hire someone; in the 20 largest U.S. cities, the American Dental Association's polling reveals that only half of hygienist positions are reported as filled; and

WHEREAS, More than 80% of dentists that are recruiting dental hygienists are raising salaries; some are also offering more flexible working hours in an attempt to attract qualified candidates; and

WHEREAS, Staffing shortages have brought greater appreciation for the services of dental hygienists and assistants; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we recognize the important role that dental hygienists and assistants play in maintaining oral health; and be it further

RESOLVED, That we urge the Illinois Community College Board to incentivize the dental hygienists programs throughout the community colleges; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Illinois Dental Hygienists' Association, the Illinois State Dental Society, and the Illinois Community College Board.

HOUSE RESOLUTION 40

Offered by Representative Buckner:

WHEREAS, The cost of construction of new state of the art professional sport stadiums has increased over time; the cost of recently built state of the art professional football stadiums has often exceeded \$1 billion and obliterated original financial estimates; these stadiums are funded through a variety of methods, including private investors as well as taxpayer funding from state and local governments; and

WHEREAS, Public funding has been used as a tactic for professional sports teams to leverage state and local governments against each other in order to get a better deal on stadium financing; and

WHEREAS, Low income and minority communities in Illinois have been historically underfunded and have lacked sufficient investment; and

WHEREAS, The COVID-19 pandemic has reaffirmed the need to use taxpayer dollars to reinvest in communities, health care, schools, and infrastructure; and

WHEREAS, Public funding has been used in the construction or maintenance of most stadiums in the National Football League; only SoFi Stadium, home of the Los Angeles Rams and Chargers, and MetLife Stadium, home of the New York Giants and Jets, were completed with 100% private funding; recently, over \$750 million in public funds was used to finance Allegiant Stadium in Las Vegas, and \$498 million in public funds was used to finance US Bank Stadium in Minneapolis; and

WHEREAS, Public funding has also been used for professional baseball, basketball, and soccer stadiums; for example, Cincinnati taxpayers funded over 86% of the Red's Great American Ball Park; and

WHEREAS, There is no assurance that residents of a taxpayer-funded stadium will remain at their new home; history has shown that professional sports clubs move across country lines as in MLB's Montreal Expos moving and becoming the Washington Nationals, state lines as in the NFL's Oakland/Los Angeles Raiders moving from California to Nevada and the NFL's St. Louis Rams moving from Missouri to California, and intrastate relocations as well as in MLS's Chicago Fire leaving their soccer-specific stadium in Bridgeview to return to Chicago's Soldier Field; and

WHEREAS, As Illinois edges closer and closer to financial solvency, we cannot afford to spend taxpayer funds on stadiums when funding for critical social services remains uncertain; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the General Assembly is urged to take all necessary steps to ensure that no state or local taxpayer money is used in the construction of new professional sport stadiums.

HOUSE RESOLUTION 42

Offered by Representative Hauter:

WHEREAS, There is an increasing number of physicians experiencing burnout, a potential factor in the increased rates of physicians having depression and committing suicide; and

WHEREAS, Physicians who have or have had mental health concerns may be reluctant to seek treatment as it may cause difficulty in obtaining and/or renewing a medical license as well as obtaining institutional privileges; and

WHEREAS, Physicians not receiving treatment for mental health issues may pose harm to patients, and a lack of treatment for mental health issues can contribute to untreated burnout, depression, and increased rates of suicide; and

WHEREAS, Physicians have the right to obtain the same care as patients without retribution and with respect for the privacy of physicians' protected health information; and

WHEREAS, The American Psychiatric Association has found no evidence that a physician who has been treated for a mental illness is any more likely to harm a patient than a physician with no mental health issues; and

WHEREAS, The Americans with Disabilities Act of 1990 states that employers cannot discriminate against employees based on mental or physical health; and

WHEREAS, The 2018 American Psychiatric Association Position Statement on Inquiries About Diagnosis and Treatment of Mental Disorders in Connection with Professional Credentialing and Licensing recommends that medical licensing bodies not ask applicants about prior diagnosis and treatment of mental health disorders; and

WHEREAS, Per the 2018 American Psychiatric Association Position Statement on Inquiries About Diagnosis and Treatment of Mental Disorders in Connection with Professional Credentialing and Licensing "Medical or hospital records requested shall be by way of narrowly tailored requests and releases that provide access only to information that is reasonably needed to assess the applicant's fitness to practice. All personal or health-related information shall be kept strictly confidential and shall be accessed only by individuals with a legitimate need for such access...Personal health information collected by the board should be kept confidential and should be destroyed after a reasonable period of time"; and

WHEREAS, Many initial and renewal applications for medical licenses and associated applications and application reference forms, medical specialty boards, and institutional privilege and credential applications continue to include questions about physicians' mental health, and physicians who disclose a current or past mental health condition may be investigated or sanctioned; and

WHEREAS, Those applications that continue to make inquiries about a physician's mental health should use language consistent with the Americans with Disabilities Act, which limits questions to whether the individual has a medical condition that currently impacts his or her ability to practice medicine; and

WHEREAS, American Medical Association Policy H-275.970 addresses issues of potential discrimination and confidentiality violations in the licensing, privileging and credentialing processes; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the Illinois State Medical Society delegation to the American Medical Association to submit a resolution to the American Medical Association requesting that Policy H-275.970, Licensure Confidentiality, be amended as follows:

"1. The AMA (a) encourages specialty boards, hospitals, and other organizations involved in credentialing <u>and/or privileging</u>, as well as state licensing boards, to take all necessary steps to assure the confidentiality of information contained on application forms for credentials; (b) encourages <u>boards</u> these entities to include in application forms only requests for information that can reasonably be related to

medical practice; (c) encourages state licensing boards, specialty boards, hospitals and other organizations involved in credentialing and/or privileging to exclude from license application forms information that refers to psychoanalysis, counseling, or psychotherapy required or undertaken as part of medical training; (d) encourages state medical societies and specialty societies to join with the AMA in efforts to change statutes and regulations to provide needed confidentiality for information collected by licensing boards and related organizations; and (e) encourages state licensing boards, specialty boards, hospitals and other organizations involved in credentialing and/or privileging to require disclosure of physical or mental health conditions only when a physician is suffering from a condition that currently impairs his/her judgment or that would otherwise adversely affect his/her ability to practice medicine in a competent, ethical, and professional manner, or when the physician presents a public health danger.

- 2. Our AMA will have all those state medical boards, specialty boards, hospitals, and other organizations involved in credentialing/privileging that wish to retain questions about the health of applicants on medical licensing applications confirm the use of or will change by 2024 all inquiries of the health of applicants to the language recommended by the Federation of State Medical Boards that reads, "Are you currently suffering from any condition for which you are not being appropriately treated that impairs your judgment or that would otherwise adversely affect your ability to practice medicine in a competent, ethical and professional manner? (Yes/No)."
- 3. Our AMA will work with the Federation of State Medical Boards, the American Hospital Association, the American Board of Medical Specialties, and state medical societies to develop policies and strategies to ensure that by 2024 all new and renewal medical licensure and associated applications and application reference forms, privileging, credentialing and related applications and documentation will request or disclose only information that is reasonably needed to address the applicant's current fitness to practice medicine and respect the privacy of physician's protected health information."; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Illinois State Medical Society and the American Medical Association.

HOUSE RESOLUTION 43

Offered by Representative Stephens:

WHEREAS, St. John's Conclave is the State of Illinois' premier body of the Order of the Red Cross of Constantine; the organization was initially chartered by the Grand Imperial Conclave of the Red Cross of England on February 3, 1872; and

WHEREAS, St. John's Conclave was declared to be the Conclave No. 1 of the Grand Imperial Council of Knights of the Red Cross of Constantine and Knights of the Holy Sepulchre of the State of Illinois on August 30, 1872, heading the Empire of the West; and

WHEREAS, The membership of St. John's Conclave has included many distinguished citizens who have contributed significantly to Chicago and the State of Illinois, including Chicago City Comptroller Theodore T. Gurney (1820–1886), Chicago Mayor DeWitt Clinton Cregier (1829-1898), Lieutenant Governor of Illinois and Brigadier General John Corson Smith (1832–1910), Chief Executive Officer W. Clement Stone (1902–2002), Governor of Illinois Richard B. Ogilvie (1923–1988), and many other leaders in medicine, law, and business; and

WHEREAS, St. John's Conclave continues in its 151st year of providing fraternal support to the community and following out the chivalric traditions of Constantinian Freemasonry; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare March 1, 2023 as St. John's Conclave Day in the State of Illinois; and be it further

RESOLVED, That a suitable copy of this resolution be presented to the Recorder Martin P. Starr of St. John's Conclave.

HOUSE RESOLUTION 44

Offered by Representative Mason:

WHEREAS, Diaper need is the lack of enough diapers to keep a baby or toddler clean, dry, and healthy and is a recognized public health issue that impacts the physical, mental, and economic well-being of U.S. children and families; and

WHEREAS, Diaper need can result from poverty, unexpected life hardships, natural disasters, and so much more; and

WHEREAS, One in three U.S. families reported experiencing diaper need; and

WHEREAS, Nearly three in five families experiencing diaper need reported missing work or school due to lack of access to clean diapers needed for childcare services; and

WHEREAS, Families reporting diaper need encompass a wide array of ages, racial groups, and income levels; of those in diaper need, 96 percent are under 45 years of age with the majority between 25 to 34 years of age; and

WHEREAS, Of those in need, two in five families said they stretch the use of diapers by keeping a child in the same diaper longer, which can increase a child's risk for skin irritation and other serious side effects; and

WHEREAS, Research shows that a lack of access to clean diapers leads to negative and long-lasting impacts on a child's physical and mental health; and

WHEREAS, The National Diaper Bank Network (NDBN) has more than 225 member diaper banks that have reported on average an 86% increase in the number of diapers distributed to families compared to the previous year, with spikes of up to 800% more in some cities; in 2020, the NDBN distributed more than 140 million diapers to families in need; no federal support programs for children cover diapers, which can cost approximately \$80 a month per child; and

WHEREAS, Diapers are a basic necessity for every baby and toddler; there are many people who do not have enough money to meet their basic needs, and diaper need can be a window into poverty; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the week of September 18 to September 24, 2023 as "Diaper Need Awareness Week" in the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be presented to the National Diaper Bank Network Illinois affiliates.

HOUSE JOINT RESOLUTION 8

Offered by Representative Meier:

WHEREAS, It is highly fitting that the Illinois General Assembly pays honor and respect to truly great individuals who have served our country and, in doing so, have made the ultimate sacrifice for our nation; and

WHEREAS, Their sacrifice and service is a reminder that freedom is not free but comes at a cost; and WHEREAS, We should always remember the men and women who helped preserve the freedoms that we all enjoy; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend the Illinois Constitution in Article I by changing Section 22 as follows:

ARTICLE I BILL OF RIGHTS

(ILCON Art. I. Sec. 22) SECTION 22. RIGHT TO ARMS

Subject only to the police power, the right of the individual citizen to keep and <u>carry firearms</u> bear arms shall not be infringed.
