WHEREAS, The members of the Illinois House of Representatives are saddened to learn of the death of Eugene Morice Barnes, who passed away on November 13, 2022; and

WHEREAS, Eugene Barnes, the eighth of 11 children born to John and Nettie L. Barnes, was born in Chicago on July 24, 1931; and

WHEREAS, Eugene Barnes was a product of Chicago Public Schools and graduated from Wendell Phillips High School; and

WHEREAS, Following high school, Eugene Barnes joined the U.S. Air Force as a private, serving in France and Germany during the Korean Conflict; during his service, he achieved the rank of sergeant and earned a Certificate of Accounting from the U.S. Air Force Specialist School; and

WHEREAS, After returning home with an honorable discharge, Eugene Barnes started his professional career working for the Social Security Administration; this was followed by a stint with the U.S. Internal Revenue Service and then a 14-year tenure with the Chicago Transit Authority; and

WHEREAS, Eugene Barnes was elected to the Illinois House of Representatives and served the 29th District from 1970 to 1979; and

WHEREAS, Joining a group of lawmakers who helped found the Illinois Legislative Black Caucus a few years prior to his arrival in Springfield, Eugene Barnes championed legislation that helped to create the Illinois State Lottery, made Illinois the first state to provide funding for Sickle Cell Anemia, and secured appropriations to finance the first buildings on the Chicago State University campus; and

WHEREAS, In 1979, Eugene Barnes resigned his seat in the Illinois House when he was named the first Black chairman of the Chicago Transit Authority; he was later elected chairman of the American Public Transportation Association; and

WHEREAS, During his four terms as a state legislator, Eugene Barnes' work on behalf of Illinois families earned him much recognition, including the Outstanding Legislator Award from the Federation of Independent Illinois Colleges and Universities; and

WHEREAS, While in office and following his retirement from the Illinois General Assembly, Eugene Barnes remained active in the community as a proud member a number of organizations, including the Maple Park Homeowners Association, the NAACP, and the A. Phillip Randolph Association and as a life member of ATU Local 241 and Operation Breadbasket, now Operation PUSH; and

WHEREAS, Eugene Barnes was preceded in death by his wife of 42 years, Lei-Lani Roach and his grandchild, Eric Antwon; and

WHEREAS, Eugene M. Barnes is survived by his three children, Vikki L. Barnes-McKenzie, EuGina M. Barnes, and Craig D. Barnes, and his six grandchildren, Michael Dewayne Jr., Tiffany Danielle, Craig Dareen II, Timothy Jacob, Elijah Malachi, and LeiLani MyL; therefore, be it

WHEREAS, The members of the Illinois House of Representatives are saddened to learn of the death of former Illinois State Representative Raymond Whitney Ewell, who passed away on October 28, 2022; and

WHEREAS, Rep. Ewell, the second child of Whitney and Severine Ewell, was born in Chicago on December 29, 1928; and

WHEREAS, Rep. Ewell excelled academically as an adolescent, attending Corpus Christi Elementary School and later graduating from Englewood High School in Chicago in 1946; and

WHEREAS, Following high school, Rep. Ewell earned a Bachelor of Arts from the University of Illinois in 1949, a Master of Arts in 1951, and a Juris Doctor from the University of Chicago in 1954; and

WHEREAS, Rep. Ewell's commitment to service began with his military conscription into the U.S. Army, and after concluding his military career with an honorable discharge, he re-established himself in the legal field, practicing law for 53 years and becoming a partner at the law offices of Ewell, Graham, McCormick, Ross and Davidson; and

WHEREAS, After years of participation in the 17th Ward Regular Democratic Organization, Rep. Ewell was elected to the Illinois House of Representatives and served the 29th District from 1967 to 1983; and

WHEREAS, At the height of the Civil Rights Movement in 1967, Rep. Ewell, along with State Representatives Harold Washington, Louis A. H. Caldwell, Otis Collins, Kenneth Hall, and Calvin L. Smith and Senators Richard H. Newhouse and Charles Chew Jr., founded the Illinois Legislative Black Caucus; and

WHEREAS, During his tenure in office, Rep. Ewell served in numerous leadership roles, such as chairman of the Illinois House Higher Education Committee, chairman of the Illinois Legislative Black Caucus, and chairman of the National Society of State Legislators; and

WHEREAS, While in office and following his retirement from the Illinois General Assembly, Rep. Ewell was an active member in numerous organizations, including the Federal Public Defender Program, the Cook County Bar Association, the NAACP, the Washington Park Y.M.C.A., the Southtown Y.M.C.A, the Business Men's Association, the St. Carthage Grooming School for Boys, and the Perry Avenue Block Club; and

WHEREAS, Rep. Ewell was preceded in death by his first wife, Joyce Ewell; and

WHEREAS, Rep. Ewell is survived by his wife, Marcia Ewell; his sons, David Raymond, Marc Whitney, Raymond Anthony "Tony", Anthony Romain, and Marcus Alleyne; his grandchildren, Marc Jr., Kareim, Raymond Anthony Jr., Kendall, Drew, Diana, Cameron, and Ala; and his great-grandchildren, Silas, Kai, Aiyanna, and Kree; therefore, be it

#### **HOUSE RESOLUTION 119**

Offered by Representative Evans:

WHEREAS, Over 50 years after Congress passed the Occupational Safety and Health Act (OSHA), promising every worker the right to a safe job, the protections in OSHA have saved hundreds of thousands of lives and prevented millions of workplace injuries; and

WHEREAS, Despite current safety laws, millions of workers are injured and thousands of workers are killed due to job hazards each year; and

WHEREAS, On April 28, 2023, organized labor will observe Workers Memorial Day across the country to remember those who have suffered and died on the job and to renew the fight for safe workplaces for all workers; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare April 28, 2023 as Workers Memorial Day in the State of Illinois; and be it further

RESOLVED, That we recognize that as long as workers are seriously injured or killed on the job, there will be a need to support stronger safety and health laws in our State and country; and be it further

RESOLVED, That we urge the Illinois Congressional Delegation and President Joe Biden to continue to revise, revamp, and strengthen federal workplace safety laws and to properly fund OSHA programs and staff; and be it further

RESOLVED, That we offer our deep-felt sympathy and understanding to the families of workers who have been seriously injured or killed on the job.

#### **HOUSE JOINT RESOLUTION 23**

Offered by Representative Stava-Murray:

WHEREAS, Interstate 55 (I-55) experiences serious congestion daily for extended periods of time and is unable to acclimate to current traffic demands due to limited roadway capacity, roadway design constraints, high truck volumes, and numerous interchanges; and

WHEREAS, Commuters have limited public transit options for their commutes, which has consequently led to increased congestion, long and unreliable travel times, reductions in safety, and increased costs for delivery of goods and services; and

WHEREAS, To improve automobile transportation along the I-55 corridor from the I-355 (Veterans Memorial Tollway) to the I-90/I-94 (Dan Ryan Expressway), the Illinois Department of Transportation (IDOT) initiated the "I-55 Managed Lane Project" to study the advantages of adding managed lanes; and

WHEREAS, A managed lane is a type of highway lane that is administered via a management scheme, such as lane use restrictions or variable tolling, to improve traffic flow, provide commuters with travel options, increase average vehicle occupancy, and support transit ridership; and

WHEREAS, The project assessed implementing two Express Toll Lanes (ETLs) in each direction on the eastern section of the corridor, between I-294 (Central Tri-State Tollway) and the I-90/94; additionally, the section from I-355 to I-294 will have one ETL in each direction; and

WHEREAS, IDOT led this project in partnership with the Federal Highway Administration (FHWA); furthermore, to reach a broad range of stakeholders, the partnership sought input from area residents, municipalities, counties, townships, agencies, elected officials, and interested groups; and

WHEREAS, An environmental study has been completed to meet the National Environmental Policy Act (NEPA) requirements; the NEPA requires federal agencies to analyze the environmental impacts of the proposed actions and requires the evaluation of reasonable alternatives; and

WHEREAS, Phase II, the "Final Design and Contract Plan Preparation," is funded in IDOT's Fiscal Year 2020-2025 Proposed Highway Improvement Program; however, IDOT does not presently have funding for Phase III which is the construction of the project; and

WHEREAS, IDOT is evaluating alternative project delivery opportunities, such as a public-private partnership or P3, to involve industry and best leverage resources for this project; using the P3 method, IDOT can deliver an I-55 project that is the safest, most efficient, and most cost-effective; and

WHEREAS, Under the Public Private Partnership for Transportation Act, IDOT must receive approval from the General Assembly to pursue the project as a P3 and see the project through to completion; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we support the "I-55 Managed Lane Project" and IDOT's efforts to pursue the project as a P3.
