HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE JOINT RESOLUTION 35

Offered by Representative West:

WHEREAS, Subsection (b) of Section 25-10 of the State Officials and Employees Ethics Act (5 ILCS 430/25-10) requires the Legislative Ethics Commission to diligently search for qualified candidates for the Legislative Inspector General position and to make recommendations to the General Assembly, which shall appoint a Legislative Inspector General by joint resolution; and

WHEREAS, Subsection (b) of Section 25-10 further states that the Legislative Inspector General shall be selected solely on the basis of integrity and demonstrated ability and sets forth the necessary educational and employment criteria; and

WHEREAS, The Honorable Michael P. McCuskey was appointed to serve as Legislative Inspector General on February 23, 2022 to complete a 5-year term that expires on June 30, 2023 and has communicated to the Legislative Ethics Commission his willingness to be reappointed to serve as Legislative Inspector General for a 5-year term that begins on July 1, 2023 and ends on June 30, 2028; and

WHEREAS, At its last meeting, the Legislative Ethics Commission unanimously voted to recommend that the General Assembly retain Judge McCuskey as Legislative Inspector General; and

WHEREAS, Judge McCuskey is an individual of high integrity and demonstrated ability who, as a former public defender and judge, has led an exemplary career of public service that more than qualifies him to continue serving as the Legislative Inspector General; and

WHEREAS, A native of Peoria, Judge McCuskey was admitted to the Illinois bar in 1975 and has dedicated his professional life to work that has demonstrated his commitment to integrity, professionalism, and ethics; and

WHEREAS, After serving for over a decade as the chief public defender in Marshall County, Judge McCuskey was elected in 1988 as an Illinois circuit court judge for the Tenth Judicial Circuit; and

WHEREAS, Judge McCuskey was elected to the Illinois Appellate Court for the Third Judicial District in 1990, where he served until 1998; and

WHEREAS, Judge McCuskey was nominated for the United States District Court for the Central District of Illinois by President Bill Clinton and confirmed by a Republican-controlled United States Senate in 1998, serving as Chief Judge of the District from 2004 to 2012; and

WHEREAS, Upon retirement from the federal bench in 2014, Judge McCuskey was appointed by the Illinois Supreme Court to serve again as a State circuit court judge for the Tenth Judicial District, a post to which he was subsequently elected by voters in 2016; and

WHEREAS, Judge McCuskey retired from the court in 2020; and

WHEREAS, Judge McCuskey served on the Illinois Supreme Court's Commission on Professionalism for nearly 15 years, first as a commissioner and then as an advisor until he retired; and

WHEREAS, Judge McCuskey currently serves on the Board of Directors of the Illinois Judges Association and formerly served as Chairman of the Illinois State University Board of Trustees; and

WHEREAS, Judge McCuskey's extensive experience, appointments, and professional activities overwhelmingly qualify him for the position of Legislative Inspector General, an office that necessitates both keen intellect and insight into the personal and professional motivations of persons acting in the public realm; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that we reappoint the Honorable Michael P. McCuskey as Legislative Inspector General in accordance with subsection (b) of Section 25-10 of the State Officials and Employees Ethics Act, endorsing him wholeheartedly as surpassing all statutory requirements and ensuring that his sterling character and dedication to government service will enhance the Office of Legislative Inspector General and benefit the administration of the ethical foundation on which Illinois legislators and legislative employees operate; and be it further

RESOLVED, That, in accordance with subsection (b) of Section 25-10 of the State Officials and Employees Ethics Act, the reappointment of Legislative Inspector General McCuskey takes effect upon the adoption of this joint resolution by the affirmative vote of three-fifths of the members elected to each house of the General Assembly, the certification of this joint resolution by the Speaker of the House of

Representatives and the President of the Senate, and the filing of this joint resolution with the Secretary of State; and be it further

RESOLVED, That, in accordance with subsection (b) of Section 25-10 of the State Officials and Employees Ethics Act, Legislative Inspector General McCuskey's next term as Legislative Inspector General shall commence upon July 1, 2023 and continue through June 30, 2028; and be it further

RESOLVED, That copies of this resolution be delivered to Legislative Inspector General McCuskey and the Legislative Ethics Commission.

INTRODUCTION AND FIRST READING OF BILLS

The following bills were introduced, read by title a first time, ordered reproduced and placed in the Committee on Rules:

HOUSE BILL 4071. Introduced by Representative Guzzardi, AN ACT concerning revenue.

HOUSE BILL 4072. Introduced by Representatives Meier - Yang Rohr - LaPointe - Ness - Elik, Blair-Sherlock, Schmidt, Swanson, Rosenthal, Weaver, Fritts, Frese, Grant and Hauter, AN ACT concerning public aid.

HOUSE BILL 4073. Introduced by Representatives Hammond - Haas, AN ACT concerning education.

HOUSE BILL 4074. Introduced by Representative Costa Howard, AN ACT concerning civil law.

HOUSE BILL 4075. Introduced by Representative Andrade, AN ACT concerning transportation.

HOUSE BILL 4076. Introduced by Representative Lilly, AN ACT concerning public aid.

HOUSE RESOLUTIONS

The following resolutions were offered and placed in the Committee on Rules.

HOUSE RESOLUTION 262

Offered by Representative Flowers:

WHEREAS, Currently, over 860 women die as a result of pregnancy and childbirth-related causes in the United States, and the latest data from 2020 shows that over 80% of the pregnancy-related deaths in the United States are preventable; and

WHEREAS, Illinois had more than 130,000 births in 2020 with 75 pregnancy-associated deaths and 943 infant deaths; and

WHEREAS, Eighty-three percent of the pregnancy-related deaths were deemed preventable in Illinois by review committees; and

WHEREAS, African American women in the United States experience maternal-related deaths at three times the rate of non-Hispanic white women, according to the Mothers and Offspring Mortality and Morbidity Awareness Act, re-introduced by U.S. Representative Robin Kelly of Illinois in February 2021; and

WHEREAS, Non-Hispanic Black women are three times more likely to die of a pregnancy-related condition than non-Hispanic white women in Illinois, according to the 2021 Illinois Department of Public Health Illinois Maternal Morbidity and Mortality Report; and

WHEREAS, Among the top common causes of pregnancy-related deaths in Illinois are mental health conditions, pre-existing chronic conditions, hemorrhage, and hypertensive disorder; and

WHEREAS, Research has shown that, relative to white patients, Black patients are less likely to be given pain medications, and, when pain medication is given, they receive lower quantities; and

WHEREAS, A 2015 study from JAMA Pediatrics found that Black children with appendicitis were less likely to receive pain medication than their white counterparts; and

WHEREAS, A study examining disparities in the triaging of, or assigning a degree of urgency to, pediatric emergency department patients concluded that Black, Hispanic, and Native American patients received lower acuity triage scores than whites when presenting subjective complaints, such as breathing difficulty or abdominal pain; and

WHEREAS, Researchers have also documented an association between race and increased mortality from stroke, and others have found that minority patients are less likely to receive thrombolytics than white patients; and

WHEREAS, A study in the Proceedings of the National Academy of Sciences contributes bias in pain assessment and management of patients partially to the fact that approximately half of medical students and residents believed inaccurate biological differences between Black and white people, including that Black people have less sensitive nerve endings or that a Black person's blood coagulates more quickly, as well as other unconscious biases; and

WHEREAS, Biases in patient assessment and treatment affect the level of care for pregnant women, particularly women of color; and

WHEREAS, Studies have also shown that women are generally less likely to be diagnosed with diseases, such as heart disease, and are less likely to receive aggressive treatment for pain management and certain diseases than men; and

WHEREAS, Due to the vast majority of Illinois births occurring in hospitals, hospitals play an important role in addressing maternal mortality; and

WHEREAS, The Illinois Department of Public Health currently works with the Maternal Mortality Review Committee and the Maternal Mortality Review Committee for Violent Deaths to review cases of maternal death and to develop statewide recommendations to prevent future maternal deaths; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that Illinois hospitals should be required to report instances of preterm birth, infant mortality, and maternal mortality within reporting under the Hospital Report Card Act, including racial and ethnic information about the mother and the disparity of these occurrences across racial and ethnic groups; and be it further

RESOLVED, That the Illinois Department of Public Health is urged to work with the review committees to implement policy and corrective actions to address causes of preventable maternal death.

HOUSE RESOLUTION 268

Offered by Representative Bunting:

WHEREAS, The latest data from the U.S. Bureau of Labor Statistics shows the agriculture sector is one of the most dangerous in the United States; and

WHEREAS, Each year, the farming profession sees over 500 fatalities nationwide; and

WHEREAS, According to the Occupational Safety and Health Administration (OSHA), most farm-related injuries and deaths are caused by tractor overturns, which result in approximately 130 deaths each year nationwide on average; and

WHEREAS, Additional injuries and deaths stem from grain storage facilities, which can be especially risky; and

WHEREAS, Farm safety extends to members of the public as well; while sharing the road with farm vehicles, visibility is key to safety on the roads; drivers should remember that farm vehicle operators have limited visibility to the rear, and anyone passing such a vehicle should use extreme caution; and

WHEREAS, It is important to bring awareness not only to the physical dangers of farming but to the emotional toll it takes on the farming community as well; while we highlight confined spaces safety, roadway safety, and other traditional farming hazards, it is also important to encourage farmers to take care of their own health; and

WHEREAS, As we enter the farming season, it is more important than ever to follow best practices to safeguard farmers and farm workers; now is the time to remind employers and farm workers to put safety first; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare September 17 through September 23, 2023 as Farm Safety Week in the State of Illinois.
