Offered by Representative Stephens:

HOUSE RESOLUTION 595

Offered by Representative Stuart:

WHEREAS, February is nationally recognized as Career and Technical Education (CTE) Month; and WHEREAS, CTE's origins stem from the signing of the Smith-Hughes Vocation Education Act of 1917, which was the first major federal investment in CTE and laid the foundation for bipartisan, bicameral support for CTE that continues today through the Strengthening Career and Technical Education for 21st Act, and February 23, 2024 marks the 107th anniversary of the Smith-Hughes Vocational Education Act being signed into law; and

WHEREAS, Approximately 382,383 secondary and postsecondary students are enrolled in CTE across the State of Illinois; and

WHEREAS, CTE in Illinois places equity at the forefront of decision-making, instructional programming, and student support services, and it is instrumental in ensuring fair and equal access to learning opportunities, supporting local communities, fostering innovation, and promoting continuous improvement; and

WHEREAS, CTE programs lead in supplying instruction for careers in high-wage, high-skill, and in-demand occupations in a number of fields, including agriculture, health care, business and finance, information technology, advanced manufacturing, and education; and

WHEREAS, CTE programs provide relevant academic and technical coursework, leading to college credits and industry-recognized credentials for secondary and postsecondary learners; these programs also offer smooth pathways to and through postsecondary education and employment, career exploration for grades K-12, and assistance in meeting the Illinois Learning Standards; and

WHEREAS, CTE prepares students for tomorrow's careers and drives economic growth by matching employability skills with workforce demand, embedding work-based learning opportunities, and allowing for local flexibility; and

WHEREAS, All students benefit from equity-centered teaching practices, career-connected learning, opportunities to develop and discover practical skills and strengths, and career exploration; and

WHEREAS, CTE programs will play a critical role in becoming the largest training provider for Electric Vehicle Technology, thereby bolstering, supporting, and delivering Governor JB Pritzker's goal for the State of Illinois to reach 100% clean energy by 2050; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the month of February 2024 as Career and Technical Education Month in the State of Illinois.

HOUSE RESOLUTION 596

Offered by Representative Stuart:

WHEREAS, Adjuncts/non-tenure/part-time instructors in institutions of higher education are not treated, respected, nor valued the same as full-time instructors; and

WHEREAS, Adjuncts/non-tenure/part-time instructors in institutions of higher education are not valued the same as full-time instructors but have the same credentials; and

WHEREAS, Adjuncts/non-tenure/part-time instructors in institutions of higher education teach a majority of all courses offered; and

WHEREAS, Adjuncts/non-tenure/part-time instructors in institutions of higher education are expected to teach the same material and are held to the same standards as full-time instructors; and

WHEREAS, Currently, all part-time/contingent/adjunct Illinois public teachers, librarians, counselors, and educational support personnel are not equitably compensated, have no access to health benefits, and lack full and fair pension reporting and accountability; and

WHEREAS, Student learning is directly related to part-time/contingent/adjunct working conditions; it follows that college and university student learning is negatively impacted by the inequities and unfairness embedded in the system of higher education; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge that adjuncts/non-tenure/part-time instructors in institutions of higher education be treated with the same respect, recognition, value, and standards as full-time instructors and no longer be second class citizens within the ranks of higher education professionals as has been the practice within these institutions of higher learning; and be it further

RESOLVED, That we affirm that these professionals, who have the same credentials as the full-time instructors, are being underpaid to do the same job; and be it further

RESOLVED, That we pledge to seek solutions that include, but are not limited to, legislated salary parity, mandated access to health benefits, and full and fair pension reporting and accountability for all part-time/contingent/adjunct Illinois public teachers, librarians, counselors, and educational support personnel; and be it further

RESOLVED, That a suitable copy of this resolution be delivered to the Higher Education Council of the Illinois Education Association.

HOUSE RESOLUTION 599

Offered by Representative Lilly:

WHEREAS, The Illinois High School Association (IHSA) currently has the authority to restrict eligible student-athletes from transferring schools, and a policy change is being sought to eliminate IHSA's authority on this matter; this policy change would prioritize academic and jurisdictional requirements as the sole determinants of eligibility; and

WHEREAS, By focusing on objective criteria such as academic standing and school location, this new policy intends to minimize bureaucratic hurdles for transferring student-athletes by aiming to streamline the transfer process and reduce unnecessary delays or complications; and

WHEREAS, Abolishing IHSA's current discretionary power over transfers will reduce the potential for subjective or biased decisions that unfairly disadvantage certain student-athletes; and

WHEREAS, Through terminating transfer restrictions, these talented student-athletes are empowered with greater autonomy, agency, and flexibility in choosing the best educational and athletic paths for

themselves based on their individual needs and aspirations, thereby fostering personal growth and development; and

WHEREAS, Removing arbitrary limitations on transfer numbers will mirror the recent National Collegiate Athletic Association (NCAA) rule change that Illinois initially opposed; in following the NCAA's lead on transfer rules, Illinois will become more aligned with national trends as this policy change will also encourage consistency and simplify the landscape for student-athletes navigating both high school and collegiate athletics; and

WHEREAS, By eliminating unnecessary restrictions and prioritizing student-athlete agency, this policy change aims to create a more equitable and flexible system for student-athletes in Illinois, allowing them to pursue their educational and athletic goals without undue obstacles; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we urge the elimination of the Illinois High School Association's (IHSA) authority to restrict eligible student-athletes from transferring schools; and be it further

RESOLVED, That a suitable copy be delivered to the Illinois High School Association.

HOUSE RESOLUTION 600

Offered by Representative Fritts:

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that the Rules of the House of Representatives of the 103rd General Assembly are amended by changing Rule 30 as follows:

(House Rule 30)

- 30. Access to the House Floor and Chamber.
- (a) Except as otherwise provided in these Rules, only the following persons shall be admitted to the House while it is in session: members and officers of the General Assembly; elected officers of the executive branch; justices of the Supreme Court; the designated aide to an executive or judicial branch constitutional officer, except as limited by the Speaker; the parliamentarian; majority staff members and minority staff members, except as limited by the Speaker or Presiding Officer; former members, except as limited by the Speaker or prohibited under subsection (d); and employees of the Legislative Reference Bureau, except as limited by the Speaker. Representatives of the press, while the House is in session, may have access to the galleries and places allotted to them by the Speaker or his or her designee. No person is entitled to the floor unless appropriately attired. Only members of the General Assembly may use telephones at the members' desks. Smoking is prohibited on the floor of the House and in the House galleries.
- (a-5) On any day in which the House is in session following a declaration of pestilence or public danger by the Speaker, the Speaker, after consultation with the Minority Leader, may limit access to the House Chamber and adjoining hallways and passages to members and officers of the General Assembly, majority and minority staff as authorized by the Speaker or Presiding Officer, and no more than 5 members of the public who are representatives of the press, except as otherwise authorized by the Speaker. If access is so limited, the Speaker may designate one or more locations outside of the House Chamber for the public to safely watch and listen to the proceedings of the House and its committees via a live audio/video broadcast. Access to such locations may be limited as necessary to maintain safety, including, but not limited to, requiring that persons at such locations follow the decorum protocols of Rule 51.5(a). This subsection may not be suspended.
- (b) On days during which the House is in session, the Doorkeeper shall clear the floor of all persons not entitled to access to the floor 15 minutes before the convening time, and the Doorkeeper shall enforce all other provisions of this Rule.
- (c) The Speaker may authorize the admission to the floor of any other person, except as prohibited under subsection (d).
- (d) No person who is directly or indirectly interested in defeating or promoting any pending legislative measure, if required to be registered as a lobbyist or compensated by an entity required to register as a lobbyist, shall be allowed access to the floor of the House at any time during the session. The Speaker, or

his or her designee, shall have the authority to determine whether a person may be granted or denied access in accordance with this subsection.

- (e) When he or she deems it necessary for the preservation of order, the Presiding Officer may by order remove any person from the floor of the House. A Representative may be removed from the floor only under Rule 51.5 or Article XI or XII of these Rules.
- (f) Notwithstanding any other provision of these House Rules, a Representative may access the House Chamber at any time on a session day and during the normal business hours of the Office of the Clerk of the House on any other day.
