WHEREAS, The symptoms of cerebral palsy vary greatly from individual to individual, and 75% of individuals with cerebral palsy also have one or more developmental disabilities, including epilepsy, intellectual disability, autism, visual impairment, or blindness; and

WHEREAS, Cerebral palsy is the most common motor disability in children; according to the Centers for Disease Control and Prevention (CDC), approximately 1 in 345 children in the United States have been diagnosed with cerebral palsy; and

WHEREAS, In 2006, National Cerebral Palsy Awareness Month was established by Reaching for the Stars (RFTS), a non-profit educational advocacy group led by parent volunteers under the guidance of the Cerebral Palsy Foundation; the observance is held annually in March to provide an educational opportunity for those outside the cerebral palsy community to learn about the condition and about life with cerebral palsy; and

WHEREAS, National Cerebral Palsy Awareness Month further encourages individuals to consider ways to be more inclusive towards those who live with the condition; most importantly, the observance allows people to learn how they can become long-term allies of the cerebral palsy community; and

WHEREAS, National Cerebral Palsy Awareness Day is also observed every year on March 25th; therefore, be it

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, that we declare the month of March 2024 as Cerebral Palsy Awareness Month in the State of Illinois; and be it further

RESOLVED, That suitable copies of this resolution be presented to the Cerebral Palsy Foundation and United Cerebral Palsy with our sincere appreciation for their efforts.

HOUSE JOINT RESOLUTIONS CONSTITUTIONAL AMENDMENTS FIRST READING

HOUSE JOINT RESOLUTION CONSTITUTIONAL AMENDMENT 19

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Section 3 of Article XIV of the Illinois Constitution as follows:

ARTICLE XIV CONSTITUTIONAL REVISION

(ILCON Art. XIV, Sec. 3)
SECTION 3. CONSTITUTIONAL INITIATIVE FOR LEGISLATIVE ARTICLE AND STATEMENTS OF ECONOMIC INTERESTS

Amendments to Article IV or Section 2 of Article XIII of this Constitution may be proposed by a petition signed by a number of electors equal in number to at least eight percent of the total votes cast for candidates for Governor in the preceding gubernatorial election. Amendments to Article IV shall be limited to structural and procedural subjects contained in Article IV. Amendments to Section 2 of Article XIII shall be limited to establishing and enforcing stronger ethical standards for candidates for or office holders of: (i) State office; (ii) offices in units of local government and school districts; and (iii) a position on a commission or board created by this Constitution. A petition shall contain the text of the proposed amendment and the date of the general election at which the proposed amendment is to be submitted, shall have been signed by the petitioning electors not more than twenty-four months preceding that general election and shall be filed with the Secretary of State at least six months before that general election. The procedure for determining the validity and sufficiency of a petition shall be provided by law. If the petition

is valid and sufficient, the proposed amendment shall be submitted to the electors at that general election and shall become effective if approved by either three-fifths of those voting on the amendment or a majority of those voting in the election.
