WHEREAS, LCpl Maher was awarded numerous citations for his service, including the Marine Rifle Sharpshooter Badge, the National Defense Service Medal, the Navy and Marine Corps Achievement Medal, the Global War on Terrorism Service Medal, the Global War on Terrorism Expeditionary Medal, the Armed

Forces Expeditionary Medal; posthumously, he received the AIA Hawaii Medal of Honor, the Purple Heart, and the Navy and Marine Corps Achievement Medal; and

WHEREAS, LCpl Maher was named an honorary member of Lake Villa VFW Post 4308; therefore, be it
