We would like these hearings to be held throughout the state in Northern, Central, and Southern Illinois, beginning in the City of Chicago. Nearly every House Member who signed this letter has either been to the border, or been to the City of Chicago itself, or both since the first of the year. We've seen this crisis first hand. We have heard from the people in minority communities in Chicago. They are absolutely fed up with their communities being overrun and their social programs being overtaken by illegal immigrants. Additionally, communities all across the state are concerned about the potential spread of this crisis downstate as a result of our sanctuary state status and the Chicago sanctuary city status. The taxpayers of Illinois are watching hundreds of millions of their tax dollars being spent on illegal immigrants flooding into our state with zero accountability. They are watching their communities become less safe, their social programs dry up, their hospitals and health systems begin to get clogged up, and so the list goes on and on. We, the General Assembly, are responsible for allocating funding to these programs. WHEREAS, The members of the Illinois House of Representatives wish to congratulate Charles Randall "Chuck" Melton II on the occasion of his serving as a member of Team USA Wheelchair Rugby for a decade and being team captain for six years; and WHEREAS, Chuck Melton moved to Hoyleton in May 2001 and worked at Nascote Industries, providing industrial cleaning services within the automotive plant; and

WHEREAS, Chuck Melton suffered a life-altering accident in 2002, severing his spinal cord and losing the use of his legs and partial use of his hands, while a father of two young children with a third on the way; and

WHEREAS, Chuck Melton attended Kaskaskia College and became involved in many organizations that promote physical activity for individuals with physical limitations, including Paraquad, which champions equity and independence for people with disabilities through services, partnerships, education, and advocacy, and the Disabled Athlete Sports Association, which empowers individuals with physical disabilities to find their inner athlete through adaptive sports and fitness; his early experiences with these groups provided him with structure and strength after his accident, teaching him many life lessons; and

WHEREAS, After being introduced to the sport of wheelchair rugby, Chuck Melton spent many years and many long hours

- training with his family by his side; he played for the St. Louis wheelchair rugby team, the Spartans, for five years before deciding to advance to the national level; and
- WHEREAS, Chuck Melton served on the developmental team in 2011 before being invited to try out for the US National Wheelchair Rugby team, defying all odds when he was named to the team after his first attempt in 2012; and
- WHEREAS, Chuck Melton made the 16-player roster on Team USA in 2012 but was not selected for the 12-person roster for the London 2012 Paralympic Games; and
- WHEREAS, Chuck Melton continued to diligently train and hone his skills while dedicating his attention to leading others who had suffered life-altering injuries; through great determination and a positive attitude, he strove to represent his nation as a member of Team USA, and he proceeded to be selected by his peers to serve as captain from 2017 through 2023; and
- WHEREAS, While representing Team USA for a decade, Chuck Melton has accumulated many medals and honors over the course his athletic career; and
- WHEREAS, Chuck Melton played in both the Rio 2016 Paralympic Games and Tokyo 2020 Paralympic Games, earning a silver medal in both tournaments; and
- WHEREAS, Chuck Melton also earned a gold medal in the 2019 Parapan American Games in Lima, Peru, and he has played in three World Championship tournaments, Denmark 2014, Australia 2018, and Denmark 2022, where he earned two bronze medals and a silver medal for the US National team, respectively; and

I also want to acknowledge our organizations that are here for today also for the National HIV and AIDS Awareness Day, which is observed first 25 years ago in the State of Illinois. I rise today to celebrate Black History Month and to recognize the contributions of Jane Bolin, a trailblazer in American criminal justice and the first black woman to serve as a judge in the United States. You know I love to bring the joy, and y'all, she is joyful. She was born and raised in New York in 1908. And despite being an excellent student throughout high school and college, she often faced headwinds due to her race and gender. In 1932, she overcame these challenges to become the first black woman to graduate from Yale Law School and

pass the New York State Bar Exam. It's a really hard thing to do. I don't if any of you've tried. It's really hard. For years, she rose through the ranks of New York law and politics, again, facing unique obstacles every step of the way. However, at just age 31, New York Mayor Fiorello La Guardia appointed her a judge of the domestic relations court, and she became the only black female judge in the country. During her 40 years as a judge, Bolin fought for racially integrated child services throughout the country and other equity reforms. While her racial accomplishments are substantial, she has also gifted us with lessons that we can use to continue her progress ourselves. Bolin often expressed the sentiment that coming in first or second, or even last, wasn't something that concerned her. Her work, like our work, concerned her. The work that she did. The work that we do was developing a fairer justice system and fairer child care system for people of color. Whatever you have chosen your work to be. Whether that is bolstering racial equity, revamping education, improving human rights, or any of the other great causes we pursue as lawmakers, the lesson is the same. Jockeying for position and competing for plaudits is not what matters. Y'all, I need you to hear me when I say this. Our work matters. Thank you, Madam Speaker."

RESOLVED, BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED THIRD GENERAL ASSEMBLY OF THE STATE OF ILLINOIS, THE SENATE CONCURRING HEREIN, that there shall be submitted to the electors of the State for adoption or rejection at the general election next occurring at least 6 months after the adoption of this resolution a proposition to amend Article XIV of the Illinois Constitution by changing Section 3 as follows:

ARTICLE XIV

CONSTITUTIONAL REVISION

Amendments to Article IV of this Constitution may be proposed by a petition signed by a number of electors equal in number to at least eight percent of the total votes cast for candidates for Governor in the preceding gubernatorial election. A petition shall contain the text of the proposed amendment and the date of the general election at which the proposed amendment is to be submitted, shall have been signed by the petitioning electors not more than twenty-four months preceding that general election and shall be filed with the Secretary of State at least six months before that general election. The procedure for determining the validity and sufficiency of a petition shall be provided by law. If the petition is valid and sufficient, the proposed amendment

shall be submitted to the electors at that general election and shall become effective if approved by either three-fifths of those voting on the amendment or a majority of those voting in the election.

SCHEDULE

This Constitutional Amendment takes effect upon being declared adopted in accordance with Section 7 of the Illinois Constitutional Amendment Act. This was First Reading in full of House Joint Resolution Constitutional Amendment #18. There being no further business, the House Perfunctory Session will stand adjourned."
