(a) Prior to permitting an individual to act as a TNC driver on its digital platform, the TNC shall: 10 (1) require the individual to submit an application to 11 the TNC or a third party on behalf of the TNC, which 12 includes information regarding his or her full legal name, 13 social security number, address, age, date of birth, 14 15 driver's license, driving history, motor vehicle

registration, automobile liability insurance, and other

2	(2) conduct, or have a third party conduct, a local and
3	national criminal history background check for each
4	individual applicant that shall include:
5	(A) Multi-State or Multi-Jurisdictional Criminal
6	Records Locator or other similar commercial nationwide
7	database with validation (primary source search); and
8	(B) National Sex Offenders Registry database; and
9	(3) obtain and review a driving history research report
10	for the individual.
11	(b) The TNC shall not permit an individual to act as a TNC
12	driver on its digital platform who:
13	(1) has had more than 3 moving violations in the prior
14	three-year period, or one major violation in the prior
15	three-year period including, but not limited to,
16	attempting to evade the police, reckless driving, or
17	driving on a suspended or revoked license;
18	(2) has been convicted, within the past 7 years, of
19	driving under the influence of drugs or alcohol, fraud,
20	sexual offenses, use of a motor vehicle to commit a felony,
21	a crime involving property damage, or theft, acts of
22	violence, or acts of terror;
23	(3) is a match in the National Sex Offenders Registry
24	database;

(4) does not possess a valid driver's license;

(5) does not possess proof of registration for the

- 1 motor vehicle used to provide TNC services;
- 2 (6) does not possess proof of automobile liability
- insurance for the motor vehicle used to provide TNC 3
- 4 services; or
- 5 (7) is under 19 years of age.
- 6 (c) An individual who submits an application under
- paragraph (1) of subsection (a) that contains false or 7
- incomplete information shall be guilty of a petty offense. 8
- (d) A TNC that reasonably relies on the information 9
- 10 provided by an individual under this Section shall not be
- 11 liable for a violation of this Section.
