- 5 WHEREAS, Judge Goldenhersh was elected to the Illinois 6 Appellate Court, Fifth District, in 1988 and assumed office in 7 December of that year; he has twice been Presiding Judge of the 8 District; prior to appellate service, he was a circuit judge, 9 St. Clair County, 20th Judicial Circuit, from 1982 to 1988, an 10 Associate Judge in St. Clair County from 1975 to 1982, and in 11 the private practice of law; he attended Washington University, receiving his A.B. degree in 1966, his J.D. in 1969, and his 12
- 13 LL.Min in Judicial Process from the University of Virginia in
- 14 2001; and

15 WHEREAS, Judge Goldenhersh is a past president of the 16 Illinois Judges Association and past co-chair of Association's Judicial Selection and Retention Committee; he 17 is also a member of the Illinois State Bar Association, a past 18 19 chair of the Civil Practice and Procedure Section Council, on 20 which he currently serves, a past member and chair of the Board of Regents, and also a current member of the Bench and Bar 21 22 Section Council; he previously has been a member of the 23 Administrative Committee of the Appellate Court, chair of the

- 1 Associate Judge's Coordinating Committee, member of the
- 2 Supreme Court Committee on Complex Litigation, and member of
- 3 the St. Clair County Constitution Bicentennial Committee; and
- 4 WHEREAS, Judge Goldenhersh has also been a speaker and
- 5 instructor for the Illinois Judicial Conference, the Illinois
- 6 Trial Lawyer's Association, the Association of Teacher
- 7 Educators, and the National Association of Administrative Law
- 8 Judges; he has spoken at teacher's conferences in Illinois and
- 9 Missouri and taught at McKendree College, Webster University,
- and St. Louis University School of Law; and
- 11 WHEREAS, Judge Goldenhersh's community activities, past
- 12 and present, include the boards of the Washington University
- 13 Law School Alumni Association, the Jewish Federation of
- 14 Southern Illinois, the St. Louis Committee on Foreign
- 15 Relations, the Jewish Judge's Association of Illinois, the
- 16 Advisory Committee for the paralegal program at Southwestern
- 17 Illinois College, and the Ehlers-Danlos National Foundation;
- 18 he has also spoken before numerous civic organizations and
- 19 classes and participated in moot court competitions at Southern
- 20 Illinois University Law School, Washington University Law
- 21 School, and John Marshall Law School; and
- 22 WHEREAS, Judge Goldenhersh was married to the late Barbara
- 23 Goldenhersh, Ph.D.; they have two children, Andrew, a

- 1 professional magician in Los Angeles, and Stephanie, a clinical
- 2 instructor and senior attorney at Harvard's Legal Aid Bureau,
- 3 and two grandchildren, Jacy and Dylan; therefore, be it
