2 AMENDMENT NO. \_\_\_\_\_. Amend Senate Bill 867 by replacing  
3 everything after the enacting clause with the following:

4 "Section 5. The Limited Liability Company Act is amended by  
5 changing Section 50-10 as follows:

7 (Text of Section before amendment by P.A. 99-637)

8 Sec. 50-10. Fees.

9 (a) The Secretary of State shall charge and collect in  
10 accordance with the provisions of this Act and rules  
11 promulgated under its authority all of the following:

12 (1) Fees for filing documents.

13 (2) Miscellaneous charges.

14 (3) Fees for the sale of lists of filings and for  
15 copies of any documents.

16 (b) The Secretary of State shall charge and collect for all

1 of the following:

2 (1) Filing articles of organization (domestic),  
3 application for admission (foreign), and restated articles  
4 of organization (domestic), \$150 ~~\$500~~. Notwithstanding the  
5 foregoing, the fee for filing articles of organization  
6 (domestic), application for admission (foreign), and  
7 restated articles of organization (domestic) in connection  
8 with a limited liability company with ability to establish  
9 series pursuant to Section 37-40 of this Act is \$400 ~~\$750~~.

10 (2) Filing articles of amendment or an amended  
11 application for admission, \$50 ~~\$150~~.

12 (3) Filing articles of dissolution or application for  
13 withdrawal, \$5 ~~\$100~~.

14 (4) Filing an application to reserve a name, \$25 ~~\$300~~.

15 (5) Filing a notice of cancellation of a reserved name,  
16 \$5 ~~\$100~~.

17 (6) Filing a notice of a transfer of a reserved name,  
18 \$25 ~~\$100~~.

19 (7) Registration of a name, \$50 ~~\$300~~.

20 (8) Renewal of registration of a name, \$50 ~~\$100~~.

21 (9) Filing an application for use of an assumed name  
22 under Section 1-20 of this Act, \$150 for each year or part  
23 thereof ending in 0 or 5, \$120 for each year or part  
24 thereof ending in 1 or 6, \$90 for each year or part thereof  
25 ending in 2 or 7, \$60 for each year or part thereof ending  
26 in 3 or 8, \$30 for each year or part thereof ending in 4 or

1 9, and a renewal for each assumed name, \$150.

2 (9.5) Filing an application for change of an assumed  
3 name, \$25.

4 (10) Filing an application for ~~change or~~ cancellation  
5 of an assumed name, \$5 ~~\$100~~.

6 (11) Filing an annual report of a limited liability  
7 company or foreign limited liability company, \$75 ~~\$250~~, if  
8 filed as required by this Act, plus a penalty if  
9 delinquent. Notwithstanding the foregoing, the fee for  
10 filing an annual report of a limited liability company or  
11 foreign limited liability company with ability to  
12 establish series is \$75 ~~\$250~~ plus \$50 for each series for  
13 which a certificate of designation has been filed pursuant  
14 to Section 37-40 of this Act and active on the last day of  
15 the third month preceding the company's anniversary month,  
16 plus a penalty if delinquent.

17 (12) Filing an application for reinstatement of a  
18 limited liability company or foreign limited liability  
19 company \$200 ~~\$500~~.

20 (13) Filing Articles of Merger, \$100 plus \$50 for each  
21 party to the merger in excess of the first 2 parties.

22 (14) Filing an Agreement of Conversion or Statement of  
23 Conversion, \$100.

24 (15) Filing a statement of change of address of  
25 registered office or change of registered agent, or both,  
26 or filing a statement of correction, \$25.

1 (16) Filing a petition for refund, \$5 ~~\$15~~.

2 (17) Filing any other document, \$5 ~~\$100~~.

3 (18) Filing a certificate of designation of a limited  
4 liability company with the ability to establish series  
5 pursuant to Section 37-40 of this Act, \$50.

6 (c) The Secretary of State shall charge and collect all of  
7 the following:

8 (1) For furnishing a copy or certified copy of any  
9 document, instrument, or paper relating to a limited  
10 liability company or foreign limited liability company, or  
11 for a certificate, \$25.

12 (2) For the transfer of information by computer process  
13 media to any purchaser, fees established by rule.

17 (a) The Secretary of State shall charge and collect in  
18 accordance with the provisions of this Act and rules  
19 promulgated under its authority all of the following:

23 copies of any documents.

24 (b) The Secretary of State shall charge and collect for all

12 for withdrawal, \$5 ~~\$25~~.

13 (4) Filing an application to reserve a name, \$25 ~~\$300~~.

14 (5) Filing a notice of cancellation of a reserved name,  
15 \$5 ~~\$100~~.

16 (6) Filing a notice of a transfer of a reserved name,  
17 \$25 ~~\$100~~.

18 (7) Registration of a name, \$50 ~~\$300~~.

19 (8) Renewal of registration of a name, \$50 ~~\$100~~.

20 (9) Filing an application for use of an assumed name  
21 under Section 1-20 of this Act, \$150 for each year or part  
22 thereof ending in 0 or 5, \$120 for each year or part  
23 thereof ending in 1 or 6, \$90 for each year or part thereof

7           filed as required by this Act, plus a penalty if  
8           delinquent. Notwithstanding the foregoing, the fee for  
9           filing an annual report of a limited liability company or  
10          foreign limited liability company is \$75 ~~\$250~~ plus \$50 for  
11          each series for which a certificate of designation has been  
12          filed pursuant to Section 37-40 of this Act and is in  
13          effect on the last day of the third month preceding the  
14          company's anniversary month, plus a penalty if delinquent.

15          (12) Filing an application for reinstatement of a  
16          limited liability company or foreign limited liability  
17          company \$200 ~~\$500~~.

18          (13) Filing articles of merger, \$100 plus \$50 for each  
19          party to the merger in excess of the first 2 parties.

20          (14) Filing articles of conversion, \$100.

21          (15) Filing a statement of change of address of  
22          registered office or change of registered agent, or both,  
23          or filing a statement of correction, \$25.

24          (16) Filing a petition for refund, \$5 ~~\$15~~.

25          (17) Filing a certificate of designation of a limited  
26          liability company with a series pursuant to Section 37-40

2 (18) Filing articles of domestication, \$100.

3 (19) Filing, amending, or cancelling a statement of
