SYNOPSIS AS INTRODUCED:

20 ILCS 3305/5

from Ch. 127, par. 1055

Amends the Illinois Emergency Management Agency Act. Provides that the Illinois Emergency Management Agency may by rule assess and collect reasonable fees for attendance at Agency-sponsored conferences and trainings to enable the Agency to carry out the requirements of the Act. Provides that any moneys received from these fees shall be deposited in the Emergency Planning and Training Fund and used by the Agency, subject to appropriation, for planning and training activities.

A BILL FOR

1 AN ACT concerning safety.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

- Section 5. The Illinois Emergency Management Agency Act is
 amended by changing Section 5 as follows:
- 6 (20 ILCS 3305/5) (from Ch. 127, par. 1055)

Sec. 5. Illinois Emergency Management Agency.

(a) There is created within the executive branch of the 8 9 State Government an Illinois Emergency Management Agency and a Director of the Illinois Emergency Management Agency, herein 10 called the "Director" who shall be the head thereof. The 11 12 Director shall be appointed by the Governor, with the advice and consent of the Senate, and shall serve for a term of 2 13 14 years beginning on the third Monday in January of the odd-numbered year, and until a successor is appointed and has 15 16 qualified; except that the term of the first Director appointed under this Act shall expire on the third Monday in January, 17 1989. The Director shall not hold any other remunerative public 18 19 office. The Director shall receive an annual salary as set by 20 the Compensation Review Board.

(b) The Illinois Emergency Management Agency shall obtain,
 under the provisions of the Personnel Code, technical,
 clerical, stenographic and other administrative personnel, and

1 may make expenditures within the appropriation therefor as may 2 be necessary to carry out the purpose of this Act. The agency 3 created by this Act is intended to be a successor to the agency 4 created under the Illinois Emergency Services and Disaster 5 Agency Act of 1975 and the personnel, equipment, records, and 6 appropriations of that agency are transferred to the successor 7 agency as of the effective date of this Act.

8 (c) The Director, subject to the direction and control of 9 the Governor, shall be the executive head of the Illinois 10 Emergency Management Agency and the State Emergency Response 11 Commission and shall be responsible under the direction of the 12 Governor, for carrying out the program for emergency management 13 of this State. The Director shall also maintain liaison and 14 cooperate with the emergency management organizations of this 15 State and other states and of the federal government.

16 (d) The Illinois Emergency Management Agency shall take an 17 integral part in the development and revision of political subdivision emergency operations plans 18 prepared under paragraph (f) of Section 10. To this end it shall employ or 19 20 otherwise secure the services of professional and technical 21 personnel capable of providing expert assistance to the 22 emergency services and disaster agencies. These personnel 23 shall consult with emergency services and disaster agencies on a regular basis and shall make field examinations of the areas, 24 25 circumstances, and conditions that particular political 26 subdivision emergency operations plans are intended to apply.

1 (e) The Illinois Emergency Management Agency and political 2 subdivisions shall be encouraged to form an emergency 3 management advisory committee composed of private and public personnel representing the emergency management phases of 4 5 mitigation, preparedness, response, and recovery. The Local 6 Emergency Planning Committee, as created under the Illinois 7 Emergency Planning and Community Right to Know Act, shall serve 8 as an advisory committee to the emergency services and disaster 9 agency or agencies serving within the boundaries of that Local 10 Emergency Planning Committee planning district for:

(1) the development of emergency operations plan
 provisions for hazardous chemical emergencies; and

13 (2) the assessment of emergency response capabilities
 14 related to hazardous chemical emergencies.

15 (f) The Illinois Emergency Management Agency shall:

16 (1) Coordinate the overall emergency management17 program of the State.

(2) Cooperate with local governments, the federal
government and any public or private agency or entity in
achieving any purpose of this Act and in implementing
emergency management programs for mitigation,
preparedness, response, and recovery.

(2.5) Develop a comprehensive emergency preparedness
and response plan for any nuclear accident in accordance
with Section 65 of the Department of Nuclear Safety Law of
2004 (20 ILCS 3310) and in development of the Illinois

1 2 Nuclear Safety Preparedness program in accordance with Section 8 of the Illinois Nuclear Safety Preparedness Act.

3 (2.6) Coordinate with the Department of Public Health
4 with respect to planning for and responding to public
5 health emergencies.

6 (3) Prepare, for issuance by the Governor, executive 7 orders, proclamations, and regulations as necessary or 8 appropriate in coping with disasters.

9 (4) Promulgate rules and requirements for political 10 subdivision emergency operations plans that are not 11 inconsistent with and are at least as stringent as 12 applicable federal laws and regulations.

13 (5) Review and approve, in accordance with Illinois 14 Emergency Management Agency rules, emergency operations 15 plans for those political subdivisions required to have an 16 emergency services and disaster agency pursuant to this 17 Act.

18 (5.5) Promulgate rules and requirements for the 19 political subdivision emergency management exercises, 20 including, but not limited to, exercises of the emergency 21 operations plans.

(5.10) Review, evaluate, and approve, in accordance
with Illinois Emergency Management Agency rules, political
subdivision emergency management exercises for those
political subdivisions required to have an emergency
services and disaster agency pursuant to this Act.

(6) Determine requirements of the State and its
 political subdivisions for food, clothing, and other
 necessities in event of a disaster.

4 (7) Establish a register of persons with types of
5 emergency management training and skills in mitigation,
6 preparedness, response, and recovery.

7 (8) Establish a register of government and private
8 response resources available for use in a disaster.

9 (9) Expand the Earthquake Awareness Program and its 10 efforts to distribute earthquake preparedness materials to 11 schools, political subdivisions, community groups, civic 12 organizations, and the media. Emphasis will be placed on 13 those areas of the State most at risk from an earthquake. 14 Maintain the list of all school districts, hospitals, 15 airports, power plants, including nuclear power plants, 16 lakes, dams, emergency response facilities of all types, 17 and all other major public or private structures which are at the greatest risk of damage from earthquakes under 18 19 circumstances where the damage would cause subsequent harm 20 to the surrounding communities and residents.

(10) Disseminate all information, completely and without delay, on water levels for rivers and streams and any other data pertaining to potential flooding supplied by the Division of Water Resources within the Department of Natural Resources to all political subdivisions to the maximum extent possible.

(11) Develop agreements, if feasible, with medical 1 2 supply and equipment firms to supply resources as are 3 necessary to respond to an earthquake or any other disaster as defined in this Act. These resources will be made 4 5 available upon notifying the vendor of the disaster. Payment for the resources will be in accordance with 6 7 Section 7 of this Act. The Illinois Department of Public 8 Health shall determine which resources will be required and 9 requested.

10 (11.5) In coordination with the Department of State 11 Police, develop and implement a community outreach program 12 to promote awareness among the State's parents and children 13 of child abduction prevention and response.

14 (12) Out of funds appropriated for these purposes, 15 award capital and non-capital grants to Illinois hospitals 16 or health care facilities located outside of a city with a 17 population in excess of 1,000,000 to be used for purposes that include, but are not limited to, preparing to respond 18 19 mass casualties and disasters, maintaining to and 20 improving patient safety and quality of care, and 21 protecting the confidentiality of patient information. No 22 single grant for a capital expenditure shall exceed 23 \$300,000. No single grant for a non-capital expenditure shall exceed \$100,000. In awarding such grants, preference 24 25 shall be given to hospitals that serve a significant number 26 of Medicaid recipients, but do not qualify for

disproportionate share hospital adjustment payments under 1 2 the Illinois Public Aid Code. To receive such a grant, a 3 hospital or health care facility must provide funding of at least 50% of the cost of the project for which the grant is 4 5 being requested. In awarding such grants the Illinois 6 Emergency Management Agency shall consider the 7 recommendations of the Illinois Hospital Association.

8 (13) Do all other things necessary, incidental or 9 appropriate for the implementation of this Act.

10 (q) The Illinois Emergency Management Agency is authorized 11 to make grants to various higher education institutions, public 12 K-12 school districts, area vocational centers as designated by the State Board of Education, inter-district special education 13 14 cooperatives, regional safe schools, and nonpublic K-12 15 schools for safety and security improvements. For the purpose of this subsection (g), "higher education institution" means a 16 17 university, a public community college, public or an independent, not-for-profit or for-profit higher education 18 institution located in this State. Grants made under this 19 20 subsection (g) shall be paid out of moneys appropriated for that purpose from the Build Illinois Bond Fund. The Illinois 21 22 Emergency Management Agency shall adopt rules to implement this 23 subsection (q). These rules may specify: (i) the manner of applying for grants; (ii) project eligibility requirements; 24 25 (iii) restrictions on the use of grant moneys; (iv) the manner 26 in which the various higher education institutions must account

1 for the use of grant moneys; and (v) any other provision that 2 the Illinois Emergency Management Agency determines to be 3 necessary or useful for the administration of this subsection 4 (g).

5 (h) Except as provided in Section 17.5 of this Act, any 6 moneys received by the Agency from donations or sponsorships 7 shall be deposited in the Emergency Planning and Training Fund 8 and used by the Agency, subject to appropriation, to effectuate 9 planning and training activities.

10 (i) The Illinois Emergency Management Agency may by rule 11 assess and collect reasonable fees for attendance at 12 Agency-sponsored conferences and trainings to enable the 13 Agency to carry out the requirements of this Act. Any moneys 14 received under this subsection shall be deposited in the Emergency Planning and Training Fund and used by the Agency, 15 16 subject to appropriation, for planning and training 17 activities.
