

## 100TH GENERAL ASSEMBLY State of Illinois 2017 and 2018 SB3241

Introduced 2/15/2018, by Sen. Jennifer Bertino-Tarrant

## SYNOPSIS AS INTRODUCED:

625 ILCS 5/3-412 from Ch. 95 1/2, par. 3-412 625 ILCS 5/18b-101 from Ch. 95 1/2, par. 18b-101

Amends the Illinois Vehicle Code. Provides that the Secretary of State shall issue distinctive registration plates for covered farm vehicles. Provides that a \$10 surcharge shall be collected, in addition to all applicable fees for the issuance of a registration plate. Provides that the surcharge shall be deposited into the Secretary of State Special License Plate Fund. Provides that a designation as a covered farm vehicle shall not limit the purposes for which that vehicle may otherwise be used. Modifies the definition of "covered farm vehicle". Effective immediately.

1 AN ACT concerning transportation.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Vehicle Code is amended by changing

  Sections 3-412 and 18b-101 as follows:
- 6 (625 ILCS 5/3-412) (from Ch. 95 1/2, par. 3-412)
- Sec. 3-412. Registration plates and registration stickers to be furnished by the Secretary of State.
- (a) The Secretary of State upon registering a vehicle subject to annual registration for the first time shall issue 10 11 or shall cause to be issued to the owner one registration plate 12 for a motorcycle, trailer, semitrailer, moped, autocycle, or 13 truck-tractor, 2 registration plates for other motor vehicles 14 and, where applicable, current registration stickers for motor vehicles of the first division. The provisions of this Section 15 16 may be made applicable to such vehicles of the second division, 17 as the Secretary of State may, from time to time, in his discretion designate. On subsequent annual 18 registrations 19 during the term of the registration plate as provided in 20 Section 3-414.1, the Secretary shall issue or cause to be 21 registration stickers as evidence of issued current 22 registration. However, the issuance of annual registration stickers to vehicles registered under the provisions of 23

Sections 3-402.1 and 3-405.3 of this Code may not be required if the Secretary deems the issuance unnecessary.

(b) Every registration plate shall have displayed upon it the registration number assigned to the vehicle for which it is issued, the name of this State, which may be abbreviated, the year number for which it was issued, which may be abbreviated, the phrase "Land of Lincoln" (except as otherwise provided in this Code), and such other letters or numbers as the Secretary may prescribe. However, for apportionment plates issued to vehicles registered under Section 3-402.1 and fleet plates issued to vehicles registered under Section 3-405.3, the phrase "Land of Lincoln" may be omitted to allow for the word "apportioned", the word "fleet", or other similar language to be displayed. Registration plates issued to a vehicle registered as a fleet vehicle may display a designation determined by the Secretary.

The Secretary may in his discretion prescribe that letters be used as prefixes only on registration plates issued to vehicles of the first division which are registered under this Code and only as suffixes on registration plates issued to other vehicles. Every registration sticker issued as evidence of current registration shall designate the year number for which it is issued and such other letters or numbers as the Secretary may prescribe and shall be of a contrasting color with the registration plates and registration stickers of the previous year.

- (c) Each registration plate and the required letters and numerals thereon, except the year number for which issued, shall be of sufficient size to be plainly readable from a distance of 100 feet during daylight, and shall be coated with reflectorizing material. The dimensions of the plate issued to vehicles of the first division shall be 6 by 12 inches.
  - (d) The Secretary of State shall issue for every passenger motor vehicle rented without a driver the same type of registration plates as the type of plates issued for a private passenger vehicle.
- (e) The Secretary of State shall issue for every passenger car used as a taxicab or livery, distinctive registration plates.
  - (f) The Secretary of State shall issue for every motorcycle distinctive registration plates distinguishing between motorcycles having 150 or more cubic centimeters piston displacement, or having less than 150 cubic centimeter piston displacement.
  - (g) Registration plates issued to vehicles for-hire may display a designation as determined by the Secretary that such vehicles are for-hire.
- 22 (h) (Blank).
  - (i) The Secretary of State shall issue for every public and private ambulance registration plates identifying the vehicle as an ambulance. The Secretary shall forward to the Department of Healthcare and Family Services registration information for

- the purpose of verification of claims filed with the Department by ambulance owners for payment for services to public assistance recipients.
  - (j) The Secretary of State shall issue for every public and private medical carrier or rescue vehicle livery registration plates displaying numbers within ranges of numbers reserved respectively for medical carriers and rescue vehicles. The Secretary shall forward to the Department of Healthcare and Family Services registration information for the purpose of verification of claims filed with the Department by owners of medical carriers or rescue vehicles for payment for services to public assistance recipients.
  - (k) The Secretary of State shall issue distinctive license plates or distinctive license plate stickers for every vehicle exempted from subsections (a) and (a-5) of Section 12-503 by subsection (g) of that Section, and by subsection (g-5) of that Section before its deletion by this amendatory Act of the 95th General Assembly. The Secretary shall issue these plates or stickers immediately upon receiving the physician's certification required under subsection (g) of Section 12-503. New plates or stickers shall also be issued when the certification is renewed as provided in that subsection.
- 23 (1) The Secretary of State shall issue distinctive 24 registration plates for low-speed vehicles.
- 25 (m) The Secretary of State shall issue distinctive 26 registration plates for autocycles. The dimensions of the plate

- issued to autocycles shall be 4 by 7 inches.
- 2 (n) The Secretary of State shall issue distinctive
- 3 registration plates for covered farm vehicles as defined in
- 4 Section 18b-101 of this Code. Beginning in registration year
- 5 2020, the owner of a motor vehicle weighing 8,000 pounds or
- 6 less who obtains a special registration plate under this
- 7 <u>subsection (n) shall be assessed a \$10 surcharge</u> in addition to
- 8 all applicable fees prescribed by the Secretary for the
- 9 issuance of registration plates under this Code. The \$10
- 10 surcharge collected under this subsection (n) shall be
- 11 deposited into the Secretary of State Special License Plate
- 12 Fund. The \$10 surcharge is an annual fee that shall be based on
- an applicant's new or existing registration year for each
- 14 vehicle displaying a registration plate issued under this
- 15 subsection (n). A designation as a covered farm vehicle under
- this subsection (n) shall not limit the purposes for which that
- vehicle may otherwise be used. The Secretary shall adopt any
- 18 rules necessary to implement this subsection (n).

- 21 Sec. 18b-101. Definitions. Unless the context otherwise
- 22 clearly requires, as used in this Chapter:
- 23 "Agricultural commodities" means any agricultural
- 24 commodity, non-processed food, feed, fiber, or livestock,
- 25 including insects.

"Agricultural operations" means the operation of a motor vehicle or combination of vehicles transporting agricultural commodities or farm supplies for agricultural purposes.

"Air mile" means a nautical mile, which is equivalent to 6,076 feet or 1,852 meters. Accordingly, 100 air miles are equivalent to 115.08 statute miles or 185.2 kilometers.

"Commercial motor vehicle" means any self propelled or towed vehicle used on public highways in interstate and intrastate commerce to transport passengers or property when the vehicle has a gross vehicle weight, a gross vehicle weight rating, a gross combination weight, or a gross combination weight rating of 10,001 or more pounds; or the vehicle is used or designed to transport more than 15 passengers, including the driver; or the vehicle is designed to carry 15 or fewer passengers and is operated by a contract carrier transporting employees in the course of their employment on a highway of this State; or the vehicle is used or designed to transport between 9 and 15 passengers, including the driver, for direct compensation; or the vehicle is used in the transportation of hazardous materials in a quantity requiring placarding under the Illinois Hazardous Materials Transportation Act. This definition shall not include farm machinery, fertilizer spreaders, and other special agricultural movement equipment described in Section 3-809 nor implements of husbandry as defined in Section 1-130.

"Covered farm vehicle", for purposes of this Chapter and

  - (B) livestock; or
  - (C) machinery or supplies; and
  - (3) if registered in this State, is:
    - (A) registered as a farm truck under subsection (c) of Section 3-815 of this Code; or
      - (B) operated in combination as an articulated vehicle when the truck in the combination is registered for 12,000 lbs. or less as a covered farm vehicle under subsections (a) and (a-5) of Section 3-815 of this Code or subsection (a) of Section 3-818 of this Code and contains in the cab of the motor vehicle a registration

designating the vehicle as a covered farm vehicle under subsections (a) and (a-5) of Section 3-815 of this Code and the trailer in the combination is registered as a farm trailer under subsection (a) of Section 3-819 of this Code and displays a farm registration license plate; or

- (C) a truck registered for 12,000 lbs. or less as a covered farm vehicle under subsections (a) and (a-5) of Section 3-815 of this Code or subsection (a) of Section 3-818 of this Code containing in the cab of the motor vehicle a registration designating the vehicle as a covered farm vehicle under subsections (a) and (a-5) of Section 3-815 of this Code that is towing an implement of husbandry as part of a farming operation; or and
- (D) a motor vehicle of the second division weighing 8,000 pounds or less with a registration plate issued under subsection (n) of Section 3-412 of this Code containing in the cab of the motor vehicle a registration designating the vehicle as a covered farm vehicle; and
- (4) is not used in for-hire motor carrier operations; however, for-hire motor carrier operations do not include the operation of a vehicle meeting the definition of a covered farm vehicle by a tenant pursuant to a crop share farm lease agreement to transport the landlord's portion of the crops under that agreement; and

| 1 | (5) has a gross vehicle weight rating (GVWR), a gross       |
|---|---|
| 2 | combination weight rating (GCWR), or a gross vehicle weight |
| 3 | or gross vehicle combination weight, whichever is greater,  |

- (A) 26,001 lbs. or less, for vehicles operating in interstate commerce; or
- greater than 26,001 lbs., operating in interstate commerce and registered in this State; or
- greater than 26,001 lbs. and traveling (C) interstate within 150 air miles of the farm or ranch for which the vehicle is being operated, regardless of whether it is registered in this State; or
- greater than 10,000 lbs. and traveling (D) intrastate.

"Direct compensation" means payment made to the motor carrier by the passengers or a person acting on behalf of the passengers for the transportation services provided, and not included in a total package charge or other assessment for highway transportation services.

"Farm supplies for agricultural purposes" means products directly related to the growing or harvesting of agricultural commodities and livestock feed at any time of the year.

"Livestock" means cattle, sheep, goats, swine, poultry (including egg-producing poultry), fish used for food, and other animals designated by the Secretary of the United States Department of Transportation (at his or her sole discretion)

- 1 that are part of a foundation herd (including producing dairy
- 2 cattle) or offspring.
- 3 "Officer" means Illinois State Police Officer.
- 4 "Person" means any natural person or individual,
- 5 governmental body, firm, association, partnership,
- 6 copartnership, joint venture, company, corporation, joint
- 7 stock company, trust, estate or any other legal entity or their
- 8 legal representative, agent or assigns.
