1 AN ACT concerning appropriations.

2 **Be it enacted by the People of the State of Illinois, represented**  
3 **in the General Assembly:**

4 ARTICLE 1

5 Section 1. The following named amounts, or so much thereof  
6 as may be necessary, respectively, for the objects and purposes  
7 hereinafter named, are appropriated from the Illinois Workers'  
8 Compensation Commission Operations Fund to the Illinois  
9 Workers' Compensation Commission:

5 Section 15. The amount of \$2,013,300, or so much thereof  
6 as may be necessary, is appropriated from the Illinois Workers'  
7 Compensation Commission Operations Fund to Illinois Workers'  
8 Compensation Commission for costs associated with the  
9 establishment, administration and operations of the Insurance  
10 Compliance Division of the workers' compensation anti-fraud  
11 program administered by Illinois Workers' Compensation  
12 Commission.

13 Section 20. The amount of \$60,000, or so much thereof as  
14 may be necessary, is appropriated from the Illinois Workers'  
15 Compensation Commission Operations Fund to Illinois Workers'  
16 Compensation Commission for costs associated with the  
17 establishment of the Medical Fee Schedule and other provisions  
18 of the Workers' Compensation Act.

19 Section 99. Effective Date. This Act takes effect July 1,  
20 2018. Notwithstanding anything in this Act to the contrary,  
21 appropriations authorized in this Act shall be used for all  
22 costs incurred prior to July 1, 2019.
