## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The State of Illinois owns the following
described real estate, which is under the control of the
Department of Transportation:

9 That part of Lot 2 in First Addition to Klefstad's Bensenville 10 Industrial Park in the east half of the Northeast Quarter of 11 Section 11, Township 40 North, Range 11 East of the Third 12 Principal Meridian, according to the plat thereof recorded 13 October 26, 1977, as Document Number R77-097746, in DuPage 14 County, Illinois, excepting therefrom that part of said Lot 2 15 described as follows:

Bearings and distances are based on the Illinois State Plane Coordinate System, East Zone NAD83 (2011 adj.), with a combined factor of 0.99996088;

Bensenville, for no less than the fair market value as
determined by an average of 3 appraisals.

Section 15. The Secretary of Transportation shall obtain a

effective date and shall record the certified document in the
Recorder's Office of DuPage County, Illinois.
