## SYNOPSIS AS INTRODUCED:

Amends various Acts relating to the governance of public universities and community colleges in Illinois. Provides that a university or community college district may not require a student, as part of his or her financial aid verification process, to submit a letter to the university or community college district indicating why the student's parent or guardian is not employed, does not file taxes, or does not have a federal Individual Taxpayer Identification Number.

## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The University of Illinois Act is amended by adding Section 105 as follows:
- 6 (110 ILCS 305/105 new)
- Sec. 105. Financial aid information. The University may not
- 8 require a student, as part of his or her financial aid
- 9 verification process, to submit a letter to the University
- 10 indicating why the student's parent or guardian is not
- 11 employed, does not file taxes, or does not have a federal
- 12 Individual Taxpayer Identification Number.
- 13 Section 10. The Southern Illinois University Management
- 14 Act is amended by adding Section 90 as follows:
- 15 (110 ILCS 520/90 new)
- 16 Sec. 90. Financial aid information. The University may not
- 17 require a student, as part of his or her financial aid
- 18 verification process, to submit a letter to the University
- 19 indicating why the student's parent or guardian is not
- 20 employed, does not file taxes, or does not have a federal
- 21 Individual Taxpayer Identification Number.

- 1 Section 15. The Chicago State University Law is amended by
- 2 adding Section 5-200 as follows:
- 3 (110 ILCS 660/5-200 new)
- 4 Sec. 5-200. Financial aid information. The University may
- 5 not require a student, as part of his or her financial aid
- 6 verification process, to submit a letter to the University
- 7 <u>indicating why the student's parent or guardian is not</u>
- 8 <u>employed, does not file taxes, or does not have a</u> federal
- 9 Individual Taxpayer Identification Number.
- 10 Section 20. The Eastern Illinois University Law is amended
- 11 by adding Section 10-200 as follows:
- 12 (110 ILCS 665/10-200 new)
- Sec. 10-200. Financial aid information. The University may
- 14 not require a student, as part of his or her financial aid
- 15 verification process, to submit a letter to the University
- 16 indicating why the student's parent or guardian is not
- 17 employed, does not file taxes, or does not have a federal
- 18 Individual Taxpayer Identification Number.
- 19 Section 25. The Governors State University Law is amended
- 20 by adding Section 15-200 as follows:

- 2 Sec. 15-200. Financial aid information. The University may
- 3 not require a student, as part of his or her financial aid
- 4 verification process, to submit a letter to the University
- 5 indicating why the student's parent or guardian is not
- 6 employed, does not file taxes, or does not have a federal
- 7 <u>Individual Taxpayer Identification Number.</u>
- 8 Section 30. The Illinois State University Law is amended by
- 9 adding Section 20-205 as follows:
- 10 (110 ILCS 675/20-205 new)
- 11 Sec. 20-205. Financial aid information. The University may
- 12 not require a student, as part of his or her financial aid
- verification process, to submit a letter to the University
- 14 indicating why the student's parent or guardian is not
- 15 employed, does not file taxes, or does not have a federal
- 16 Individual Taxpayer Identification Number.
- 17 Section 35. The Northeastern Illinois University Law is
- amended by adding Section 25-200 as follows:
- 19 (110 ILCS 680/25-200 new)
- 20 Sec. 25-200. Financial aid information. The University may
- 21 not require a student, as part of his or her financial aid
- 22 verification process, to submit a letter to the University

- 1 indicating why the student's parent or guardian is not
- 2 employed, does not file taxes, or does not have a federal
- 3 Individual Taxpayer Identification Number.
- 4 Section 40. The Northern Illinois University Law is amended
- 5 by adding Section 30-210 as follows:
- 6 (110 ILCS 685/30-210 new)
- 7 Sec. 30-210. Financial aid information. The University may
- 8 <u>not require a student, as part of his or her financial aid</u>
- 9 verification process, to submit a letter to the University
- 10 indicating why the student's parent or guardian is not
- 11 employed, does not file taxes, or does not have a federal
- 12 Individual Taxpayer Identification Number.
- 13 Section 45. The Western Illinois University Law is amended
- 14 by adding Section 35-205 as follows:
- 15 (110 ILCS 690/35-205 new)
- Sec. 35-205. Financial aid information. The University may
- 17 not require a student, as part of his or her financial aid
- 18 verification process, to submit a letter to the University
- 19 indicating why the student's parent or quardian is not
- 20 employed, does not file taxes, or does not have a federal
- 21 Individual Taxpayer Identification Number.

- Section 50. The Public Community College Act is amended by adding Section 3-29.13 as follows:
- 3 (110 ILCS 805/3-29.13 new)
- 4 Sec. 3-29.13. Financial aid information. A community
- 5 <u>college district may not require a student, as part of his or</u>
- 6 her financial aid verification process, to submit a letter to
- 7 the community college district indicating why the student's
- 8 parent or quardian is not employed, does not file taxes, or
- 9 <u>does not have a federal Individual Taxpayer Identification</u>
- 10 Number.
