2	AMENDMENT NO Amend House Bill 3884, AS AMENDED, by
3	replacing everything after the enacting clause with the
4	following:
5	"Section 1. References to Act. This Act may be referred to
6	as the CROWN (Create a Respectful and Open Workplace for
7	Natural Hair) Act.
8	Section 5. The Illinois Human Rights Act is amended by
9	changing Sections 1-103 and 5-102.2 as follows:
10	(775 ILCS 5/1-103) (from Ch. 68, par. 1-103)
11	Sec. 1-103. General definitions. When used in this Act,
12	unless the context requires otherwise, the term:
13	(A) Age. "Age" means the chronological age of a person who
14	is at least 40 years old, except with regard to any practice
15	described in Section 2-102, insofar as that practice concerns

training or apprenticeship programs. In the case of training or apprenticeship programs, for the purposes of Section 2-102, "age" means the chronological age of a person who is 18 but not yet 40 years old.

5 (B) Aggrieved party. "Aggrieved party" means a person who 6 is alleged or proved to have been injured by a civil rights 7 violation or believes he or she will be injured by a civil 8 rights violation under Article 3 that is about to occur.

(B-5) Arrest record. "Arrest record" means:

10

an arrest not leading to a conviction;

11

(2) a juvenile record; or

12 (3) criminal history record information ordered
13 expunged, sealed, or impounded under Section 5.2 of the
14 Criminal Identification Act.

15 (C) Charge. "Charge" means an allegation filed with the 16 Department by an aggrieved party or initiated by the Department 17 under its authority.

(D) Civil rights violation. "Civil rights violation"
includes and shall be limited to only those specific acts set
forth in Sections 2-102, 2-103, 2-105, 3-102, 3-102.1, 3-103,
3-104, 3-104.1, 3-105, 3-105.1, 4-102, 4-103, 5-102, 5A-102,
6-101, and 6-102 of this Act.

(E) Commission. "Commission" means the Human Rights
 Commission created by this Act.

(F) Complaint. "Complaint" means the formal pleading filedby the Department with the Commission following an

1 investigation and finding of substantial evidence of a civil 2 rights violation.

3 (G) Complainant. "Complainant" means a person including
4 the Department who files a charge of civil rights violation
5 with the Department or the Commission.

6 (H) Department. "Department" means the Department of Human7 Rights created by this Act.

8 (I) Disability. "Disability" means a determinable physical 9 or mental characteristic of a person, including, but not 10 limited to, a determinable physical characteristic which 11 necessitates the person's use of a quide, hearing or support dog, the history of such characteristic, or the perception of 12 13 such characteristic by the person complained against, which may 14 result from disease, injury, congenital condition of birth or functional disorder and which characteristic: 15

16 (1) For purposes of Article 2, is unrelated to the 17 person's ability to perform the duties of a particular job 18 or position and, pursuant to Section 2-104 of this Act, a 19 person's illegal use of drugs or alcohol is not a 20 disability;

(2) For purposes of Article 3, is unrelated to the person's ability to acquire, rent, or maintain a housing accommodation;

24 (3) For purposes of Article 4, is unrelated to a
 25 person's ability to repay;

(4) For purposes of Article 5, is unrelated to a

person's ability to utilize and benefit from a place of public accommodation;

3 (5) For purposes of Article 5, also includes any
4 mental, psychological, or developmental disability,
5 including autism spectrum disorders.

(J) Marital status. "Marital status" means the legal status
of being married, single, separated, divorced, or widowed.

8 (J-1) Military status. "Military status" means a person's 9 status on active duty in or status as a veteran of the armed 10 forces of the United States, status as a current member or 11 veteran of any reserve component of the armed forces of the United States, including the United States Army Reserve, United 12 13 States Marine Corps Reserve, United States Navy Reserve, United States Air Force Reserve, and United States Coast Guard 14 15 Reserve, or status as a current member or veteran of the 16 Illinois Army National Guard or Illinois Air National Guard.

17 (K) National origin. "National origin" means the place in18 which a person or one of his or her ancestors was born.

19 (K-5) "Order of protection status" means a person's status 20 as being a person protected under an order of protection issued 21 pursuant to the Illinois Domestic Violence Act of 1986, Article 22 112A of the Code of Criminal Procedure of 1963, the Stalking No 23 Contact Order Act, or the Civil No Contact Order Act, or an 24 order of protection issued by a court of another state.

(L) Person. "Person" includes one or more individuals,
 partnerships, associations or organizations, labor

organizations, labor unions, joint apprenticeship committees, or union labor associations, corporations, the State of Illinois and its instrumentalities, political subdivisions, units of local government, legal representatives, trustees in bankruptcy or receivers.

6 (L-5) Pregnancy. "Pregnancy" means pregnancy, childbirth,
7 or medical or common conditions related to pregnancy or
8 childbirth.

9 (M) Public contract. "Public contract" includes every 10 contract to which the State, any of its political subdivisions, 11 or any municipal corporation is a party.

12 (M-5) Race. "Race" includes traits associated with race, 13 including, but not limited to, hair texture and protective 14 hairstyles such as braids, locks, and twists.

(N) Religion. "Religion" includes all aspects of religious observance and practice, as well as belief, except that with respect to employers, for the purposes of Article 2, "religion" has the meaning ascribed to it in paragraph (F) of Section 2-101.

(0) Sex. "Sex" means the status of being male or female.

(0-1) Sexual orientation. "Sexual orientation" means actual or perceived heterosexuality, homosexuality, bisexuality, or gender-related identity, whether or not traditionally associated with the person's designated sex at birth. "Sexual orientation" does not include a physical or sexual attraction to a minor by an adult. 1 (P) Unfavorable military discharge. "Unfavorable military 2 discharge" includes discharges from the Armed Forces of the 3 United States, their Reserve components, or any National Guard 4 or Naval Militia which are classified as RE-3 or the equivalent 5 thereof, but does not include those characterized as RE-4 or 6 "Dishonorable".

7 (Q) Unlawful discrimination. "Unlawful discrimination" 8 means discrimination against a person because of his or her 9 actual or perceived: race, color, religion, national origin, 10 ancestry, age, sex, marital status, order of protection status, 11 disability, military status, sexual orientation, pregnancy, or 12 unfavorable discharge from military service as those terms are 13 defined in this Section.

17 Sec. 5-102.2. Jurisdiction limited. In regard to places of public accommodation defined in paragraph (11) of Section 18 19 5-101, the jurisdiction of the Department is limited to: (1) 20 the failure to enroll an individual; (2) the denial or refusal 21 of full and equal enjoyment of access to facilities, goods, or 22 services; or (3) severe or pervasive harassment of an individual when the covered entity fails to take corrective 23 24 action to stop the severe or pervasive harassment.
