

101ST GENERAL ASSEMBLY State of Illinois 2019 and 2020 HB4776

Introduced 2/18/2020, by Rep. Daniel Didech and Daniel Swanson

SYNOPSIS AS INTRODUCED:

105 ILCS 5/2-3.180 105 ILCS 5/10-20.68

Amends the School Code. In a provision concerning school safety and security grants, allows a law enforcement agency that provides a school resource officer to a public school to be awarded a grant (to be used exclusively to defray the costs related to providing a school resource officer to a school located within a Tier 1 or Tier 2 school district). Allows grant funds to be used to defray the costs associated with hiring a school resource officer, with the State Board of Education prioritizing estimated law enforcement response time in awarding grant funds for such a purpose. Requires the State Board to annually disseminate a request for grant applications, requires grant funds to be distributed annually, and permits the State Board to adopt rules. In a provision concerning school resource officers, changes how "school resource officer" is defined. Effective immediately.

- 9 <u>(a) In this Section, "school resource officer" has the</u>
 10 meaning given to that term under Section 10-20.68.
 - (b) Subject to appropriation or private donations, the State Board of Education shall award grants to school districts to support school safety and security and to law enforcement agencies that provide school resource officers to public Grant funds may be used for school security schools. improvements, including professional development, safety-related upgrades to school buildings, equipment, including metal detectors and x-ray machines, and facilities, including school-based health centers, and to defray the costs associated with hiring a school resource officer. However, grant funds received by a law enforcement agency under this Section must be used exclusively to defray the costs related to providing a school resource officer to a school located within

- 17 (a) In this Section, "school resource officer" means a law
- 18 enforcement officer who has been primarily assigned to a school
- 19 or school district under an agreement with a local law
- 20 enforcement agency. "School resource officer" also includes a
- 21 retired law enforcement officer associated with a local law
- 22 enforcement agency for the purpose of serving as a school
- 23 resource officer.
- 24 (b) Beginning January 1, 2021, any law enforcement agency
- 25 that provides a school resource officer under this Section

- 1 shall provide to the school district a certificate of
- 2 completion, or approved waiver, issued by the Illinois Law
- 3 Enforcement Training Standards Board under Section 10.22 of the
- 4 Illinois Police Training Act indicating that the subject
- 5 officer has completed the requisite course of instruction in
- 6 the applicable subject areas within one year of assignment, or
- 7 has prior experience and training which satisfies this
- 8 requirement.
- 9 (c) In an effort to defray the related costs, any law
- 10 enforcement agency that provides a school resource officer
- should apply for grant funding through the federal Community
- 12 Oriented Policing Services grant program.
