13 Section 40. The sum of \$1,000,000, or so much thereof as 14 may be necessary, is appropriated from the Public Pension 15 Regulation Fund to the Department of Insurance for costs and 16 expenses related to or in support of the agency's operations.

Section 45. The sum of \$2,862,000, or so much thereof as may be necessary, is appropriated from the Illinois Workers' Compensation Commission Operations Fund to the Department of Insurance for costs associated with the administration and operations of the Insurance Fraud Division of the Illinois Workers' Compensation Commission's Anti-Fraud Program. -5- OMB101 00197 NHB 45197 b

Section 50. The sum of \$284,200, or so much thereof as may 1 2 be necessary, is appropriated from the Illinois Department of Insurance Federal Trust Fund to the Illinois Department of 3 Insurance for grants and administrative expenses associated 4 with Federal grants to support states in providing added 5 6 flexibility to strengthen the private health insurance market 7 through implementation of market reforms under Part A of Title XXVII of the Public Health Services Act. 8

9 Section 55. The sum of \$7,500,000, or so much thereof as 10 may be necessary, is appropriated from the Health Insurance 11 Coverage Administration Fund to the Department of Insurance for 12 costs associated with the administration of the Illinois Health 13 Insurance Marketplace and related activities.

Section 99. Effective Date. This Act takes effect July 1,2020.
