SYNOPSIS AS INTRODUCED:

15 ILCS 205/6.3 new 15 ILCS 205/6.4 new

Amends the Attorney General Act. Creates the Worker Protection Unit within the Office of the Illinois Attorney General to intervene in, initiate, enforce, and defend all criminal or civil legal proceedings on matters and violations relating to specified statutes. Provides further powers and requirements of the Attorney General in the Worker Protection Unit. Creates the Worker Protection Task Force. Provides for the purposes and composition of the Task Force. Provides that the Task Force shall submit a report to the Governor and the General Assembly regarding its progress no later than December 1, 2020. Repeals the Task Force December 1, 2021.

2 Be it enacted by the People of the State of Illinois, 3 represented in the General Assembly:

4 Section 5. The Attorney General Act is amended by adding 5 Sections 6.3 and 6.4 as follows:

6 (15 ILCS 205/6.3 new)

7 <u>Sec. 6.3. Worker Protection Unit.</u>

The General Assembly finds that the welfare and 8 (a) 9 prosperity of all Illinois citizens and businesses requires the 10 establishment of a Unit within the Attorney General's Office dedicated to combat the State's underground economy, which 11 12 forces its employees to work in unsafe conditions and gives businesses that avoid their tax and labor responsibilities an 13 14 unfair economic advantage. The Worker Protection Unit shall be focused on protecting the State's workforce to ensure workers 15 16 are paid properly, guarantee safe workplaces, and allow law-abiding business owners to thrive through healthy and fair 17 competition. Businesses that operate "off-the-books" put a 18 19 greater burden on taxpayers by hurting the State's ability to provide critical services; compliant businesses cannot compete 20 21 against those who gain an unfair advantage by evading their 22 responsibilities.

23 (b) There is created within the Office of the Attorney

General a Worker Protection Unit, consisting of Assistant 1 2 Attorneys General appointed by the Attorney General, who, 3 together with other staff as deemed necessary by the Attorney General, shall have the power and duty on behalf of the People 4 5 of the State, as parens patriae on behalf of persons within the State, to intervene in, initiate, enforce, and defend all 6 7 criminal or civil legal proceedings on matters and violations 8 relating to the Prevailing Wage Act, the Employee 9 Classification Act, the Minimum Wage Law, the Day and Temporary 10 Labor Services Act, or the Wage Payment and Collection Act, 11 whenever the Attorney General determines that such action is 12 necessary to protect the rights and interests of Illinois 13 workers and Illinois businesses.

14 (c) In addition to the investigative and enforcement powers 15 available to the Attorney General under the laws of this State, 16 Attorney General has the power and authority, the 17 notwithstanding and regardless of any proceeding instituted or to be instituted by or before the Illinois Department of Labor, 18 19 or any other administrative agency, to protect the rights and 20 interests of Illinois workers and Illinois businesses by 21 commencing an action or proceeding in circuit court. Prior to 22 initiating an action, the Attorney General shall conduct an investigation and may: (1) require an individual or entity to 23 24 file a statement or report in writing under oath or otherwise, 25 as to all information the Attorney General may consider 26 necessary; (2) examine under oath any person alleged to have

participated in or with knowledge of the alleged violation; or
(3) issue subpoenas or conduct hearings in aid of any
investigation.

4 (d) In an action brought under this Section, the Attorney 5 General may obtain, as a remedy, monetary damages to the State, restitution, and equitable relief, including any permanent or 6 7 preliminary injunction, temporary restraining order, or other 8 order, including an order enjoining the defendant from engaging 9 in a violation, or order any action as may be appropriate. In 10 addition, the Attorney General may request and the court may 11 impose a civil penalty against any person or entity found by 12 the court to have engaged in a violation of the Prevailing Wage Act, the Employee Classification Act, the Minimum Wage Law, the 13 14 Day and Temporary Labor Services Act, or the Wage Payment and Collection Act, in a sum not to exceed the civil penalty 15 16 provided in the respective Act that was violated. An aggrieved 17 individual may not recover monetary relief in more than one 18 proceeding.

19 <u>(e) Upon the Attorney General's request, the Illinois</u> 20 <u>Department of Labor shall provide any materials or documents</u> 21 <u>already in the Department's possession pertaining to the</u> 22 <u>enforcement of this Section. Nothing in this Section is</u> 23 <u>intended to take away or limit any powers of the Attorney</u> 24 <u>General under common law or other statutory law.</u>
