SYNOPSIS AS INTRODUCED:

25 ILCS 155/4

from Ch. 63, par. 344

Amends the Commission on Government Forecasting and Accountability Act. Provides that the House of Representatives and the Senate, in consultation with of the Office of the Governor, shall by joint resolution adopt or modify revenue estimates provided by the Commission on Government Forecasting and Accountability within 2 days after the Governor's Budget Address to the General Assembly or by March 1, whichever occurs first. Provides that the joint resolution shall constitute both the estimate of the General and the estimate of the Governor of the funds estimated to be available during the next fiscal year. Makes conforming changes.

1 AN ACT concerning State government.

2 **Be it enacted by the People of the State of Illinois,**
3 **represented in the General Assembly:**

4 Section 5. The Commission on Government Forecasting and
5 Accountability Act is amended by changing Section 4 as follows:

6 (25 ILCS 155/4) (from Ch. 63, par. 344)

7 Sec. 4. (a) The Commission shall publish, at the convening
8 of each regular session of the General Assembly, a report on
9 the estimated income of the State from all applicable revenue
10 sources for the next ensuing fiscal year and of any other funds
11 estimated to be available for such fiscal year. The Commission,
12 in its discretion, may consult with the Governor's Office of
13 Management and Budget in preparing the report. On the third
14 Wednesday in March after the session convenes, the Commission
15 shall issue a revised and updated set of revenue figures
16 reflecting the latest available information. The House and
17 Senate, in consultation with of the Office of the Governor,
18 shall by joint resolution adopt or modify the revenue estimates
19 within 2 days after the Governor's Budget Address to the
20 General Assembly or by March 1, whichever occurs first ~~by joint~~
21 ~~resolution shall adopt or modify such estimates as may be~~
22 ~~appropriate.~~ The joint resolution shall constitute the ~~General~~
23 ~~Assembly's~~ estimate of the General Assembly and the estimate of

1 the Governor, under ~~paragraph (b) of~~ Section 2 of Article VIII
2 of the Constitution, of the funds estimated to be available
3 during the next fiscal year.

4 (b) On the third Wednesday in March, the Commission shall
5 issue estimated:

- 6 (1) pension funding requirements under P.A. 86-273;
7 and
8 (2) liabilities of the State employee group health
9 insurance program.

10 These estimated costs shall be for the fiscal year
11 beginning the following July 1.

12 (c) The requirement for reporting to the General Assembly
13 shall be satisfied by filing copies of the report as required
14 by Section 3.1 of the General Assembly Organization Act, and
15 filing such additional copies with the State Government Report
16 Distribution Center for the General Assembly as is required
17 under paragraph (t) of Section 7 of the State Library Act.
