

101ST GENERAL ASSEMBLY State of Illinois 2019 and 2020 SB3234

SYNOPSIS AS INTRODUCED:

Amends various acts relating to the governance of public universities and community college districts in Illinois. Prohibits public universities and community colleges from holding any classes on the day of a general primary election or general election, as established by the Election Code. Allows public universities and community colleges to remain open for other purposes.

1 AN ACT concerning education.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The University of Illinois Act is amended by adding Section 120 as follows:
- 6 (110 ILCS 305/120 new)
- 7 Sec. 120. No classes on election days. The University shall
- 8 not hold any classes on the day of a general primary election
- 9 or a general election, as established by the Election Code.
- 10 However, the University may remain open for other purposes.
- 11 Section 10. The Southern Illinois University Management
- 12 Act is amended by adding Section 100 as follows:
- 13 (110 ILCS 520/100 new)
- Sec. 100. No classes on election days. The University shall
- not hold any classes on the day of a general primary election
- or a general election, as established by the Election Code.
- However, the University may remain open for other purposes.
- 18 Section 15. The Chicago State University Law is amended by
- 19 adding Section 5-210 as follows:

- 1 (110 ILCS 660/5-210 new)
- 2 Sec. 5-210. No classes on election days. The University
- 3 shall not hold any classes on the day of a general primary
- 4 election or a general election, as established by the Election
- 5 Code. However, the University may remain open for other
- 6 purposes.
- 7 Section 20. The Eastern Illinois University Law is amended
- 8 by adding Section 10-210 as follows:
- 9 (110 ILCS 665/10-210 new)
- 10 Sec. 10-210. No classes on election days. The University
- shall not hold any classes on the day of a general primary
- 12 election or a general election, as established by the Election
- 13 Code. However, the University may remain open for other
- 14 purposes.
- 15 Section 25. The Governors State University Law is amended
- 16 by adding Section 15-210 as follows:
- 17 (110 ILCS 670/15-210 new)
- 18 Sec. 15-210. No classes on election days. The University
- shall not hold any classes on the day of a general primary
- 20 election or a general election, as established by the Election
- 21 Code. However, the University may remain open for other
- 22 purposes.

- 1 Section 30. The Illinois State University Law is amended by
- 2 adding Section 20-215 as follows:
- 3 (110 ILCS 675/20-215 new)
- 4 Sec. 20-215. No classes on election days. The University
- 5 shall not hold any classes on the day of a general primary
- 6 election or a general election, as established by the Election
- 7 Code. However, the University may remain open for other
- 8 purposes.
- 9 Section 35. The Northeastern Illinois University Law is
- amended by adding Section 25-210 as follows:
- 11 (110 ILCS 680/25-210 new)
- 12 Sec. 25-210. No classes on election days. The University
- shall not hold any classes on the day of a general primary
- 14 election or a general election, as established by the Election
- 15 Code. However, the University may remain open for other
- 16 purposes.
- 17 Section 40. The Northern Illinois University Law is amended
- 18 by adding Section 30-220 as follows:
- 19 (110 ILCS 685/30-220 new)
- Sec. 30-220. No classes on election days. The University

- 1 shall not hold any classes on the day of a general primary
- 2 election or a general election, as established by the Election
- 3 Code. However, the University may remain open for other
- 4 purposes.
- 5 Section 45. The Western Illinois University Law is amended
- 6 by adding Section 35-215 as follows:
- 7 (110 ILCS 690/35-215 new)
- 8 Sec. 35-215. No classes on election days. The University
- 9 shall not hold any classes on the day of a general primary
- 10 election or a general election, as established by the Election
- 11 Code. However, the University may remain open for other
- 12 purposes.
- 13 Section 50. The Public Community College Act is amended by
- 14 adding Section 3-29.14 as follows:
- 15 (110 ILCS 805/3-29.14 new)
- Sec. 3-29.14. No classes on election days. A community
- 17 college shall not hold any classes on the day of a general
- primary election or a general election, as established by the
- 19 Election Code. However, a community college may remain open for
- 20 other purposes.
