1 AN ACT concerning appropriations.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1

Section 5. The amount of \$562,528,200, or so much thereof as may be necessary, is appropriated from the Education Assistance Fund to the Board of Trustees of the University of Illinois to meet its operational expenses for the fiscal year ending June 30, 2021.

Section 10. The amount of \$28,126,400, or so much thereof as may be necessary, is appropriated from the Education Assistance Fund to the Board of Trustees of the University of Illinois to meet its operational expenses for the fiscal year ending June 30, 2021 if, but only if, Public Act 101-0008 takes effect.

Section 15. The following named amounts, or so much thereof as may be necessary, are appropriated from the Education Assistance Fund to the Board of Trustees of the University of Illinois for Labor and Employment Relations:

- Section 20. The sum of \$14,803,100, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for costs and expenses related to or in support of the Prairie Research Institute, in accordance with Public Act 95-0728.
- Section 25. The sum of \$740,200, or so much thereof as may
 be necessary, is appropriated from the General Revenue Fund to
 the Board of Trustees of the University of Illinois for costs
 and expenses related or in support of the Prairie Research
 Institute, in accordance with Public Act 95-0728 if, but only
 if, Public Act 101-0008 takes effect.
- Section 30. The sum of \$40,380,600, or so much thereof as may be necessary, is appropriated from the General Revenue Fund to the Board of Trustees of the University of Illinois for operating costs and expenses related to or in support of the University of Illinois Hospital.
- Section 35. The sum of \$673,800, or so much thereof as may be necessary, is appropriated from the Education Assistance Fund to the Board of Trustees of the University of Illinois for

- 3 Section 40. The sum of \$276,600, or so much thereof as may
- 4 be necessary, is appropriated from the Education Assistance

- 7 Section 45. The sum of \$1,052,700, or so much thereof as
- 8 may be necessary, is appropriated from the Education Assistance
- 9 Fund to the Board of Trustees of the University of Illinois for
- 10 costs associated with the Public Policy Institute at the
- 11 Chicago campus.
- 12 Section 50. The sum of \$294,800, or so much thereof as may
- 13 be necessary, is appropriated from the Education Assistance
- 14 Fund to the Board of Trustees of the University of Illinois for
- 15 a grant to the College of Dentistry.
- Section 55. The amount of \$500,000, or so much thereof as
- may be necessary, is appropriated from the General Revenue Fund
- 18 to the Board of Trustees of the University of Illinois for
- 19 costs associated with the Illinois Heart Rescue.
- Section 60. The sum of \$4,427,900, or so much thereof as

- 1 may be necessary, is appropriated from the Fire Prevention Fund
- 2 to the Board of Trustees of the University of Illinois for the
- 3 purpose of maintaining the Illinois Fire Service Institute,
- 4 paying the Institute's expenses, and providing the facilities
- 5 and structures incident thereto, including payment to the
- 6 University for personal services and related costs incurred.
- 7 Section 65. The sum of \$250,000, or so much thereof as may
- 8 be necessary, is appropriated from the State College and
- 9 University Trust Fund to the Board of Trustees of the University
- of Illinois for scholarship grant awards.
- 11 Section 70. The sum of \$250,000 or so much thereof as may
- be necessary, is appropriated from the Pet Population Control
- 13 Fund to the University of Illinois for costs associated with
- 14 pet population control at the College of Veterinary Medicine.
- 15 Section 75. The sum of \$300,000, or so much thereof as may
- 16 be necessary, is appropriated from the Emergency Public Health
- 17 Fund to the University of Illinois for costs and expenses
- 18 related to or in support of Emergency Mosquito Abatement.
- 19 Section 80. The sum of \$400,000, or so much thereof as may
- 20 be necessary, is appropriated from the Used Tire Management
- 21 Fund to the University of Illinois for costs and expenses

- 1 related to or in support of mosquito research and abatement.
- 2 Section 85. The sum of \$500,000, or so much thereof as may
- 3 be necessary, is appropriated from the Hazardous Waste Research
- 4 Fund to the University of Illinois for its ordinary and
- 5 contingent expenses.
- 6 Section 90. The sum of \$500,000, or so much thereof as may
- 7 be necessary, is appropriated from the General Professions
- 8 Dedicated Fund to the Board of Trustees of the University of
- 9 Illinois for costs associated with the development, support or
- 10 administration of pharmacy practice education or training
- 11 programs for the College of Medicine at Rockford.
- 12 Section 99. Effective Date. This Act takes effect July 1,
- 13 2020.
