## Be it enacted by the People of the State of Illinois, represented in the General Assembly:

4 ARTICLE 1 Section 5. - Section 45. The amount of \$6,094,300, or so much thereof

- 18 grants and administrative expenses related to Metropolitan
- 19 Family Services' support of street intervention programming.
- Section 50. The amount of \$5,000,000, or so much thereof
- 21 as may be necessary, is appropriated from the General Revenue

- 2 administrative costs and grants related to the support of
- 3 violence prevention and street intervention programming in
- 4 municipalities with a population of 1,000,000 or greater.
- 5 Section 55. The amount of \$4,000,000, or so much thereof
- 6 as may be necessary, is appropriated from the General Revenue
- 7 Fund to the Illinois Criminal Justice Information Authority for
- 8 grants and administrative expenses related to the support of
- 9 violence prevention and street intervention programming in
- 10 DuPage, Kane, Lake, McHenry, Will and Cook counties for
- 11 municipalities with a population less than one million.
- 12 Section 60. The amount of \$3,000,000, or so much thereof
- as may be necessary, is appropriated from the General Revenue
- 14 Fund to the Illinois Criminal Justice Information Authority for
- 15 grants and administrative expenses related to the support of
- 16 violence prevention and street intervention programming
- 17 statewide excluding DuPage, Kane, Lake, McHenry, Will and Cook
- 18 counties.
- 19 Section 65. The amount of \$3,361,700, or so much thereof
- as may be necessary, is appropriated from the General Revenue
- 21 Fund to the Illinois Criminal Justice Information Authority for
- 22 grants and administrative expenses related to trauma centers.

1	Section 70. The amount of \$1,000,000, or so much thereof
2	as may be necessary, is appropriated from the General Revenue
3	Fund to the Illinois Criminal Justice Information Authority for
4	a grant to the Safer Foundation for violence prevention
5	services and any associated administrative expenses.

Section 75. The amount of \$500,000, or so much thereof as 6 7 may be necessary, is appropriated from the General Revenue Fund 8 to the Illinois Criminal Justice Information Authority for 9 grants to local law enforcement agencies for training pursuant 10 to the Community-Law Enforcement Partnership for Deflection and 11 Addiction Treatment Act and any associated administrative 12 expenses.

14 Section 5.
