SYNOPSIS AS INTRODUCED:

105 ILCS 5/21B-40

Amends the School Code. Beginning July 1, 2021, provides that an individual who holds a Professional Educator License or an Educator License with Stipulations (including an individual who has not been entitled by an Illinois-approved educator preparation program at an Illinois institution of higher education) may apply for a refund of the required application fee after 12 months of issuance and shall be issued a refund by the State Board of Education if the individual provides evidence that the individual has taught at a school district for at least 12 months. Effective immediately.

AN ACT concerning education.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

Section 5. The School Code is amended by changing Section
21B-40 as follows:

6 (105 ILCS 5/21B-40)

7 Sec. 21B-40. Fees.

8 (a) Beginning with the start of the new licensure system 9 established pursuant to this Article, the following fees shall 10 be charged to applicants:

(1) A \$100 application fee for a Professional Educator 11 12 License or an Educator License with Stipulations. Beginning July 1, 2021, a licensee under this subdivision 13 14 (1) may apply for a refund of the application fee after 12 months of issuance and shall be issued that refund by the 15 16 State Board of Education if the licensee provides evidence 17 to the State Board that the licensee has taught at a school district for at least 12 months. 18

19 (1.5) A \$50 application fee for a Substitute Teaching
20 License. If the application for a Substitute Teaching
21 License is made and granted after July 1, 2017, the
22 licensee may apply for a refund of the application fee
23 within 18 months of issuance of the new license and shall

be issued that refund by the State Board of Education if the licensee provides evidence to the State Board of Education that the licensee has taught pursuant to the Substitute Teaching License at least 10 full school days within one year of issuance.

6 (1.7) A \$25 application fee for a Short-Term 7 Substitute Teaching License. The Short-Term Substitute Teaching License must be registered in at least one region 8 9 in this State, but does not require a registration fee. 10 The licensee may apply for a refund of the application fee within 18 months of issuance of the new license and shall 11 12 be issued that refund by the State Board of Education if licensee provides evidence to the State Board of 13 the 14 Education that the licensee has taught pursuant to the 15 Short-Term Substitute Teaching License at least 10 full 16 school days within one year of issuance.

17 (2) A \$150 application fee for individuals who have 18 been entitled by an Illinois-approved educator not 19 preparation program at an Illinois institution of higher 20 education and are seeking any of the licenses set forth in 21 subdivision (1) of this subsection (a). Beginning July 1, 22 2021, a licensee under this subdivision (2) may apply for 23 a refund of the application fee after 12 months of 24 issuance and shall be issued that refund by the State 25 Board of Education if the licensee provides evidence to 26 the State Board that the licensee has taught at a school - 3 - LRB102 10061 CMG 15381 b

district for at least 12 months.

2 (3) A \$50 application fee for each endorsement or
3 approval.

(4) A \$10 per year registration fee for the course of 4 5 the validity cycle to register the license, which shall be of 6 paid to the regional office education having supervision and control over the school in which the 7 8 individual holding the license is to be employed. If the 9 individual holding the license is not yet employed, then 10 the license may be registered in any county in this State. 11 The registration fee must be paid in its entirety the 12 first time the individual registers the license for a 13 particular validity period in a single region. No 14 additional fee may be charged for that validity period 15 should the individual subsequently register the license in 16 additional regions. An individual must register the 17 license (i) immediately after initial issuance of the license and (ii) at the beginning of each renewal cycle if 18 the individual has satisfied the renewal requirements 19 20 required under this Code.

Beginning on July 1, 2017, at the beginning of each renewal cycle, individuals who hold a Substitute Teaching License may apply for a reimbursement of the registration fee within 18 months of renewal and shall be issued that reimbursement by the State Board of Education from funds appropriated for that purpose if the licensee provides HB0221

evidence to the State Board of Education that the licensee has taught pursuant to the Substitute Teaching License at least 10 full school days within one year of renewal.

4 (5) The license renewal fee for an Educator License
5 with Stipulations with a paraprofessional educator
6 endorsement is \$25.

7 (b) All application fees paid pursuant to subdivisions (1) 8 through (3) of subsection (a) of this Section shall be 9 deposited into the Teacher Certificate Fee Revolving Fund and 10 shall be used, subject to appropriation, by the State Board of 11 Education to provide the technology and human resources 12 necessary for the timely and efficient processing of applications and for the renewal of licenses. Funds available 13 from the Teacher Certificate Fee Revolving Fund may also be 14 15 used by the State Board of Education to support the 16 recruitment and retention of educators, to support educator 17 preparation programs as they seek national accreditation, and provide professional development aligned with the 18 to requirements set forth in Section 21B-45 of this Code. A 19 20 majority of the funds in the Teacher Certificate Fee Revolving Fund must be dedicated to the timely and efficient processing 21 22 of applications and for the renewal of licenses. The Teacher Certificate 23 Fee Revolving Fund is not subject to 24 administrative charge transfers, authorized under Section 8h 25 of the State Finance Act, from the Teacher Certificate Fee 26 Revolving Fund into any other fund of this State, and moneys in

the Teacher Certificate Fee Revolving Fund shall not revert
 back to the General Revenue Fund at any time.

The regional superintendent of schools shall deposit the registration fees paid pursuant to subdivision (4) of subsection (a) of this Section into the institute fund established pursuant to Section 3-11 of this Code.

7 (c) The State Board of Education and each regional office 8 of education are authorized to charge a service or convenience 9 fee for the use of credit cards for the payment of license 10 fees. This service or convenience fee shall not exceed the 11 amount required by the credit card processing company or 12 vendor that has entered into a contract with the State Board or regional office of education for this purpose, and the fee 13 14 must be paid to that company or vendor.

(d) If, at the time a certificate issued under Article 21 of this Code is exchanged for a license issued under this Article, a person has paid registration fees for any years of the validity period of the certificate and these years have not expired when the certificate is exchanged, then those fees must be applied to the registration of the new license.
