1 AN ACT concerning transportation.

Be it enacted by the People of the State of Illinois, represented in the General Assembly:

- Section 5. The Illinois Vehicle Code is amended by changing Section 6-100 as follows:
- 6 (625 ILCS 5/6-100) (from Ch. 95 1/2, par. 6-100)
- Sec. 6-100. Definitions. For <u>the</u> purposes of this Chapter, the following words shall have the meanings ascribed

- 10 (a) Application Process. The process of obtaining a
- driver's license, identification card, or permit. The process
- 12 begins when a person enters a Secretary of State Driver
- 13 Services facility and requests a driver's license,
- identification card or permit.
- 15 (b) Conviction. A final adjudication of guilty by a court
- of competent jurisdiction either after a bench trial, trial by
- jury, plea of guilty, order of forfeiture, or default.
- 18 (c) Identification Card. A document made or issued by or
- 19 under the authority of the United States Government, the State
- 20 of Illinois or any other state or political subdivision
- 21 thereof, or any governmental or quasi-governmental
- 22 organization that, when completed with information concerning
- 23 the individual, is of a type intended or commonly accepted for

- 1 the purpose of identifying the individual.
- 2 (d) Non-compliant driver's license. A driver's license
- 3 issued in a manner which is not compliant with the REAL ID Act
- 4 and implementing regulations. Non-compliant driver's licenses
- 5 shall be marked "Not for Federal Identification" and shall
- 6 have a color or design different from the REAL ID compliant
- 7 driver's license.
- 8 (e) REAL ID compliant driver's license. A driver's license
- 9 issued in compliance with the REAL ID Act and implementing
- 10 regulations. REAL ID compliant driver's licenses shall bear a
- 11 security marking approved by the United States Department of
- 12 Homeland Security.
- 13 (f) Limited Term REAL ID compliant driver's license. A
- 14 REAL ID compliant driver's license issued to a person who is
- not a permanent resident or citizen of the United States, and
- 16 marked "Limited Term" on the face of the license.
